The Trustees present their annual report and financial statements of the charity for the year ended 5th April 2025. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with their governing documents, and the Charities Act 2011

Structure, Governance and Management

The charity was established by a charitable trust deed on 9th September 2021.

The charity has been founded by the amalgamation of two charities, The Jeremiah Inns Almshouse Charity (charity number: 213088) and The John Inns Almshouse Charity (charity number: 213087). This is with the aim of enhancing the capacity to deliver greater public benefit to both the Stevenage and Aston local areas.

Objectives and Activities

The charity's objects are the provision and maintenance of almshouses for the benefit of elderly and poor persons within the Stevenage and Aston areas and to make grants and allowances to the same areas. The policies adopted in furtherance of these objects are to build sustainable unrestricted reserves to a sufficient level to provide financial stability, meet exceptional expenditure and to assist with the future development of the charity and there has been no change in these during the year.

Achievements and Performance

During the year, the charity provided affordable accommodation for people of limited means in the Stevenage and Aston areas, which are areas of high housing cost.

Financial Review

The trustees are happy with the performance following the amalgamation of the previous two charities. Investment growth has been pleasing and the statement of assets and liabilities totals £246,835 at the year end.

The trustees are satisfied with the continued tenancy of the almshouses and offering of affordable accommodation for the tenants which are the elderly and poor.

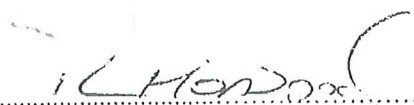
