TO BENEFIT THE PUBLIC, BY THE PROVISION OF FUNDING AND FINANCIAL ASSISTANCE TO ORGANISATIONS THAT ADVANCE AND FURTHER THE MAINTENANCE, CONSERVATION AND PROTECTION OF WILDLIFE AND ITS HABITATS, AND PLACES OF NATURAL BEAUTY.

Activities: The Carl Lewis Foundation is a fundraising charity, to provide funding to medical facilities treating and undertaking research into cancer; to provide assistance to persons suffering from cancer, and their families and carers; to advance the maintenance, conservation and protection of places of natural beauty and wildlife and its habitats.
