The trustees are pleased to present their report together with the financial statements of the charity for the year ended 31st January 2024

Structure, Governance and Management

Objectives and Activities

The objects of Unique Sisters of Manchester is the prevention and relief of poverty amongst children in Greater Manchester by the provision of clothing, food and grants of financial assistance to parents/carers in receipt of means-tested state benefits.

Statement of Trustees' responsibilities

The Board of Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice.

Charity law applicable to charities in England/Wales requires the Board of Trustees to prepare financial statements for each financial year which gives a true and fair view of the state of affairs of the Charity and of the surplus or deficit of the Charity for that period. In preparing those financial statements the Board of Trustees have:

- Selected suitable accounting policies and applied them consistently.
- Made judgments and estimates that are reasonable and prudent,
- Stated whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- Prepared the financial statements on a going concern basis (unless it is inappropriate to presume that the Charity will continue in operation).

The Board of Trustees has overall responsibility for ensuring that the Charity has an appropriate system of controls, financial and otherwise. They are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 1993. Independent Examiner's Report for the Year Ended 31st January 2024

I report on the financial statements of the charity for the year ended 31 January 2024 which comprise the Statement of Financial Activities and Balance Sheet with associate notes.
