The Trustees present their annual report together with the financial statements of The Redeemed Christian Church of God The All-Sufficient Sanctuary (the charity) for the year ended 31<sup>st</sup> December 2024. The Trustees confirm that the annual report and financial statements of the charity comply with the current statutory requirements, the requirements of the charity's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued 16 July 2014.

**STRUCTURE, GOVERNANCE AND MANAGEMENT**

**a. CONSTITUTION**

The church is constituted under a Trust Deed dated 20<sup>th</sup> April 2021

**b. METHOD OF APPOINTMENT OR ELECTION OF TRUSTEES**

The management of the charity is the responsibility of the Trustees who are appointed and co-opted under the terms of the Trust deed.

**c. POLICIES ADOPTED FOR THE INDUCTION AND TRAINING OF TRUSTEES**

**FINANCIAL REVIEW**

**a. RESERVES POLICY**

Members of the church have been generous this year. The statement of the financial activities shows a surplus for the year of £45,746.

The Trustees have established a policy whereby the unrestricted funds not committed or invested in tangible fixed assets ('the free reserves') held by the church should be 3 months of annual expenditure. At this level, the trustees feel that they would be able to continue the current activities of the church in the event of a significant drop in funding.

This is provided mainly through voluntary tithes and offerings by the church members.

I report on the accounts of the Charity for the year ended 31 December 2024, which are set out on pages 6 to 10.


