The charity is governed by its Constitution as adopted on 31st January 2017 and is administered by trustees selected by appointment.

Objectives

The Charity's objective is to advance the education of pupils at Burlington School by developing effective relationships between the staff, parents and others associated with the school and by engaging in activities or providing facilities or equipment which support the school.

Achievements and performance

During the year the Friends of Burlington School raised money by running events for the pupils such as discos, a Christmas fair and a talent show. We also received a large donation from a local business.

The Friends of Burlington School have supported the school by purchasing software and an interactive whiteboard, assisting with a reading product and contributing towards several school trips.

Financial review

The Charity received income of £67,405.89 this year, £66,175.00 of this was from a restricted donation. Expenditure totalled £41,246.53. This created a surplus of £26,159.36 to be added to the reserves brought forward of £8,387.02. At the year end unrestricted reserves totalled £5,762.28 and restricted reserves of £28,784.10.

The reserve policy of the Charity is to hold sufficient funds to meet its day to day liabilities as they fall due.
