The other was a Platinum Jubilee celebration project working with hard-to-reach young people suffering from social deprivation and economic isolation.

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	During this financial period the projects have worked directly with around 80 beneficiaries – young people aged between 11 – 18 from Darwen and the surrounding areas who come from socioeconomic deprivation and who are recognised as marginalised and hard to reach. Both projects were user led and remained dynamic throughout. All young attendees were engaged in activities pertinent to their interests and were encouraged to work towards accreditation were appropriate. All were fed and given refreshments whilst attending the projects – this was deemed necessary as many young people were not adequately eating at home. Through qualitative and quantitative questionnaires, we found that 82% of all participants finished the programmes with a higher degree of self-esteem and confidence than when they first arrived. We also observed an increase in positive communication between the facilitators and young people and that of their peer groups.



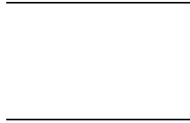
