Take Away The Tears has provided equipment and supplies that animal rescuers need to look after the animals in their care, whether that be food, items for the animals' physical or mental well-being or kennel equipment. The charity has supported neutering programmes and helped with emergency vet bills and in disasters, such as the devastating fires in Cyprus and the war in Ukraine. Pet food is also donated locally within the Newcastle area, to help individuals struggling to feed their pets in the ongoing financial crisis. The charity has managed to secure rental of a new warehouse which is not only financially cheaper but has allowed them to undertake more fundraising with open days and inside dog shows, and also has allowed them to engage with the local community more, providing a social hub suitable for adults with their children and dogs.

The trustees are acutely aware of the guidance on public benefit issued by the Charity Commission, all activities benefit the wellbeing of animals in need and therefore benefit rescuers, animal lovers, animal owners and the public in general who care about animal welfare and provide a means for the wider public to be able to help these animals in need.

Achievements and Performance

Take Away The Tears has alleviated the suffering of many animals by providing what has been needed for them to sustain an acceptable quality of life, where possible the donations have enhanced their quality of life substantially. The charity has supported programmes to help with ongoing care of animals and to educate the public on matters of animal welfare.

The charity has supported UK animal rescues that have been hit by a decline in donations due to the financial crisis.

The charity continues to support animal rescues in Romania and Cyprus where needed, including a cat colony and a spay and neuter campaign.

Support has continued to animal rescues in Ukraine affected by the war.

The charity has supported families in the Newcastle area struggling to feed their pets thus allowing these pets to remain in their homes rather than being surrendered to already overflowing rescue centres.

The charity has continued to support a disabled dog in the UK by contributing to vet bills, to allow her owners to give her the best quality of life available.

The new warehouse has allowed the charity to undertake more fundraising with open days and inside dog shows, and also has allowed them to engage with the local community more, providing a social hub suitable for adults with their children and dogs.

Financial Review

The charity's incoming resources are £16,327 (2023 - £16,478) and the outgoing resources are £14,755 (2023 - £17,395). The charity reported a net surplus of £1,573 (2023 - a deficit of £917).

The trustees carry out an annual review of the level of income reserves which they feel is appropriate to maintain in order to meet the charity's objectives effectively. The charity held fund balances at the year end of £4,889, all of which were unrestricted funds and held in forms considered appropriate to the charitable company's activities and future commitments.

Reserves policy

The policy is to hold three months fixed expenditure.

The trustees are therefore in a position to cover other expected charitable expenditure under an adverse scenario.

Going concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. 




