Report of the Trustees for the year ended 31 December 2024

The Friends of Petersfield Hospital was originally formed in 1954 as a registered charity. On 12th October 2021 the charity was converted to a CIO charity registered as 1196115. The aims of the Charity are to provide equipment and support for the benefit of patients in the hospital that is beyond the scope of the NHS. By the terms of its constitution the Charity is also able to provide similar support to the wider healthcare community within the Petersfield area.

The Charity raises funds by membership subscriptions (currently £5 minimum per year), fundraising events, donations and legacies. Expenditure in accordance with the Trust's objectives is approved by the full committee in regular meetings and is in response to requests or suggestions by hospital and other healthcare staff, either in person or in writing. The Committee is grateful to all of the subscribing members for their continuing support, and those individuals and organisations that donate to the Charity.

After an exceptional year in 2023 (income of £122,094) income fell back to £11,598 to include Donations and Legacies of £7,808. Expenditure was £19,249 which included £7,685 for equipment in The Urgent Treatment Centre and £6,703 for equipment in the Swan Street and Grange surgeries in Petersfield. £1,000 was donated to the local Stroke Group. The deficit for the year was £7,651 which deducted from the 2023 Reserves of £139,554 gave £131,903 of Reserves to carry forward.

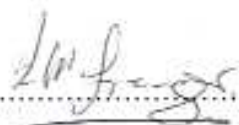
The Charity continues to fund the routine provision of newspapers and maintenance of the gardens in the hospital.
