Weekly communal gathering celebrating the life of the Prophet Muhammad (PBUH).

We hold fortnightly Islamic history classes for men, discussing how this relates to the world today.

Seasonal Social Events:

Typically, we host and support social events, designed to bring together a broader cross-section of our target audience. These events are thoughtfully organised around significant dates within the Islamic Calendar, fostering a sense of community and cultural celebration.

Achievements and Performance

Performance is diligently monitored and reviewed by both the Trustees and the sub-committee during our monthly meetings. We are proud to report the following:

- Continued offering free burials for children under 12 saving families over £2,000.00
- Spent over £16,000.00 on community outreach consisting of events and educational class.
- Donated £4,000 to external causes and likeminded charities.
- Carried out our annual Badr event with over 300 people in attendance and help organise The Beloved event.
- Continue to offer young men 12- 16 JiuJitsu session and increasing student numbers by 20%.
- Continue to offer mens 16+ jiuJitsu session and increasing student numbers by 10%.
- Continue to offer Archery for all and this has seen the biggest increase of students by 35%.
- We have started our new weekly Friday gathering, which is open to all for free, celebrating the life of the Prophet Muhammad (PBUH).

The Sunnah Supports Academy continues to demonstrate steady growth. We remain committed to enhancing the breadth and quality of our educational and developmental programs. In the coming period, we intend to introduce structured swimming courses designed for beginners, children, and adults.

Additionally, we plan to expand our martial arts offerings by introducing a women's self-defence class and adding a second Jiu Jitsu session for children and young men, thereby increasing training frequency to twice weekly.

In the field of archery, we aim to increase participation by expanding class capacity and offering sessions twice per week.

We also seek to broaden our community outreach by hosting additional learning and community engagement events, complementing our existing men's fortnightly gatherings and special programs such as the annual Badr event.

Finally, we aspire to play a more active role in mobilising financial and material support for humanitarian initiatives, contributing to relief efforts as needs arise.



The Sunnah Supports Academy is experiencing growth, and we are committed to enhancing our array of disciplines while further developing our existing programs. Specifically, we plan to introduce Swimming courses tailored for beginners, children and adults.

We aim to add a women's self-defence class under our martial arts offering, as well as a second Jiu Jitsu session for children and young men, bringing the frequency to twice a week.

In the field of archery, we intend to augment the number of students, with emphasis on increasing the number of sessions we are offering, by going up to twice a week.

We would like to offer more educational gatherings as we do with our men's fortnightly gathering and one off events such as our annual Badr event.

Being more involved in helping to raise finance / goods for humanitarian crisis such the Turkey Earthquake Appeal we carried out in 2023.

Aim and Vision

Al Ansaar is a community-based endeavour in Oxford that aims to provide educational and social services built upon prophetic principles and teachings, thereby developing and strengthening society. Our focus is to serve God by serving others, helping and supporting each other and offering solutions that help nurture and strengthen the individual and the wider community.

Activities

Islamic Burial Service:

The services provided extend to both those who can afford them and those who cannot. This encompasses offering guidance, conducting ceremonial washings in accordance with Islamic traditions, coordinating transportation for the deceased, arranging burial plots, and organising non-invasive scans to provide support for those coping with the loss of a loved one.

Sunnah Sports Academy:

The Sunnah Sports Academy allows students to participate in Archery, Jiu Jitsu and Horse Riding:

Archery:

Children mixed 7-12 classes once a week in term times.

Women only 13+ classes once a week in term times

Men only 13+ classes once a week in term times

Jiu Jitsu:

Men only 16+ session once a week throughout the year.

Horse Riding:

6-week beginners summer course offered to children and adults.

Seasonal Social Events:

Typically, we host and support social events, designed to bring together a broader cross-section of our target audience. These events are thoughtfully organised around significant dates within the Islamic Calendar, fostering a sense of community and cultural celebration.

Achievements and Performance

Performance is diligently monitored and reviewed by both the Trustees and the sub-committee during our monthly meetings. We are proud to report that our efforts have resulted in significant cost savings for families, exceeding £14,000 in reduced burial charges. Furthermore, our Sunnah Sports Academy has successfully engaged over 60 members across all our disciplines. In addition, we have extended our support including like-minded organisations by contributing more than £10,400 in donations.

Future Plans

Our primary objective is to expand our Islamic burial support services, given the rising demand from refugees and individuals lacking a stable foundation within the community. This growing reliance on support necessitates our continued efforts in this area.

The Sunnah Supports Academy is experiencing growth, and we are committed to enhancing our array of disciplines while further developing our existing programs. Specifically, we plan to increase the frequency of men only jiu jitsu classes to twice a week and introduce sessions for children, young men, and women. In the field of archery, we intend to augment the number of students, with a particular emphasis on engaging children. Additionally, we are introducing a horse riding course that will be available for enrolment year-round, not restricted solely to the summer months.


