ACFC are based around a team of volunteers who are responsible for the governance and management of the organisation.

Para 1.17 and 1.19	<p>Due to time constraints, we were only able to host two of our flagship Community Conversations during the reporting year.</p> <p>In November 2024 we discussed Discrimination in the Workplace with guest speaker MJ Maher and in April 2025 we addressed The evolution of the School system with guest speaker Paul Obinna.</p> <p>In the spring of 2024, the Saturday School was renamed the Black Learning & Excellence Saturday School (BLESS). All of our flagship Community Conversations and BLESS programme are delivered via Zoom.</p> <p>BLESS offers a powerful blend of education, history, and health and wellbeing issues specifically aimed at people from the Black diaspora. Feedback shows that these events provided clear public benefit by raising awareness of significant issues</p>

		<p>within the community.</p> <p>These sessions have been instrumental in enhancing participants' knowledge in core subjects like Maths and English as well as looking at prominent Black people in British, US and world history, alongside fostering awareness of mental health and neurodiversity. The ages of the students were between 9 to 16 years old.</p> <p>Some of our sessions were led by our students and after a short absence, we were able to take our young people on two field trips: one within the local area; the other was to The British National Library as part of Black History month. Among the topics/subjects covered by BLESS in the reporting year included:</p> <ul style="list-style-type: none"> • Life stories of prominent Black people in English, US and world history • Maths, English, Geography and History • Riddles and games to consolidate learning during the reporting year <p>Periodical reviews are important as they help young people enhance their knowledge and to recall what they know or remember.</p>

Para 1.17 and 1.19	<p>While we could not hold our flagship Community Conversations due to limited resources, we remain optimistic about resuming these vital discussions in the coming year.</p> <p>Our other main activity, the Saturday School, was more productive. These sessions have been instrumental in enhancing participants' knowledge in core subjects like Maths, English, and Black History, alongside fostering awareness of mental health and neurodiversity. Of the 39 planned Saturday School sessions, we successfully delivered 34 during the reporting year. The other five sessions were either cancelled or postponed because of a family bereavement or due to unforeseen circumstances. The ages of the participants in the school were between 8 to 14 years.</p> <p>Two of our 34 sessions were led by our students; one session was about Neuro-divergent Dyslexia (a condition that can impact learning); the other was about mental health awareness. Other topics/subjects covered in the</p>

		<p>reporting year included:</p> <ul style="list-style-type: none"> • Black History • Maths and English • Geography and History • Quiz and Game <p>To consolidate learning, there are quizzes at the end of each term. These quizzes are mostly a review or a reflection of the previous term's sessions and topics covered. These reviews help young people enhance their knowledge and to recall what they remember.</p>

Para 1.17 and 1.19	<p>Community Conversations, one of the centre pieces of ACFC, have been delivered from 2021-2022 with a total of 50 attendees participating. The following community conversations during this period addressed:</p> <ul style="list-style-type: none">• Mental health approaches to trauma caused by serious youth violence• Trauma of knife crime• Race and racism• Disproportionality of police stop and search. <p>Although it is an identified service, the Community Conversations there was no budget set aside for them.</p> <p>Another ACFC activity is our Saturday School. For children aged 9 - 16 years old, we placed a strong emphasis on non-curricular and co-curricular education e.g. emotional and mental health, cultural heritage, nutrition etc. The supplementation of mainstream education helped to increase the confidence and self-esteem of our targeted group. The Saturday School has proved to be invaluable in strengthening relationships between parents and their children. It also provides opportunity for intergenerational learning which is something we would like to further develop going forwards. The tutors have mainly been individuals who have generously volunteered their time and resources to improve the academic achievement of our targeted group.</p>
