## Trustees Report

### Trust information

Details of trustees and other information are set out on pages 1 & 2 and form part of this report. This report and accounts cover the period 01 January 2024 to 31 December 2024.

### Structure, governance and management

The charity is a CIO governed by a constitution with trust deed dated 15 August 2021. It was granted status on 16 November 2021 and was fully operational, with the main transfer of assets, from 1 April 2022. On completion of all transfers, the previous unincorporated charity (number 1052191) was dissolved on 19 December 2023.

The charity has a Council comprising the trustees. New trustees are elected by the Council.

In 2024 there were two part-time employees (not trustees) and many volunteers.

The charity is in fellowship with Christ Central Churches Worldwide, which is linked to Newfrontiers International Trust Ltd. Christ Central Workington is part of Churches Together in Workington & District, which is then part of Churches Together in Cumbria. Christ Central Workington is part of the Evangelical Alliance.

### Objectives and activities

The objects are for the benefit of the public in such ways and in such parts of the UK or the world as the Charity Trustees from time to time may think fit (1) to advance the Christian faith in accordance with the Statement of Faith, (2) to relieve sickness and financial hardship and to promote and preserve good health by provision of funds, goods or services or support of any kind.

Christ Central Workington operates and maintains the Bridge Centre in Central Square, Workington, providing a place for worship, making facilities available for other community activities, including providing the Workington distribution centre for the North Lakes Foodbank.

The Charity Trustees have had regard to the Charity Commission's guidance on public benefit and, in particular, the specific guidance on charities for the advancement of religion when exercising any powers or duties to which the guidance is relevant.

### Achievements during the year

#### *A place of worship*

##### *Sunday Meetings*

Normally, Sundays start in the café area with coffee and the opportunity to socialise and get to know one another in an informal setting. Then we move into the large hall and have a time of lively worship. People are encouraged to bring testimonies of encouraging events in their lives or to share requests for prayer. A teaching time follows, which outlines principles of the Christian faith and how it relates to our everyday lives, then we enjoy more socialising with more refreshments. Once a month we all have lunch together and invite friends to join us.

A number of international people have joined Christ Central over the last years, and this has added variety in our worship and friendships while extending our family across a number of different cultures, customs and expressions of the one Christianity. There is a separate Malayalam speaking meeting, which attracts other Malayalam speaking families and friends across the Cumberland region.

##### *Children's work*

Through 2022 to 2024 children's work has expanded significantly, with increased numbers of families coming and inviting their friends as well. Our children enjoy being part of our worship times. We seek to facilitate our young people to gain relevant help and teaching. At the end of 2024 there were three separate groups, covering age 2 to infants end of year 2, juniors' years 3-6 with secondary years 7&8 and secondary years 9-13. The situation is continually expanding and requires more space, resources and recruitment of helpers.

### *Small Groups*

A fortnightly Seekers meeting has been vital in shaping our understanding of the way forward and has reassured us that it is “God who builds His church”. It’s a time for seeking God, praying and listening for what God is saying to us.

A prayer group, meeting each week, uses Open Doors material to pray for Christians around the world, particularly where they are most persecuted.

An Alpha course met in the summer term and further Alpha courses are expected in 2025.

A small group enjoy meeting people in the town centre to talk and share the good news while carrying a wooden cross.

Other smaller groups of 2s and 3s meet regularly for bible study, prayer and encouragement.

A men’s breakfast meets once a month, usually in the Carnegie Theatre, gathering men from other churches and those with no church background.

### *Leadership Team*

Mike Renouf has continued in leadership over the year, providing pastoral support, regular teaching, and direction for the church family. He has been specifically assisted by Rob & Jo Horn, together with Ian Ruddick. There is a core group of six who assist with general leadership overview of the church. There is a wider leadership team to manage the many practical and operational aspects of church life and management of facilities.

### *Churches Together in Workington and District*

Christ Central has been a key member, seeking to support and encourage other churches in the area. We are regular attendees at the meetings and have been involved in the events the group has organised. We enjoy the love, friendship and mutual trust among several of the local churches, and we look forward to working more together for the good of our town and its people.

### **Foodbank**

Throughout 2024, Foodbank has continued to operate from the Bridge Centre. Most weeks we were feeding 30 people. We were aware of food pantries and other emergency provision available in the area and were able to ensure that needy people could access all that was available locally.

Over the school holidays at Easter, in the summer, and at Christmas, Foodbank gave out Kids Lunch Packs to families on benefits with children in receipt of Pupil Premium.

Foodbank has a Finance Inclusion Officer who operates at the Bridge Centre, working alongside the team in West Cumbria. This has helped local people with financial problems and has ensured that they are getting all the benefits due to them.

The ‘Green Doctor (funded by Groundworx) gives advice during Foodbank sessions on energy efficiency and fuel bill issues.

### ***Making facilities available for other community activities***

The Bridge Centre has been made available for use by the following organisations

- Alcoholics Anonymous meet weekly
- Narcotics Anonymous meet weekly since 19 March 2024
- Our partnership with Victim Support continues. The Turning the Spotlight programme has used our premises for a number of courses, programmes and drop-in sessions throughout the year, as they seek to prevent domestic violence locally
- Parkinson’s Carers met regularly at the building until October 2024, when their coffee mornings came to an end
- Hospice at Home West Cumbria use the building regularly for staff meetings and training
- Cumberland Council have used the building for a local government election and a social prescribing information day, and they will use the venue again
- Westmorland and Furness Council, which operates adult education services across Cumbria, began using the building during the autumn term to run an English for Speakers of Other Languages (ESOL) course, an ongoing programme which will continue into 2025

- Team Autism began using the building in July 2024 for regular lunch club sessions and occasional training events, which will continue into 2025
- Workington's Carnegie Singers used the venue for their Christmas concert in 2023 and 2024 and have asked to use it again for this event in 2025.

### **Trustees**

The trustees met 5 times in 2024 covering

- financial and budgeting reviews against intended and future activities, including investments
- employment and wages, contracts and agreements
- getting more space in the building and elsewhere, short term and long term
- away days and away weekends
- continual safeguarding review
- maintenance, new equipment and technology enhancements
- support for visiting speaker commitments
- trustee changes
- accident and incident reviews
- provision of specific training funding
- spending delegations

The trustees recognise the significant contributions from many volunteers to the charity's objectives and activities.

### **Future plans**

We plan to consolidate and continue what we have done in 2024, including looking for ways to continue our benefit to our community. We still actively pursue assistance to maintain and extend our activities and effectiveness.

A number of organisations have indicated that they wish to continue using the Bridge Centre in 2025.

We have an increasing number of youth in Christ Central and are looking to provide resources and space for these age groups, not only on Sundays but during the week.

We have realised the benefit of away-days and weekends as a means to getting to know everyone better and inviting friends and new people to benefit from the Christ Central family. 2025 will have an away-weekend in June and possibly another away-day in the autumn, with other potential activities in the summertime. We have also provisionally booked for an away-weekend in June 2026.

### **Financial Review**

Income and expenditure for 2024 (and 2023 in brackets) were £71,226 (£63,237) and £60,323 (£41,193). This gave a net surplus of £10,904 (£22,044).

Current assets at 31 December, apart from the Bridge Centre, were £107,400 (£96,496), of which £86,641 (£67,766) were held in savings accounts, £14,426 (£22,158) were held in current accounts and petty cash was £117 (£146). There were no funds in deficit.

The Malayalam-speaking worship group, raising separate offerings and having separate expenses, has a designated fund.

The provision for Visiting Support changed during 2024 and a designated fund has been set up, with contributions being received from other churches and transfers from our undesignated funds. The end of year balance carries over for continued donations in 2025.

Income increase in 2024 is due to more people and more generous giving. 2023 had a specific gift of £12,000.

Expenditure increases in 2024 relate to higher ministry costs, more youth work, more donations, weekend away costs, more specific charitable administrative assistance, the loft project feasibility, more maintenance, repairs and equipment.

- The Day/Weekend away costs are high in 2024 not only for the cost of the weekend and day away events in 2024 but also in placing deposits for events in 2025 and 2026 (£3,900 total)

- Administration is for both charity management and charitable activities management
- The loft project involved professional fees to explore getting more space from the Bridge Centre loft area. The designs meant that there would be too many constraints and loss of space on the ground floor (due to stairs, lift, etc.) and therefore little gain in space overall, for quite high costs
- Maintenance included replacement of various smoke detectors and the main hall high level lighting and smoke detectors
- More equipment has been purchased for more live worship both in the Bridge Centre and elsewhere.

### **Reserves**


The charity has a policy on reserves, covering 6 months operating costs, review and termination/windup considerations. At 31 December 2024, the charity held funds of £107,400 that will cover operating costs and

- payment of further employment and contracts, as required
- specific projects either in the community or abroad
- building, projects, maintenance and repairs contingencies

By the end of 2023 there were four separate groups, covering age

2 to infants year 2, juniors years 3-6, secondary years 7&8 and secondary years 9-13. The situation is expanding and requires more space, resources and recruitment of helpers.

#### *Small Groups*

Through 2023, small groups were partly on hold as we piloted a small group with different emphasis – seeking more specifically to invite friends who would not perhaps attend church normally but would attend a low-key friendship group.

A fortnightly Seekers meeting has been vital in shaping our understanding of the way forward and has reassured us that it is “God who builds His church”. It’s a time for seeking God, praying and listening for what God is saying to us.

The fortnightly Prayer Meeting has been less frequent in 2023 (partly replaced by the Seekers meeting) but it has been encouraging to look back and realise how many of our prayers over the years are now being realised.

A prayer group, meeting each week, uses Open Doors material to pray for Christians around the world, particularly where they are most persecuted.

Other smaller groups of 2s and 3s meet regularly for bible study, prayer and encouragement.

A men’s breakfast meets once a month, usually in Monroe’s bar in the Carnegie Theatre, gathering men from other churches and those with no church background.

#### *Lunch Club*

The over-55s Lunch Club used to meet once a month and offered a good two-course meal at a reasonable price to between 40 and 50 people. After closing Lunch Club in March 2020, it was opened again in November 2021. We had lost quite a few to Covid-19, deaths and ill health so numbers were down and it was difficult to get regular volunteers. Lunch club stopped in April 2022.

#### *Leadership Team*

Mike Renouf has continued in leadership over the year, providing pastoral support, regular teaching, and direction for the church family. He has been specifically assisted by Rob & Jo Horn via Whitehaven Grace Church, together with Ian Ruddick. A core group of six has been formed and five were able to attend a Christ Central Churches leaders’ Conference. A wider leadership team has been assembled to manage the many practical and operational aspects of church life and management of facilities.

#### *Churches Together in Workington and District*

Christ Central has been a key member, seeking to support and encourage other churches in the area. We are regular attendees at the meetings and have been involved in the events the group has organised. We enjoy the friendship and mutual trust among several of the local churches, and we look forward to working more together for the good of our town and its people.

#### *Toddler Group*

Toddler Group has not restarted since we closed it due to the lockdown in March 2020. It was hugely popular and controlling numbers and ensuring safety was a challenge. We had hoped to restart the group on a smaller scale, with a different focus but this has not been the case as we have redirected resources into other activities for now.

#### **Foodbank**

Throughout 2023, Foodbank has continued to operate from the Bridge Centre. Most weeks we were feeding 30-40 people. We were aware of food pantries and other emergency provision available in the area and were able to ensure that needy people could access all that was available locally.

Over the school holidays at Easter, in the summer, and at Christmas, Foodbank gave out Kids Lunch Packs to families on benefits with children in receipt of Pupil Premium.

### ***Making facilities available for other community activities***

The Bridge Centre has been made available for use by the following organisations

- Alcoholics Anonymous meet weekly
- Our partnership with Victim Support continues. The Turning the Spotlight programme uses our premises for up to three courses almost continually, as they seek to prevent domestic violence locally
- The local GP practices hold team training sessions and other meetings
- Parkinson's Carers meet regularly
- Hospice at Home West Cumbria use the building regularly
- Cumbria County Council / Cumberland Council have used the building for a local government election and an exposition, and they will use the venue again
- The NSPCC used the Bridge centre for a Childhood Day.
- Workington's Carnegie Singers used the venue for their Christmas concert and have asked to use it again for this event in 2024.

### ***Trustees***

The trustees met 4 times in 2023 covering

- financial and budgeting reviews against intended and future activities
- employment and wages
- training
- donations to other organisations
- away day and away weekend
- New policies (e.g., complaints, conflict of interest, risk management and its register) policy reviews and risk assessment reviews
- maintenance, new equipment and technology enhancements
- getting more space in the building, short term and long term,
- town building projects
- wider leadership team

### **Future plans**

We plan to consolidate and continue what we have done in 2023, including looking for ways to continue our benefit to our community. We still actively pursue assistance to maintain and extend our activities and effectiveness.

A number of organisations have indicated that they wish to continue using the Bridge Centre in 2024.

We have an increasing number of youth in Christ Central and are looking to provide resources and space for these age groups, not only on Sundays but during the week

We are exploring gaining more space in the building (using loft areas) with the help of a local architect and design company.

We have realised the benefit of away days and weekends as a means to getting to know everyone better and inviting friends and new people to benefit from the Christ Central family. 2024 will have an away weekend in March and probably another away day in the autumn, with other potential activities in the summertime.

### **Financial Review**

2022 figures only cover 9 months of CIO operation from 01/04/2022, when transfer of assets occurred from the previous unincorporated charity (number 1052191). The 2022 figures listed therefore only relate to CIO and not the whole of 2022, which included the previous charity.

Income and expenditure for 2023 (and 2022 in brackets for CIO/both charities) were £63,237 (£25,455/£38,968) and £41,193 (£23,818/£41,065). This gave a net surplus of £22,044 (£1,637/deficit £2,097).

Current assets at 31 December, apart from the Bridge Centre, were £96,496 (£74,452), of which £67,766 (£49,260) were held in savings accounts, £22,158 (£20,237) were held in current accounts and petty cash was £146 (£109). There were no funds in deficit.

Introduction of a Malayalam-speaking worship group, raising separate offerings, has led to the introduction of a designated fund in 2023 covering this group.

A one-off gift of £12,000 was granted to Christ Central Workington early in 2023. The gift and the Malayalam offering, together with some generous donors, has increased specific income in 2023 significantly. Income in 2024 may well be less than in 2023.

While overall expenditure between 2022 and 2023 is similar, cost increases in 2023 relate to higher wages, higher contributions for visiting speakers, paying for more training of volunteers and paying for more administrative assistance.

### **Reserves**



**6 CIO Conversion**

The CIO took over all operations from the charity (reg no 1052191) with effect from 1 April 2022 under a transfer agreement dated 16 November 2021. The transfer of all assets, liabilities etc has been completed and an application is currently with the Charity Commission to dissolve the charity.
