They also undertook physical challenges including a day-long volcano hike and two snorkels.
- Planted wild flower seeds in Wakehurst – Kew Gardens wild botanical garden to continue to work to offset our carbon emissions from expeditions.
- Highlighted the need for diversity within the adventure fields across multiple media platforms and events - including Sky News, Travel Weekly, the RGS and various Scouts talks.
- Provided references for several of our young people - two of whom secured places at university being the first in their families to do so, the other secured a paid work placement which resulted in a job offer.
- Premiered #WeTwo: Changing the Face of Adventure film in London at Kew Gardens at a special event, bringing some of our young people together from Antarctica for a reunion on stage for a Q&A, proving to sponsors and donors the difference the charity makes in our YP's lives and securing additional fundraising.
- Began planning for our 1-day fundraiser to increase donations into the Foundation for the next expedition.

These included: Seed collecting and planting in Leeds, organised litter picks in Surrey, High Wycombe (with youth group), Manchester (with youth group), Wales (Borders), Hampstead, Birmingham (organised with the school), work in the local community gardens of north London, south London and Glasgow, joining local climate change programme (London).

- **OPPORTUNITY AND MENTORING:** The Foundation provided further references for several of the young people from the Antarctica programme, with one getting a full time paid work placement thanks to networking through the Foundation's contacts.

- **YOUTH TALKS:** One of our YP from Scotland continues to give talks across the country inspiring other young people as a positive role model from their region, he has gone on to volunteer as a Scout leader. Additionally, three of the young people from the Galapagos have already given talks to their schools and Scout groups to showcase their learning from the trip. The remainder of the YP plan to do the same.

Key Priorities

To achieve the WeTwo Foundation's C.I.O. strategic priorities in the coming year, the charity proposed to implement the following strategic actions:

- Enhance the relationship with existing partners and foster new contacts to secure further funding for future expeditions and opportunities for our young people.
- To take a further 10 YP on another lifechanging expedition - this time to Morocco – to help rebuild a village road post-earthquake, walk and camp in the Sahara and climb Toubkal the highest peak in North Africa.
- Increase fundraising activities throughout the year and encourage all our young people to help.
- Launch the Galapagos film in a venue TBC to encourage further donations with key donors and make the charity more visible.
- We are still in need of a Finance Officer - this is a priority for the coming 12 months, and continues to be difficult to recruit for. We also need a fundraiser and an administrator potentially.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 4 April 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

Overview

The Trustees report outlines the activities, achievements and financial performance of the WeTwo Foundation C.I.O., a registered charity (Charity Number: 1196799) focused on empowering underprivileged young people through life-changing adventures.

OBJECTIVES AND ACTIVITIES

Objectives and aims

The primary objectives of the WeTwo Foundation C.I.O. are to:

- Give underprivileged young people from deprived areas, the chance to partake in once-in-a-lifetime expeditions in unique countries and eco-systems to enhance their CVs with vital life skills, boost their confidence and become role models for their peers and local communities.
- Encourage, develop and foster the young people to partake and start environmental and sustainable projects that will benefit their local communities (our "Pay it Forward" pledge that all participants agree to work towards).
- Mentor the next generation of climate-conscious explorer to create more diversity in the adventure community.

Significant activities

During the reporting period, the WeTwo Foundation C.I.O.:

- Continued mentorship work with the 10 underprivileged young people (aged 16-19) from deprived areas of Scotland, Wales, Northern Ireland, North and South England who came with us to Antarctica, to help them improve their employability and network to maximise job and further educational opportunities.
- Secured several paid speaking opportunities for our young people to give them experience in public speaking, add skills to their CV and boost confidence.
- Planted 120 more trees in East London to continue to work to offset our carbon emissions from expeditions.
- Highlighted the need for diversity within the adventure fields across multiple media platforms and events - including the National newspapers and Cardiff Uni, 5x15, Antarctic Heritage Trust podcast, Scouts and Kew Gardens.
- Provided references for several of our young people - two of whom secured places at university being the first in their families to do so, the other secured a paid work placement which resulted in a job offer.
- One of our young people returned to his school and talked 3 young boys out of joining gangs.
- Secured supplies left over from Hampton Court Palace Garden Show to donate to 3 of our young people's pay it forward projects in North and South London and Birmingham.
- Premiered #WeTwo: Changing the Face of Adventure film at Kendal Mountain Festival, bringing all our young people together for a reunion on stage for a Q&A, proving to sponsors and donors the difference the charity makes in our YP's lives and securing additional fundraising.
- Undertook a UK fundraiser with 6 of our young people from Antarctica walking the width of mainland Britain - 100 miles - in 4 days, raising over £5,000.

OBJECTIVES AND ACTIVITIES

Beneficiaries and Impact

- **PAY IT FORWARD PROJECTS:** Each of the 10 participants who journeyed to Antarctica undertook environmental projects in their local communities. Since returning several of them are still volunteering. Furthermore the WeTwo Foundation managed to secure donated supplies from Hampton Court Palace to give to three of these initiatives in North and South London and Birmingham. All supplies were sustainable and made from recycled and locally sourced materials, maintaining the values of our charity even in our donations.

- **OPPORTUNITY AND MENTORING:** The Foundation provided further references for several of the young people two more have gone to university, and one has, after getting a paid work placement thanks to networking through the Foundation's contacts, been offered a job in his chosen career.

- **YOUTH TALKS:** One of our YPs continues to give talks across Scotland inspiring other young people as a positive role model from their region. Additionally, all the YPs took to the stage at Kendal Mountain Festival in a Q&A session, discussing how much they have changed through working with WeTwo, inspiring over 200 people in the audience. The film made from the expedition proved a great way of showing why changing the face of adventure makes a real difference to individuals and their communities.

Key Priorities

To achieve the WeTwo Foundation's C.I.O. strategic priorities in the coming year, the charity proposed to implement the following strategic actions:

- Enhance the relationship with existing partners and foster new contacts to secure further funding for future expeditions and opportunities for our young people.
- To take a further 10 YP on another lifechanging expedition - this time to Galapagos - in Darwin's Footsteps. We have secured a partnership with Intrepid to make this happen for October 2024. And to work with those young people to help Pay it Forward in 10 new communities.
- Increase fundraising activities throughout the year and encourage all our young people to help.
- Launch the film in London to encourage further donations with key donors and make the charity more visible.
- Attain Gift Aid status.
- We are still in need of a Finance Officer - this is a priority for the coming 12 months.

FINANCIAL REVIEW

Reserves policy

The WeTwo Foundation C.I.O. maintains a Reserves Policy of a minimum of £5,000 to ensure sufficient funds are available to cover operational costs and unexpected expenses. When on overseas expeditions the Reserves Policy increases to cover any unforeseen costs relating to the health and safety of young people (i.e. upfront costs of an emergency evacuation etc).

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the period 26 November 2021 to 4 April 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

Overview

The Trustees report outlines the activities, achievements and financial performance of the WeTwo Foundation C.I.O., a registered charity (Charity Number: 1196799) focused on empowering underprivileged young people through life-changing adventures.

INCORPORATION

The charitable company was incorporated on 26 November 2021 and commenced trading on the same date.

OBJECTIVES AND ACTIVITIES

Objectives and aims

The primary objectives of the WeTwo Foundation C.I.O. are to:

- Give underprivileged young people from deprived areas, the chance to partake in once-in-a-lifetime expeditions in unique countries and eco-systems to enhance their CVs with vital life skills, boost their confidence and become role models for their peers and local communities.
- Encourage, develop and foster the young people to partake and start environmental and sustainable projects that will benefit their local communities (our "Pay it Forward" pledge that all participants agree to work towards).
- Mentor the next generation of climate-conscious explorer to create more diversity in the adventure community.

Significant activities

During the reporting period, the WeTwo Foundation C.I.O.:

- Worked with 10 underprivileged young people (aged 16-19) from deprived areas of Scotland, Wales, Northern Ireland, North and South England to help them improve their local communities through environmental/sustainable projects.
- Mentored the 10 young people for a total of two year - pre, during and post expedition - to identify work opportunities, provide references and enhance their CVs.
- Taken the 10 young people to Antarctica on a carbon neutral (eventually becoming negative) expedition where they were working with scientists to collect data, supporting crew members with key tasks, identifying and logging species as part of wider research programs and undertaking a group presentation about how people can be more environmentally friendly in their travels and at home.
- Planted 120 trees in East London (the start of the WeTwo Forest) and a community of trees in Kew Garden's conservation Area.
- Highlighted the need for diversity within the adventure fields across multiple media platforms. The trip garnered more than 30 hits with media including the BBC, Sky News, ITV, and national and regional newspapers.
- Talks : In 2022 and 2023 Phoebe, Dwayne and the YPs did several talks about the WeTwo expedition. These include: Keswick Mountain Festival, Kew Gardens, Scouts, Antarctic Heritage Trust, British Exploring, 5x15 and Cardiff Uni for which we secured payment for our young people.

OBJECTIVES AND ACTIVITIES

Beneficiaries and Impact

- **PAY IT FORWARD PROJECTS:** Each of the 10 participants who journeyed to Antarctica undertook environmental projects in their local communities. These included: rewilding a section of the River Clyde in Scotland, removing invasive species from the Black Mountains in Belfast, multiple beach and town clean ups in Devon, Essex and Wales, a clothing swap in Liverpool (where people 'paid' for their items with sustainability pledges), plastic bottle collection to build a greenhouse for a local youth group in inner city Birmingham, fruit and veg garden establishment in a Nottingham school to reduce food miles and help provide for the poorest children, working to get a London School certified Green Flag status, removing debris and replanting key vegetation in London's wetlands.

- **OPPORTUNITY AND MENTORING:** The Foundation provided references for several of the young people and actively sort opportunities for them in the year since Antarctica (2023). In that time three have got on to university, four have gained jobs and one is about to start an apprenticeship.

- **YOUTH TALKS:** One of our YP has given 10 talks across Scotland. Additionally, five of our YPs have given talks at their schools/unis/youth groups. One gave a talk to the local police. Another has talked 3 boys from his old school out of joining gangs in an ongoing mentorship programme.

Key Priorities

To achieve the WeTwo Foundation's C.I.O. strategic priorities in the coming year, the charity proposed to implement the following strategic actions:

- Enhance the relationship with existing partners and foster new contacts to secure funding for future expeditions and opportunities for our young people.
- Secure destination for the next expedition with a focus on following in the footsteps of a historical figure to attract quality nominations and media interest in the charity.
- To encourage the YPs from the Antarctic expedition to help us fundraise for the next group of YP.
- To complete the edit of the documentary from Antarctica and use this as a fundraising and awareness tool to help promote the charity and the work we do.
- Increase fundraising activities throughout the year
- Look into Gift Aid registration
- Due to employment commitments our finance officer, Mark Stinson, had to step down a week before this report was due. We are seeking a replacement and have appointed AGK Partners as our accounting firm going forwards.
