## **Trustee Report**

### **Our Aims and Objectives**

ZOF strives to empower Zimbabwe's next generation of entrepreneurs by funding digital technology education. We also arrange mentorship and career guidance for aspiring young entrepreneurs. We pair courses with laptops and educational aids which are gifted by corporate sponsors.

### **How our activities deliver public benefit**

ZOF works with local partners to provide technology educational courses directly to youths from low-income backgrounds in Zimbabwe. Our aim is to create a positive feedback loop where the graduates of our courses will obtain the resources to impact the next generation.

The Trustees have had due regard to the Charity Commission's guidance on Public Benefit.

### **Who used and benefitted from our services?**

In 2024, ZOF empowered 90 high-potential, low-income students across Zimbabwe through transformative education in coding, robotics, digital marketing, entrepreneurship, and career development.

### **Key Milestones**

- 90 students funded for foundational and advanced training
- 25 students progressed to follow-on courses
- 6 students from the 2023 cohort placed into internships
- First all-girls career coaching workshop conducted
- In-house assessments launched to track student progress and identify top talent
- Hosted a national webinar on Innovations in Digital Payments in Zimbabwe

### **Coding & Robotics**

- 50 students (60% girls, ages 14–18) trained in coding and robotics in Epworth
- 60% were first-time laptop users
- 25 top performers advanced to an intensive robotics course
- Students built functional robots, gaining skills in sensors, logic, and teamwork
- Career readiness sessions led by Joy Mahobebe resulted in professional CVs and greater confidence

### **Digital Marketing Training**

- 21 students (62% women, ages 18–35) completed an 8-week practical training in SEO, social media, and email marketing
- Delivered in partnership with Afrodigital and Miracle Missions Vimba
- Focused on employability in Zimbabwe's growing digital economy

**Girls' Career Coaching Workshop**

- 13 teenage girls from a children's home attended a 3-day workshop on entrepreneurship, goal setting, and workplace etiquette

**Internship Opportunities**

- 6 top students from 2023 placed in internships with partners like The Maker Club
- Internships provided critical real-world exposure and professional development
- ZOF aims to expand internship placements for 2024's top students



### How our activities deliver public benefit

ZOF works with local partners to provide technology educational courses directly to youths from low-income backgrounds in Zimbabwe. Our aim is to create a positive feedback loop where the graduates of our courses will obtain the resources to impact the next generation.

The Trustees have had due regard to the Charity Commission's guidance on Public Benefit.

### Who used and benefitted from our services?

During the year we partnered with the local partners to enable the following courses:

- 125 students funded in high density suburbs of Harare to take courses in robotics and coding, with some career coaching alongside these technical courses
- We funded our first all-girls coding class of 30 girls
- We developed in-house assessments developed to track the potential & progress of students
- In Q4, we doubled down on 25 students who demonstrated exceptional ambition. During an 8-weekend course, they deepened their understanding of critical tech fields, including 3D printing and digital design
- This year (2024), we have secured 6 internships for 2023's top students to teach them critical workplace etiquette and grow their networks. All students have demonstrated incredibly high ambition for learning and growth
- We donated 63 laptops for courses in Zimbabwe
- Career coach Joy Mahobele developed a robust career readiness & leadership skills curriculum that resulted in increased confidence and impressive CVs designed on Canva

## **Trustee Report**

### Our Aims and Objectives

ZOF strives to empower Zimbabwe's next generation of entrepreneurs by funding digital technology education. We also arrange mentorship and career guidance for aspiring young entrepreneurs. We pair courses with laptops and educational aids which are gifted by corporate sponsors.

### How our activities deliver public benefit

ZOF works with local partners to provide technology educational courses directly to youths from low-income backgrounds in Zimbabwe. Our aim is to create a positive feedback loop where the graduates of our courses will obtain the resources to impact the next generation.

The Trustees have had due regard to the Charity Commission's guidance on Public Benefit.

### Who used and benefitted from our services?

ZOF was registered as a UK charity in December 2021. In our first year of activity our local delivery partners were Start Innovate Grow (SIG); Zimbabwe Flyng Labs and Precision Aerial; Makers Club. Our Beneficiary carers were Emerald Hill Children's Home (EHCH), St Joseph's Home for Boys, both in Harare, and King George VI School in Bulawayo.

During the year we partnered with the local partners to enable the following courses. The total number of student beneficiaries was 109:

- Precision Aerial delivered a two-day drone operating workshop for 10 boys at King George School and 13 young people at EHCH. Drone flying is increasingly relevant in Zimbabwe and further develops STEM skills.
- Makers Club delivered a basic Python coding course for 12 youths at EHCH and a robotics and coding course for 4 more juniors at EHCH.
- SIG provided career counselling at an Entrepreneurship Day for 10 youths and further career counselling for 7 youths at St Joseph's boys.
- Donated and funded the shipment of 16 used computers and 2 used iPhones to St Joseph's and EHCH. We partnered with corporate sponsors in UK to donate many more used computers in 2023.
- Funded vocational support advice for former residents of EHCH who are benefitting from our Big Sister mentoring programme.
- CV building workshop and mentoring advice conducted remotely at EHCH for 15 – 18-year-old girls who are close to leaving the institution in search of future careers.
