The trustees are pleased to present their report together with the financial statements of the charity for the year ended 1ST of October 2022

Structure, Governance and Management

Objectives and Activities

The objects of the Iremide Charity Foundation is the prevention or relief of poverty in Greater Manchester and Nigeria, By providing Grants, items and services to individuals in need, charities or other organisations working to prevent or relieve poverty.

Support work in Manchester

We support the less privileged in Manchester by providing them this clothing, household items, and food supplies.

Support work in Nigeria

We support the work of the youth in Lagos, Ogun and Ekiti state, who have limited access to clothing, standard technological items like laptop, computers and printers, phones, books, clean water by providing them with these items for personal use.

Financial Sources

The church income comes mainly from Public voluntary donations.

Statement of Trustees' responsibilities

The Board of Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice.

I report on the financial statements of the charity for the year ended 1st October 2022 which comprise the Statement of Financial Activities and Balance Sheet with associate notes.

This report is made solely to the charity's Trustees, as a body, in accordance with section 145 of the Charities Act 2011 and regulations made under section 154 of that Act. My work has been undertaken so that I might state to the charity's Trustees those matters I am required to state to them in an Independent examiner's report and for no other purpose. Respective Responsibilities of Trustees and Examiner

The charity's Trustees are responsible for the preparation of the financial statements, and they consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the Act) and that an independent examination is needed.
