(d) in the written opinion, given to the company, of a registered medical practitioner treating that person, has become physically or mentally incapable of acting as a director and may remain so for more than three months;

(e) can no longer subscribe in good conscience to the statement of faith in the Schedule; or if his or her conduct is, in the reasonable opinion of the other charity trustees after hearing representations from the charity trustee concerned, seriously inconsistent with that expected by the Christian scriptures of a Christian in good standing.





