There are no employees and the Trustees carry out the administration.

The objects of the charity are to advance such exclusively charitable objects and purposes (according to the laws of England and Wales) as the Trustees in their discretion think fit from time to time, including but without prejudicing the generality of the foregoing:

3. the advancement of religion
4. the advancement of health or the saving of lives
5. the relief of those in need, by reason of youth, ill-health, disability, financial hardship or other disadvantage
6. any other charitable purpose

Reporting Serious Incidents

Activities undertaken for the public benefit

Initially, the Trustees intend to provide funding principally to charities which are involved in: the advancement of education, the advancement of health or savings of lives, relief of those in need, the prevention of or relief from poverty and the advancement of religion (principally Christianity).

The Trustees will consider who to benefit based on their meeting the charity's stated charitable purposes, aims and objective and based on the geographical location and size.

Financial Review

In summary in 2022/23:

Expenditure on Charitable Donations totalled £30,000.

Voluntary Income was £36,714, consisting wholly of donations received.

Total funds carried forward were £11,814 as at 5 April 2023, consisting wholly of a cash balance at the Bank.

- preparing the accounts on a going concern basis unless it is inappropriate to presume that the charity will continue in operation.



1 BASIS OF PREPARATION

Basis of accounting

The accounts are prepared under the historical cost convention, modified to include the revaluation of Investments, in accordance with the Charities Act 2011.

2 ACCOUNTING POLICIES

a) Recognition of incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy.

b) Donations

Donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Expenditure and Liabilities

c) Liability recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

d) Charitable expenditure

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

e) Governance costs

Governance costs relate to the costs of the preparation and examination of statutory accounts, the costs of trustees meetings and cost of any legal advice to trustees on governance or constitutional matters.

f) Fund Accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.
