We provide 3 hours a week of athletics training to young and old who have a disability. We extended the time of our training session on both days to help those who needed a little more attention to improve their skills and fitness.

We provide, organise and accompany all athletes to athletic competitions locally, regionally, nationally and internationally.

It has been a very busy year for competitions,
We have attended Indoor competitions at Manchester Championships at Sheffield (seniors and juniors)
Championships at Birmingham (seniors and juniors)

We have attended competitions that have lasted over a whole weekend nationally with Activity Alliance.

We attended the Cerebral Palsy Games in Coventry this year.

We hosted our first home competition; it was well attended and everyone seemed to enjoy themselves.

We have 2 Paralympians who attended the World Championships in India and they came away with a Gold medal in their 400M event.

2025 at Bradford Sports Awards, saw recognition for Guillaume for receiving a Bronze medal at the Paris Paralympics (2024).
Also, recognition for an athlete with Downs Syndrome as the first athlete to be attending the European Championships in Prague (2025).

There were 2 athletes who competed in their first Equestrian competition, in Sheffield, both came away with medals and are looking forward to their next competition. The plan is to try and encourage more to take part in the Equestrian club and for them to be able to have more opportunities to compete.

We continue to fundraise at local galas and encouraged the athletes to actively take part. This has been a good way of promoting the club but also, showing positively what people can achieve when they have a disability.

We also now provide 1 and a quarter hour of a swimming training session every week for young and old who have a disability. We are looking into providing swimming lessons in addition to a swim training session as we are constantly being asked if we provide swimming lessons for people with disabilities.

We attend swimming Galas nationally at Special Olympics level with the group now. We are hoping to widen their scope by registering with England Swim, hopefully this will be completed in 2025. This is still ongoing.

All our volunteers work hard to improve the athletics, swimming and Equestrian of all those who want to take part, who have a disability. A lot of the work is behind the scenes, whether preparing information for a grant or preparing for a competition etc...

Some of our volunteers have undertaken training to support the efficiency and running of the club. Some of the Athletes have taken up training to become Assistant Coaches and are now an important part of the Coaching Team.

Our volunteers get behind any fundraising that is going on, help with bids for grants, take photos at competitions, act as support workers when needed (all DBS checked).

One Athlete won a Gold Medal in his 400M event at the World Games in India.
Our Juniors and seniors who were invited to attend the Championships in Birmingham and Sheffield, all came away with medals.
Every competition we have attended this year we have come away with medals.
We continue to participate in the West Yorkshire Track and Field League.

We have over 40 athletes on our books and over 20 swimmers. We are offering 3 physical activities a week. We have arranged the pricing so that the more activities the athletes do per week, it's offered to them at a reduced rate. This is encouraging athletes to do more than one physical activity a week. Some even do all 3.

We are the largest Athletics Group in Yorkshire.

We have a large swimming team now.
One of the swimmers has been recognised by the paralympic swimming team and is being encouraged to train and compete with the paralympic team.

2 of our athletes have taken up their coaching certificate and are active in the training sessions as coaches.

Recognition for all athletes' achievements in the form of an annual presentation and in announcements on the group chat and at training, where appropriate.

Also, recognition at the Bradford Sports Awards for recognition of achievements for Paralympic games in Paris and for one of our athletes who was the only athlete to compete and represent GB with Down's Syndrome at the European Downs Games in Prague.

The Trustees are actively involved in the club, this is because their children are involved in athletics but it also means that they have a better understanding of what the club needs and of the challenges that many people with disabilities face on a day to day basis.

In 2025, we managed to raise £6,000 and this was enough for Keighley Town Council to release the funds for the £10,000 late 2025. We can now proceed with purchasing of the much-needed equipment for the wheelchair users.

We secured a grant for training, we are looking at other volunteers and athletes, who might be able to be put forward to do the training.




