REPORT OF THE TRUSTEES

The Trustees present their report and unaudited financial statements of the Society for the period ended 31 December 2022.

The Byron Society (the 'New Society') is a Charitable Incorporated Organisation ('CIO') which was registered with the Charities Commission on 23 December 2021 (charity number 1197293).

The New Society did not conduct any activity in the period under review. During the financial year ended 31 December 2022, the unincorporated Byron Society (the 'Old Society', charity number 265458) continued to conduct the activities of the charity, as reflected in its financial statements for that period, filed with the Charities Commission on 31 October 2023.

Pursuant to an agreement dated 31 December 2022, the Trustees of the Old Society transferred the whole undertaking of the Old Society as a going concern, with all assets and liabilities, including, without limitation, book debts, cash, contracts, gifts, goodwill, intellectual property rights, rights of action and records, to the New Society.

The New Society therefore conducted the activities of the charity from 1 January 2023, as will be reflected in its first full financial statements for the financial year ended 31 December 2023.
