A non-trustee was substantively involved in helping the trustees with the above work and a politics events team of volunteers was established but the onset of exams prevented much work before the end of the 2022 academic year. As all the trustees are no longer students in the Greater London area and have been unable to create momentum behind London Speakers Union, we plan to close the charity and delist it from the charities register in the coming weeks (this document being filed in April 2023 as per the Commission's guidelines).</p>
