<p>Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.</p>	<p>Para 1.17 and 1.19</p>	<p>Activities in Relation to the First Purpose – Health Care Support in Rural Ivory Coast</p> <p>In line with the Yahjireh Foundation’s first charitable objective — to provide education and healthcare assistance to vulnerable people in rural areas of the Ivory Coast — the following key activity was undertaken during the reporting period:</p> <p>The Foundation successfully organised a medical outreach campaign for three days in the villages of Djoroplo and Lypoyo, located in the Sassandra region of the Ivory Coast.</p> <p>The campaign provided free medical consultations and essential medication to approximately 1089 individuals from the local community, many of whom have limited or no access to regular healthcare services.</p> <p>The most commonly identified and treated conditions included malaria, hypertension, diabetes and minors sugeries were performed— reflecting the prevalent health challenges faced by rural populations in the region.</p> <p>This initiative not only provided immediate relief to those treated but also raised health awareness within the community and reinforced the Foundation’s commitment to improving healthcare access in underserved areas.</p>

Total income for the year amounted to £3000 derived from a combination of individual donations, corporate contributions.</p> <p>Expenditure for the year totalled £3000, primarily directed towards programme activities in both the Ivory Coast and Kettering. Key areas of expenditure included:</p> <p>Educational support (scholarships and school supplies)</p> <p>Medical outreach campaigns (including medicines and minor surgeries)</p> <p>Refugee support services (language classes, job readiness training)</p> <p>Emergency aid for widows and orphans</p> <p>The charity ended the period with net assets of £250, including cash reserves of £250. These reserves will support ongoing and upcoming projects, ensuring continuity of services and sustainability.</p> <p>The Trustees are satisfied that the financial management of the charity is sound. Adequate controls and budgeting processes are in place, and the charity has no significant liabilities at the period end.</p>
