The St Nicolas School and Education Trust Abingdon has not yet begun its charitable activities.

With the notification (in July 2024) of the Retirement of the Team Rector with effect from November 2024, momentum slowed, and was further affected by the unavailability through ill health of one Trustee for much of January & February 2025.

The provision of Bibles to St Nicolas School (established by tradition by the existing Trust) continued.

It is hoped that 2025-26 will see

- A new Team Rector, and thus Trustee, in post
- The completion of negotiations with the Charity Commission
- The transfer of assets to the chosen Investment Company
- A renewal of the lease to the St Nicolas Pre-school, for the provision of preschool services
- Adoption of appropriate policies

so that the Trust is able to start work in direct furtherance of its charitable objectives in the year.

The St Nicolas School and Education Trust Abingdon has not yet begun its charitable activities.

Since its incorporation Trustees have been working with its advisors to

- Appoint Financial Advisors in preparation for a transfer of assets
- Create a sound framework for effective governance
- Establish policies for future activities (such as a Grant Making, Investment Management, Risk Assessment etc)
- Obtain Charity Commission agreement to a transfer of assets from the Oxford Diocesan Trust to the St Nicolas School and Education Trust Abingdon
- Obtain Charity Commission consent to the termination of two Recoupment Orders (of 5 April 2004 and 21 December 2004) on some of the funds to be transferred.

Discussions with the Charity Commission have been protracted and are ongoing. The Trustees believe that it is best for these to be concluded before seeking to start operations.

Looking ahead to management of the charity's assets 'in house' the Trustees met in the summer and early autumn to identify and select an investment management firm in readiness for the eventual transfer of funds to the CIO. In the first quarter of 2024 the Trustees opened discussion with St Nicolas CoE School concerning views on the proposed abolition of the recoupment scheme currently in place dating from funds provided for school buildings.

It is hoped that the Trust will be able to start work in furtherance of its charitable objectives in the year to 31 March 2025.

The provision of Bibles to St Nicolas School (established by tradition by the existing Trust) continued.
