Structure, Governance and Management

People's Enterprise and Empowerment Forum (The Association) Charity Registration Number 1060294 has been closed and all assets including Fixed and current assets comprising of bank balance and property have been transferred to People's Enterprise and Empowerment Forum Ltd, Charity Registration Number 1197953.

Trustees

Trustees are recruited when particular skills are needed. The trustee's meetings are held on a quarterly basis. The day to day running of the Charity is delegated to a Management Committee who meet on a monthly basis.

Risk Management

The Trustees have examined the major strategic, business and operational risks that the charity faces and confirm that systems have been established to enable regular reviews to be carried out so that necessary steps can be taken to lessen these risks.

Objectives and Activities

The main objectives of PEEF are:

1. To improve the economic conditions of the local community.
2. To advance educational attainment levels of the inhabitants of the district of Pendle.
3. To improve the skills of the local community
4. To improve the social, welfare and health conditions for the local inhabitants.
5. To improve the recreations, leisure and cultural facilities for inhabitants of Northwest England.

Services:

To further its objectives over the years, the organisation has developed its services to cater for the wide range of issues facing the local community, especially, the ethnic minority community.

The services provided include:

- Advice
- Employability
- Advocacy
- Health wellbeing advice
- Education
- Information
- Lobbying
- Outreach work
- Pilot projects
- Practical support
- Training

Brierfield Peoples Centre officially opened in March 2005 and after an extensive period of renovation designed to bring it up to contemporary standards, both in terms of amenities offered and also health and safety requirements. It has been set up to serve the needs of the communities in Pendle and Northwest of England.

Achievements and Performance

PEEF Ltd exists to empower and enable socially and economically excluded individuals to access personal development opportunities. The Brierfield Peoples Centre is a resource for the whole community and provides an ideal venue to facilitate these initiatives.

Currently PEEF is running various projects in and from the centre, all of which aim to improve the economic, educational, social and cultural conditions of pendle residents.

The centre has been designed with a great deal of consideration for people with disabilities. Much emphasis has been placed on providing full access to every room for wheelchair users with the aid of a lift to each floor.

The Centre provides a physical base for other organisations to operate from either on a permanent or sessional basis. Our policy has always been to provide equal access to all sections of the community. Therefore, our facilities are available for use by all categories of organisations, whether voluntary, statutory, charitable or commercial.

Affiliated organisations that have used the Centre include:

Pendle Brough Council, Department for Work and Pensions, Lancashire County Council, Pendle Women's Forum, Building Bridges Lancashire, BME Network, Calico Housing, Together Housing, Rosendale, Burnley and Pendle CVS, Local Mosques and Churches.

Reserves Policy

The trustees are mindful of the constraints of obtaining revenue grant funding at present and are looking into ways of generating its own income to enable its activities to continue.

The Charity's free reserves not invested in tangible fixed assets at 31st March 2025 amounted to £39,706. The trustees consider the charity needs £17,207 in reserves, the equivalent of six months running costs. The free reserve is currently in excess of this amount.

Responsibility of the Trustees

Law applicable to charities in England and Wales requires the Trustees to prepare financial statements for each financial year. Under the law the Trustees have elected to prepare the financial statements with United Kingdom generally accepted accounting standards and the applicable law.

The financial statements are required by law to give a true and fair view of the state of affairs of the charity and of the surplus or deficit of the charity for the period.

In preparing these financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently.
- Make judgements and estimates that are reasonable and prudent.
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its operation.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position for the charity and which enable them to ensure that the financial statements comply with the 'charities Act 2011. The Trustees are also responsible for the safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Notes To the Financial Statements for the Year Ended 31st March 2025

1. Accounting policies

The financial statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended practice 'Accounting and Reporting by Charities (SORP 2005), issued on March 2005. Applicable accounting standards and the Charities Act 2011.

Fund Accounting Policy

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose. Designated funds are unrestricted funds set aside at the discretion of the trustees for specific purposes. Further details of each fund are disclosed in note 13. No trading income was received during the year.

Incoming Resources

Voluntary income including donations and grants that provide core funding or are of a general nature is recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability.

Investment income is recognised on a receivable basis.

Resources expended.

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Cost of generating funds are the costs associated with attracting voluntary income.

Governance costs

Governance costs include costs of the preparation and examination of the statutory accounts, the costs of trustee meetings and the cost of any legal advice to trustees on governance or constitutional matters.

Fixed Assets

Individual fixed assets are initially recorded at cost.

Depreciation

Depreciation is provided on tangible fixed assets to write off the cost or valuation, less any estimated residual value, over their expected useful economic life as follows:
