MAKING EXPERTISE IN LANGUAGE TESTING AND ASSESSMENT READILY AVAILABLE FOR THE SOLUTION OF ASSESSMENT PROBLEMS6. DEVELOPING LINKS WITH OTHER GROUPS INTERESTED IN LANGUAGE TESTING AND ASSESSMENT7.
