During the year under review it also transferred its investment portfolio to The Brailsford Charity. These investments will continue to be held in an expendable endowment fund and the income from this fund will be included in unrestricted funds for spending on charitable purposes. The capital can be spent at the trustees' discretion.

The charitable trust aims to distribute all its income for charitable purposes each year.

It is the intention to apply all investment income received to charitable purposes. These investments and properties are held as an endowment fund which is available for distribution if the trustees see fit. The trustees aim to retain reserves in the region of £15,000 to cover unexpected expenditure. At 31 March 2024 the trust held free reserves of £24,763. The surplus will be paid out in subsequent periods.
