


Independent Examiner's Report to the Trustees of Woodham Walter Village Hall
Registered Charity No. 207930

I report on the accounts of the charity for the year ended 30th September 2022.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.
