**Recruitment & Appointment of Trustees**

**Organisational Structure**

Derby Vineyard is supported by a Board of Trustees who are responsible for policy decisions, and who regularly interact with the Senior Pastors throughout the year, to encourage best practice within the activities of the organisation.

**Decision Making**

The Senior Pastors are responsible for all matters related to the spiritual guidance and leadership of the church and the Trustees have specific responsibility for employment, policy making and major financial decisions and commitments. The charity employs both Senior Pastors on a part time basis (one for 2 days each per week and one for 3 days).

The Trustees and staff have conducted a review of the major risks to which the Charity is exposed. Where appropriate, systems or procedures have been established to mitigate the risks faced by the charity. Procedures are in place to ensure compliance with Health and Safety of staff, volunteers and visitors in accordance with all of the activities we are engaged in. These procedures are periodically reviewed to ensure that they continue to meet the needs of the charity.

#### **Objectives & Activities**

5. Development of the international partnerships - Keep regular contact with overseas project workers and take trips to assist in the development of projects and staff.

**Achievements & Performance**

1. The development of Small Groups and Sunday Services.

The church has continued to enjoy growth and momentum. The Sunday services have had a varied programme, with the opportunity for involvement of those in the congregation. The services included a regular 'Thanksgiving Service' on the first Sunday followed by sausage and chips provided by the Irish Centre, and special services at Easter and Christmas, which helped with continuity and momentum.

As the church increased in membership, the number of Small Groups has increased to accommodate new people.

The church continued to hold regular youth meetings and social outings for teenagers, with a new regular programme for the Youth on a Sunday morning at the Wilkins Centre.

The services and small group meetings have followed a range of themes to aid people in their spiritual, relational and emotional development.

2. The support and training of leaders.

To facilitate continuity, the small groups continued to meet without the usual termly change. The small groups leaders were supported with regular leadership meetings/check-ins during this time.

A number of the leaders attended the Vineyard National Leaders Conference held in Nottingham.

3. The expansion and development of the volunteer workforce.

The vast majority of the work of the church happens through the contribution of volunteers. We have a broad team of volunteers who serve on a rota basis, helping to conduct the meetings. The volunteer workforce is engaged in all areas of the charity objectives including community activities and special projects.

4. Continued positive engagement with the communities we serve.

Several members of the church serve as trustees of the William Wilkins Trust (Charity No. 1168218) and have taken responsibility for managing the Wilkins Centre. Volunteers who are part of the church have been involved in managing the affairs of the building, including managing the lettings of the building, decorating the building and arranging maintenance as required. In return, only minimal charges are made when groups from the church use the building.

The church provided a 'Warm Hub' during the winter months, a weekly event during the day on a Friday morning. The Wilkins Centre was opened from 10am to 2pm, and members of the church provided a simple meal, and company for those in need in the local community. These often included homeless and rough sleepers. We were able to work closely with other agencies, including the nearby Derby City Church Hope Centre, Community Action Derby and Derby City Council's Public Protection Officers.

The church hosted 'Outreaches' in the local shopping center. Using a vacant store, they were able to distribute chocolates, provide children's activities and offer friendship to local shoppers.

5. Development of the international partnerships.

The church has continued to support a family who train and support workers in the Middle East.

**Financial Review**

Income for the year amounted to £79,548 (2023: £8,308) and expenditure £73,603 (2023: £3,639). The profit of £5,945 was added to the funds brought forward of £4,669 resulting in a closing figure for February 25 of £10,614 .

**Principal Funding Source**

The principal income source for Derby Vineyard is through personal donations from its members. We do not currently receive any grants or bursaries from external bodies.

**Investment Policy**

Aside from retaining a prudent amount in reserves each year, all of the charity's funds are to be allocated towards fulfilling the objectives of the charity.

**Reserves Policy**

The Trustees have agreed to the reserves of £10,000, and save towards 3 months core running costs. This policy is subject to a review annually.

**Public Benefit**

The Trustees confirm that they have complied with the requirements of section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales.

**Trustees Responsibilities**

The Charities Act 2011 require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the trust and of the surplus of the trust for that period. In preparing those financial statements the Trustees are required to:

- Select suitable accounting policies and apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Prepare financial statements on the going concern basis unless it is inappropriate to presume that the trust will continue in existence.

The Trustees are responsible for keeping proper accounting records, which disclose with reasonable accuracy at any time the financial position of the trust. They are also responsible for safeguarding the assets of the trust and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 28TH FEBRUARY 2025

#### **Basis of preparation:**

These accounts have been prepared under the historical cost basis of accounting in accordance with the Charities Act 2011. The accounts have been prepared in accordance with: the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) 2nd edition issued on 1 January 2019.

Derby Vineyard meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost unless otherwise stated in the relevant accounting policy notes.

Preparation of the accounts is on a going concern basis. The Trustees are of the view that the level of reserves will support the charity going forward.

The charity has applied Update Bulletin 1 as published on 2 February 2016 and does not include a cash flow statement on the grounds that it is applying FRS 102 Section 1A.

#### **Changes to accounting estimates**

No changes to accounting estimates have occurred in the reporting period.

#### **Material prior period errors**

No material prior year error have been identified in the reporting period.

#### **1. ACCOUNTING POLICIES**

The particular accounting policies adopted are set out below.

#### **INCOME**

##### ***Recognition of Income***

These are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the income;
- it is more likely than not that the trustees will receive the resources; and
- the monetary value can be measured with sufficient reliability.

##### ***Offsetting***

There has been no offsetting of assets and liabilities, or income and expenses, unless required or permitted by the FRS 102 SORP or FRS 102.

##### ***Grants and Donations***

Grants and donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP).

##### ***Tax Reclaims on Donations and Gifts***

Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.

##### ***Contractual Income and Performance Related Grants***

This is only included in the SoFA once the charity has provided the related goods or services or met the performance related conditions.

##### ***Gifts in Kind***

Gifts in kind for use by the charity are included in the SoFA as income from donations when receivable.

##### ***Legacies***

Legacies are included in the SOFA when receipt is probable, that is, when there has been grant of probate, the executors have established that there are sufficient assets in the estate and any conditions attached to the legacy are either within the control of the charity or have been met.

### NOTES TO THE FINANCIAL STATEMENTS (continued) FOR THE YEAR ENDED 28TH FEBRUARY 2025

#### **Government Grants**

The charity has not received government grants in the reporting period.

#### **Donated goods**

Donated goods are measured at fair value (the amount for which the asset could be exchanged) unless impractical to do so.

The cost of any stock of goods donated for distribution to beneficiaries is deemed to be the fair value of those gifts at the time of their receipt and they are recognised on receipt. In the reporting period in which the stocks are distributed, they are recognised as an expense at the carrying amount of the stocks at distribution.

Donated goods for resale are measured at fair value on initial recognition, which is the expected proceeds from sale less the expected costs of sale, and recognised in 'Income from other trading activities' with the corresponding stock recognised in the balance sheet. On its sale the value of stock is charged against 'Income from other trading activities' and the proceeds from sale are also recognised as 'Income from other trading activities'.

Goods donated for on-going use by the charity are recognised as tangible fixed assets and included in the SoFA as incoming resources when receivable.

#### **Donated Services and Facilities**

Donated services and facilities are included in the SOFA when received at the value of the gift to the charity provided the value of the gift can be measured reliably.

Donated services and facilities that are consumed immediately are recognised as income with an equivalent amount recognised as an expense under the appropriate heading in the SOFA.

#### **Volunteer Help**

The value of any voluntary help received is not included in the accounts but is described in the Directors' annual report.

#### **Income from interest, royalties and dividends**

This is included in the accounts when receipt is probable and the amount receivable can be measured reliably.

#### **Investment Gains and Losses**

This included any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

#### **Insurance claims**

Insurance claims are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP) and are included as an item of other income in the SoFA.

#### **Income from membership subscriptions**

Membership subscriptions received in the nature of a gift are recognised in Donations and Legacies.

Membership subscriptions which gives a member the right to buy services or other benefits are recognised as income earned from the provision of goods and services as income from charitable activities.

#### **Expenditure and liabilities**

##### **Liability Recognition**

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

#### **Governance and Support Costs**

Support costs have been allocated between governance costs and other support. Governance costs comprise all costs involving public accountability of the charity and its compliance with regulation and good practice.

### NOTES TO THE FINANCIAL STATEMENTS (continued) FOR THE YEAR ENDED 28TH FEBRUARY 2025

#### **Grants with Performance Conditions**

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SOFA once the recipient of the grant has provided the specified service or output.

#### **Grants Payable without Performance Conditions**

Where there are no conditions attaching to the grant that enables the donor charity to realistically avoid the commitment, a liability for the full funding obligation must be recognised.

#### **Employee benefits**

Short term benefits including holiday pay are recognised as an expense in the period in which the service is received.

#### **Redundancy cost**

The charity made no redundancy payments during the reporting period.

#### **Deferred income**

No material item of deferred income has been included in the accounts.

#### **Creditors**

The charity has creditors which are measured at settlement amounts less any trade discounts.

#### **Debtors**

Debtors (including trade debtors and loans receivable) are measured on initial recognition at settlement amount after any trade discounts or amount advanced by the charity. Subsequently, they are measured at the cash or other consideration expected to be received.

#### **Stocks and work in progress**

Stocks held for sale as part of non-charitable trade are measured at the lower of cost or net realisable value.

#### **Cash at Bank and in hand**

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

#### **Provisions for liabilities**

A liability is measured on recognition at its historical cost and then subsequently measured at the best estimate of the amount required to settle the obligation at the reporting date.

#### **Taxation**

Derby Vineyard is not registered for Value Added Tax and therefore expenditure is shown inclusive of Value Added Tax.

#### **Funds**

Funds held consist of:

- Unrestricted General Funds which are used for general running of the charity
- Designated Funds which have been ring-fenced for a specific purpose by the Trustees
- Restricted Funds which must only be used for the purpose specified by the donor of those funds

#### **Financial instruments**

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

#### **Fixed Assets**

These are capitalised if they can be used for more than one year, and cost at least £500. They are valued at cost or, if gifted, at the value to the charity on receipt.
