The trustees have complied with their duty to public benefit in accordance with the guidance published by the Charity Commission.

The grant made to Neuroblastoma UK in the year of £6,000 (2024: £5,500) is an example of direct public benefit, which helps enable the research into drugs and also makes these drugs available to UK NHS patients.

The charity has provided public benefit by donating £4,352 (2024: £928) to local families with children that are suffering with Neuroblastoma to help improve their lives.

Summary of the main achievements of the charity during the year

The main achievements in the year for the charity was the running of the shop as the main income stream in order to generate funds, as well as raising awareness and support in the community. Overall this has helped the charity raise £39,243 (2024: £41,940).

During the year the charity has helped families with children suffering with neuroblastoma by providing them with much needed family day trips, toys and as well as funding with accessibility conversions.

In the year the charity held two main funding events which were the Gala Ball and the Charity Golf Event; generating income for the charity.

The financial statements show reserves of £12,694 (2024: £(5,744)) with net income of £18,438 (2024: net expenditure of £4,729). Reserves have increased during the year as the result of holding two successful fundraising events.

Positive reserves are as a direct result of other charity shops in the area closing down and the two successful fundraising events in the year.

The charity made donations of £10,352 (2024: £6,648) leaving net current assets of £1,397 (2024: net current liabilities £18,223) to carry forward to next year.

This year the charity has continued the collaboration with Neuroblastoma UK and the Bradley Lowery Foundation to fund a medical research programme into neuroblastoma at the University of Southampton. Dr Juliet Grey and her colleagues are looking at antibody immunotherapy for children with neuroblastoma, a form of treatment which relies on cells of the body's own immune system to kill cancer cells.






The trustees have complied with their duty to public benefit in accordance with the guidance published by the Charity Commission.

The grant made to Neuroblastoma UK in the year of £3,500 is an example of direct public benefit, which helps enable the research into drugs and also makes these drugs available to UK NHS patients.

The charity has provided public benefit by donating £6,009 to local families with children that are suffering with Neuroblastoma to help improve their lives.

Summary of the main achievements of the charity during the year

The main achievements in the year for the charity was the running of the shop as another income stream in order to generate funds, as well as raising awareness and support in the community. Overall this has helped the charity raise £52,021.

During the year the charity has helped families with children suffering with neuroblastoma by providing them with much needed family day trips, toys and as well as funding with accessibility conversions.

In the year the charity held two main funding events which were the Gala Ball and the Charity Boxing Evening; generating income for the charity.

The financial statements show reserves of (£1,015) with net income of £7,224.

During the year the charity received donations and gift aid of £30,946. The charity generated funds of £34,564 through organised fundraising activities and £52,091 through the shop. In the year the two main funding events were the Gala Ball and the Charity Boxing Evening. The charity incurred costs of £30,585 in generating funds and governance costs of £68,813. The charity made donations of £10,179 leaving net current (liabilities)/assets of (£16,957) to carry forward to next year.

This year the charity has continued the collaboration with Neuroblastoma UK and the Bradley Lowery Foundation to fund a medical research programme into neuroblastoma at the University of Southampton. Dr Juliet Grey and her colleagues are looking at antibody immunotherapy for children with neuroblastoma, a form of treatment which relies on cells of the body's own immune system to kill cancer cells.

The charity has now become incorporated and has taken over the assets and liabilities of the unincorporated charity (Niamh's Next Step charity number 1150081) as at 1st July 2022. Niamh's Next Step CIO continues the good work of the charity but within a corporate structure.
