Para 1.20	<p>Following years of general evangelistic and discipling work at our two centres of Chiolo and Mulanje, we have been responding to the demand for more formal Bible teaching arrangements in the eastern town of Mulanje. Initially we met this demand through a series of long-weekend teaching seminars. But the need for a Bible training institution with a formal curriculum and regular classes had become apparent.</p> <p>The main achievement of the year, therefore, has been developing consensus among Malawian and GWM UK trustees about the format of a new, fixed Bible teaching facility. The result was a commitment to start 'Mount Mulanje Bible Institute' in January 2025. Other ministries at our two centres will continue but with greater use of local leadership.</p>

The latter arose after a grant promised for September 2023 was not received until October 2023. This required GWM UK to take out an interest free loan to resolve a cash flow issue. This was repaid in full in October 2023. GWM UK carry no loans into 2024.

A3 Payments 'Loans repaid to trustee and external funder': this covers repayment of both of the (interest free) loans mentioned in respect of A1 above.
