All were sent via our partnership charity in Romania and were distributed to families in need.</p> <p>As well as purchasing pallets of flour, we received donated pallets of flour from a number of sponsors. All were sent to bread ovens established by our partner charity along the front line in towns and villages from Kherson to Kharkiv.</p> <p>We have been able to materially affect hundreds of lives through the goods that have been donated.</p> <p>The charity is investigating how we might support a mortuary investigating unexplained child mortality in Chernivtsi.</p> <p>We continue to work with like minded charities to facilitate the effective distribution of aid.</p>
