The Society informs and supports its members on issues affecting the Bedford Park street scene, the quality of the environment and the services provided to the community by the local authorities, police and other agencies.

The Executive Committee of the Society ensures that the Society meets the requirement of carrying out the charity's purposes for the public benefit through ensuring that its decisions reflect its charitable purposes and its understanding of the way in which these purposes benefit the public, both its members and the public in general.

5. Summary of the main achievements of the Society during the year 2024.

The Bedford Park Society (the Society) achieved significant milestones in 2024, focusing on celebrating its heritage, managing conservation efforts, and strengthening its organisational capacity:

- **150th Anniversary Preparations:** During 2024 the Society dedicated extensive time to planning, researching, producing an exhibition focussed on the communities in Bedford Park, and a special publication to celebrate the 150th anniversary of Bedford Park in 2025.
- **Securing Sponsorship and Grant Funding:** The Society successfully secured sponsorship for the exhibition and publication from Knight Frank, Savills, and Whitmans, and secured grant funding from the Hounslow Thriving Communities Fund.
- **Successful Planning and Conservation Outcomes:** The Society's core role of commenting on planning and listed building applications continued, with 72 applications considered. A notable achievement was the refusal of an application for two extensions to a house due to its "alien design and excessive scale," which was detrimental to the Conservation Area.
- **Strengthened Planning Committee Leadership:** The Society welcomed Barbara Boehm, an architect and long-standing resident, as the new Chair of the Planning Committee in January 2025, following her joining the team in 2024.
- **Membership Growth:** Membership numbers increased to 651 at the end of 2024, up from 640 the previous year, with 46 new residents in 30 households joining the Society.
- **Successful Volunteer Mobilisation:** A total of 12 people volunteered to research material for the 150th exhibition, many of whom were first-time volunteers, unearthing new and interesting material. Overall, 14 new volunteers became involved in 2024, mostly for the exhibition.
- **Successful Financial Management and Governance Modernisation:**

- The Society's finances remained strong, with total funds of £54,812 at the end of 2024.
- Routine income was healthy, with a 40% increase in events income and higher merchandise sales.
- The issue with the 2022 Gift Aid claim was resolved early in 2024, and the 2023 claim was made and paid during the year, getting the process back on track.
- The transition to a Charitable Incorporated Organisation (CIO) was guided to completion by the retiring Hon Sec, Nick Mesquita, modernising the Society's governance.

6. Summary of the main activities of the Society undertaken for the public benefit in relation to its objectives

The Society's main objective is to preserve and enhance the architectural heritage of Bedford Park. The activities undertaken in 2024 for public benefit in relation to this objective, and its broad portfolio of work for the community, include:

1. Preservation and Enhancement of Architectural Heritage (Core Objective)

- **Planning Consultation and Advice:** The Society considered 72 planning and listed building applications submitted to Local Authorities (up from 63 in 2023). It provided advice and guidance to householders at the early stages of design projects, which often resulted in better outcomes for the householder and Bedford Park's heritage.
- **Working to Address Conservation Issues:** The Society continued to work constructively with both local authorities to address issues like the trend for oversized/unsympathetic extensions, unsympathetic alterations to roofscapes, and the loss of period detail in listed houses.
- **Publishing and Information Dissemination:** The annual *Bedford Park Journal* was produced, celebrating the architecture, people, and history of the suburb. Information to help householders undertaking work on their houses was made available on the Society's website.

2. Community Engagement and Education

- **150th Anniversary Exhibition and Publication:** plans were made for the launch of the 150th-anniversary exhibition, focusing on the history of communities in Bedford Park, and the development of a special publication for distribution to all homes, to showcase and educate the public about the suburb's heritage.
- **Betjeman Annual Lecture:** The Society held its annual Betjeman lecture, which was delivered by textile authority Mary Schoeser, providing members with an educational tour of the history of the Sanderson family,

their Chiswick connections, and the technological developments in wallpaper and textile production illustrated with Arts and Crafts designs.

- **Regular Communications:** The Society maintained contact with members through regular e-news, including updates on relevant developments and contributed photographs.

3. Advocating on Local Amenities and Issues


- **Streetscape and Infrastructure Engagement:** The Infrastructure team actively engaged with residents and borough teams to highlight and seek solutions for streetscape issues, including the use of tarmac, the build-up of weeds, heavy leaf fall, management of street trees, and the selection of locations for bike hangers.
- **Heathrow Third Runway Monitoring:** The Society continued to monitor the threat of a third runway at Heathrow, working with the No 3rd Runway Coalition and CHATR, and planned to alert and guide members and local residents on consultations to submit their views on this major threat to Bedford Park and Chiswick.
- **Eco Guide Distribution:** Expenditure for the year included the production and distribution of an Eco guide for the community.




