The trustees follow the guidance provided by the charity commission in order to advance and achieve the objectives of the charity. HFI will also raise and promote issues to the statutory authority bodies and any other organisation necessary to help achieve the objectives.

This year the trustees concentrated on developing more policies to help support the work of the charity. These include the risk management and code of conduct. In addition, the trustees have also updated the trustees expenses policy in line with the latest advise from the charity commission.

Activities and Achievements

During the year HFI commenced on the planning work with key objectives highlighted below:

During the year, the charity received donations from the trustees and other donors. Consequently the charity was able to help vulnerable families with the provision of support for widows, disabled and sick beneficiaries. The charity also supported poor families with food and financial grants. The charity again increased its work in the provision of infrastructure projects to help local communities and in this regard four water wells were constructed in the needy areas. The charity also supported the construction of a mosque in Pakistan.

The above programmes were carried out directly and in partnership with local partners who fulfill the charity's due diligence checks.

Throughout the year the charity made steady progress in achieving the objectives highlighted above.

These donations were received in their entirety for the charitable projects the charity promotes through its website, hence help to achieve 'its objective of helping those in need.

The trustees have successfully applied to HMRC to be recognised as a charity, and this will help the charity to claim the gift aid which the trustees intend to use for primarily on charitable projects with some allocated to fund the administration of the charity.

Charity Assets

The assets of the charity consist of cash in hand and in the bank.

Risk Management

The current account funds are held with a leading bank to minimise disruption to activities and reduce risk. All investment decisions are made to achieve a reasonable return from acceptable sources whilst minimising the risk.






