Objectives and Activities

Our objectives are to raise funds to support the Charities aims by

1. Encouraging people to make regular donations by direct debit.
2. Running " Village " events . This year we have had a patronal lunch and a Harvest festival meal. Donations are received for the monthly after service breakfasts and we ran a Christmas raffle. We also ran a Fete in conjunction with the Poling Activities group..

Review of the year

1. The Trustees met four times in the year.
2. The fund raising events raised £2111 for the Friends .
3. Members donations amounted to £1439
4. The friends received a £2000 gift towards the grounds improvements donation.
5. Gift aid received was £682 and interest on investments was £626.
6. The Charity donated £4,234 to ST Nicholas church for ground and building improvements.

7. The "Norfolk" funds which the friends treat as a separate fund with slightly different objectives received £34,442 in investment interest in the year.
8. It granted St Nicholas church £4,000 for running costs to enable the P.C.C to show a small surplus.
9. It also granted a further £2531 towards the organ restoration fund.
