Market Harborough Story Centre (MHSC) was registered as a Charitable Incorporated Organisation (CIO) on 12th May 2022.

Objects:

For the public benefit, the relief of those in need by reason of physical or mental ill health, disability social disadvantage in Market Harborough and the surrounding area primarily by providing opportunities to participate in storytelling and story making activities.

The promotion for the public benefit of the art of storytelling by the provision of opportunities for public education and participation.

First Year

The vision is to eventually secure a building from which to operate a wide range of activities linked to story making and storytelling to deliver the Charity's objects for the public benefit.

Prior to obtaining a building we have run events in different locations designed to raise awareness of the benefits of story making and storytelling, enhance connection across the community, enjoy the pleasure of sharing stories and enlarge the group of volunteers committed to delivering the vision.

In addition to the trustees, we have another eight individuals involved in planning, developing and delivering a wide range of activities utilising different strengths to ensure eclectic offerings. The aim is to increase the number of trustees as the Charity evolves ensuring we have the right levels of expertise to ensure sound governance, creative input and quality provision.

Events included a fund raising event and awareness raising session where some who attended were keen to share their personal stories including those who had experienced trauma and who were using stories as a means of making sense of what happened to them.

We ran a workshop on the Art of Storytelling lead by one of the first professional storytellers in the UK. This allowed us to gain access to local media, bookshops and the library. The workshop was followed by an enjoyable performance where we were able to see a master storyteller in action. Further workshops are planned in the next year.

A local pub allowed us to use a room to run monthly storytelling sessions through the winter. One person who dropped in brought letters written by his great grandfather from the trenches in the First World War – an emotive experience for him and all in the group.

Just before Christmas we ran four days of storytelling at a local Christmas Barn reaching over 240 people mainly children and their caregivers.

There was then the opportunity to engage with a group of older people and people with disabilities to share stories allowing us to reach another 30+ people from different generations.

One significant development was engaging with a small group who were just starting to write stories, translate them into film scripts and then produce short films. The synergy was evident, and they have become the Film Division of MHSC. Their appeal to a different cohort of the population is of particular benefit as well as offering a different medium to translate stories into performances which can be shared widely.

We have committed to running a Story Tent at the town Carnival in June 2023 and expect to be able to reach many more people through this event. It has also been possible to begin to engage with other charities and community organisations within the town to develop partnerships which will allow us to effectively deliver the Charity's objects.

One of the priorities for the next year is to try and secure a regular venue and to further partnership working with other organisations in town to engage with more vulnerable children and families and older people with cognitive impairments.

Grants are being sought to allow us to commit to leasing regular premises to allow us to offer sustainable therapeutic groups and activities for children and families as well as regular storytelling events.

The number of people engaged with the charity has increased over the year and our aim is to continue to encourage people of all ages and abilities to become involved as story making and storytelling is integral to being human and to enhancing our understanding of each other.
