Donations

Total donations of £58,235.66 were received in the year, of which £6,000.30 were restricted. The main restricted donations were £2,300.00 towards the New Church Fund .

Children and Families

ROCEG has done really well with lots of exciting activities for children for the Sunday School.

We split the children in 3 groups based on their academic school year:

Group 1: from year 7 up

Group 2: year 2- 6

Group 3: year 1 and all ages below

Each of these groups are led by a few parents from our congregation who prepare in advance various stories and activities linked to the Bible and the teaching of the Orthodox Faith in order for the children to have a better understanding of the Gospel.

These parents offer their time voluntarily and any supporting materials are paid out either from the Parish account or are donated by various parents from their own resources.

All these parents who are involved with the children had their DBS Checks (taken in Dec 2025)

For every service, we undertake training for altar servers and we currently have 6 young boys age 8 to 10 who are actively involved in this task.

Baptism

During the year, we had 35 people (babies and adults) who were baptised in our Parish.

Also we had 3 weddings that happened during 2024.

House Blessings

In January 2025 we have been requested by 127 families to have their house blessed after the Epiphany Sunday as this is part of the Orthodox tradition, with 18 families less than 2024.

Outreach

Since 30Th September 2023, the Parish Priest commenced Liturgy services once a month - more specifically on the last Saturday of the month - in an Anglican church building in Gloucester. This is with the purpose of reaching the wider Orthodox community, particularly addressed to those whom, for various reasons, are unable to reach to our church services in Ledbury.

With the financial help from the Romanian community, our parish has managed to support a family back in January 2025 - we sent £1000 to support a single mother from our parish .

Total donations of £61,657 were received in the year, of which £6,050 were restricted. The main restricted donations were £4,185 towards the new Gloucester church (see Outreach below).

We split the children in 3 groups based on their academic school year:

Group 1: from year 7 up

Group 2: year 2- 6

Group 3: year 1 and all ages below

Each of these groups are led by a few parents from our congregation who prepare in advance various stories and activities linked to the Bible and the teaching of the Orthodox Faith in order for the children to have a better understanding of the Gospel.

These parents offer their time voluntarily and any supporting materials are paid out either from the Parish account or are donated by various parents from their own resources.

For every service, we undertake training for altar servers and we currently have 6 young boys age 8 to 10 who are actively involved in this task.

Baptism

During the year, we had 63 people (babies and adults) who were baptised in our Parish.

House Blessings

In January 2024 we have been requested by 145 families to have their house blessed after the Epiphany Sunday as this is part of the Orthodox tradition, with 40 families more than 2023.

Outreach

Since 30Th September 2023, the Parish Priest commenced Liturgy services once a month - more specifically on the last Saturday of the month - in an Anglican church building in Gloucester. This is with the purpose of reaching the wider Orthodox community, particularly addressed to those whom, for various reasons, are unable to reach to our church services in Ledbury.

With the financial help from the Romanian community, our parish has managed to support various people and organizations as follows:

July 2023 - we raised £1800 for some children in Republic of Moldova to help them with stationary at school.

December 2023 - we helped 4 families within our parish with food in the value of £1000

December 2023 - we sent £1000 to father Petru in Romania for some poor families.

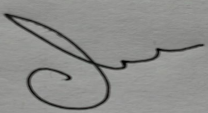

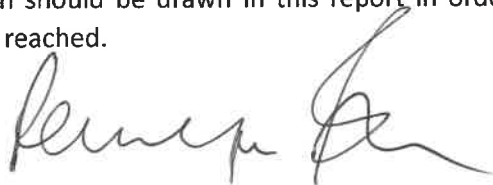

As at the moment we are renting the Church Hall from the local Church of England in Ledbury, Herefordshire and we are limited in terms of usage of the building.

We have split the children in 3 groups depending on their school year:

Group 1 : from year 6 up

Group 2 : year 2- 5

Group 2 : year 1 and all ages below.

Each of this group is led by a few parents from our congregation who prepare in advance various stories and activities linked to the Bible and

the teachings of the Orthodox Faith in order for the children have a better understanding of the Gospel.

These parents offer their time voluntarily and any supporting material is paid out of the Parish account.

Baptism

During 2022 we had 51 children who were baptised in our Parish.

House Blessing

In January 2023 we have been requested by 105 families to have their house blessed after the Epiphany Sunday as this is part of the Orthodox tradition.

Outreach

With the financial help from the Romanian community, our parish has managed to support various people and organizations as follows:

May 2022: £200 was sent to help Ukrainians refugees in Romania.

Sept 2022: £3400 to help 291 children from Romania to have the stationery and school bags they required in preparation to Starting School.

Sept 2022: £840 for a child called Daniel who suffers with Cancer (London).

25th Dec 2022: £450 for 5 families from our parish to help them with necessary food for Christmas.

Dec 2022: £3100 to buy Christmas Presents for children in a poor village from Iasi, Romania (Coarnele Caprei).

March 2023: £1830 for a family in Romania in need of Shelter.
