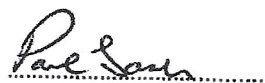

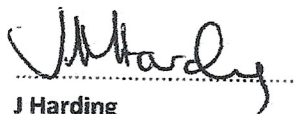

ANNUAL REPORT FOR 2024 - 2025

Bagley Baptist Church, Coldnose Lane, Bagley, BS28 2TG, is incorporated under a Charitable Deed of Trust. The Church registered as a charity (1199127) with the Charity Commission for England and Wales.

The Church Office Telephone Number is 01934 710779.

The Church, which is affiliated to the Baptist Union of Great Britain and Ireland and the West of England Baptist Association, aims to uphold the Declaration of Principle of the aforesaid Baptist Union, which is:

- That our Lord and Saviour Jesus Christ, God manifest in the flesh is the sole and absolute authority in all matters pertaining to faith and practice, as revealed in the Holy Scriptures, and that each Church has liberty, under the guidance of the Holy Spirit, to interpret and administer His Laws.
- That Christian Baptism is the immersion in water in the Name of the Father, the Son and the Holy Spirit, of those who have professed repentance towards God and faith in our Lord Jesus Christ who died for our sins according to the Scriptures; was buried and rose again on the third day.
- Every disciple has to bear personal witness to the Gospel of Jesus Christ and take part in the evangelisation of the world.

Objects

The Charity is governed by an Approved Governing Document which states that the principal purpose of the charity is the advancement of the Christian faith according to the principles of the Baptist denomination including the advancement of education, community service and other general charitable purposes in such parts of the United Kingdom and the world as the Church shall determine.

Our Vision:

To spread the good news of the gospel of our Lord Jesus Christ. We live to serve Jesus, and for Him to be at the centre of all that we are and do. We desire to be a light on a hill, growing together and serving our local communities, founded on the Word and led by the Spirit, for the glory of the Father.

Aims

Jesus is Lord: We aim for Jesus to be at the heart of who we are and all that we do as a church. We believe that Jesus is revealed through both the Word and the Spirit. Our preaching and teaching is founded on the scriptures. We seek to give space for the Holy Spirit to operate freely in our activities

1. **Discipleship:** We aim for each person who belongs to Bagley to be an apprentice of Jesus - To know Jesus, to become more like Him and to do the things He did.
 - a. We encourage everyone to pursue their discipleship through activities that Jesus modelled to the first disciples such as prayer, knowing the scriptures, fasting, building community, generosity, hospitality, serving, solitude, sabbath and witness
 - b. We provide opportunities to grow through worship, teaching, collective prayer, studying the scriptures, being part of a community of believers, eating together, serving and witness

2. **Church Community:** We aim to build a purposeful, family community where everyone feels valued and is enabled to grow and use their gifts for the benefit of the whole body.

a. We are a gathered group of people gathering together at Bagley to be equipped and encouraged to serve our local communities:

b. We seek to build community through regular opportunities to spend time and eat together such as church lunches, summer BBQs, men and women's events, annual weekend aways and camps

c. We encourage everyone to be connected to a small group

d. We encourage everyone to use their gifts and talents

3. **Mission:** We aim to equip each other to be effective ambassadors and witnesses for God in the communities we are called to live and work in.

a. We encourage everyone to be salt and light in their local community

b. We aim for our services to be a welcoming and safe place for new comers

c. We offer 'open access' activities including Wednesday Coffee, Hub Youth Club, Alpha courses etc.

d. We actively support key mission activities including Iris Ministries Glastonbury, Aid to Albania, CAP, Christian Institute, Kids Club Kampala, Compassion, TEN and Partnership in Mission (local Baptist mission projects)

e. At least 10% of our church income will go to local, national and world mission

f. We will support individuals participating in mission opportunities

Main Focus of Activities

We have been encouraged to see an on going growth in those calling Bagley their home church. Our Membership has grown from 63 last year to 71 this year. We are delighted to have people of all generations in our church family.

As a rural church that gathers people from surrounding villages and towns, mid-week small groups are a priority for us and we are pleased to see that these groups are well supported over all. This year we have followed more systematic teaching on a Sunday morning with many small groups discussing this teaching in their weekly meetings.

Our youth worker has continued to develop the link with our local middle school and is involved in mentoring as well as assemblies. The regular church youth group enjoyed a residential weekend at a local Christian centre and also attended a national Christian youth festival.

Our main building has been open for 18 years and so this year we have had to invest in renewing or updating some of our equipment and facilities. We are also in the process of repurposing our old church building into a youth space.
