The Trustees submit their report for the year ended 30 April 2025.

**STRUCTURE, GOVERNANCE AND MANAGEMENT**

West Street Evangelical Church, a registered charity in England and Wales, is regulated by a set of rules approved in June 2022 registration with the Charity Commission. Responsibility for the management of the activities of West Street is vested in the 4 Trustees and who are elected by the members at the Annual General Meeting held each year.

The charity has 02 employees. One of the trustees has received remuneration from the Charity. The Trustees are asked to maintain regular training on Trustee duties and compliance with charities legislation.

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting & Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), and The Charities Act 2011.

The Officers and Committee are responsible for the management of the risks faced by the West Street Evangelical Church. The major risks have been identified, assessed and controls established. It is recognised that systems can only provide reasonable but not absolute assurance that major risks have been adequately managed.

The trustees confirm that the major risks to which the charity is exposed has been reviewed, and systems and procedures have been established to identify and respond to such risks.

Laws and regulations: Compliance with the financial reporting standard in the UK and Republic of Ireland (FRS102) and the Charities Act 2011.

I report on the accounts of West street evangelical church for the year ended 30 April 2025, which are set out on pages 6 to 10.

**Respective responsibilities of trustees and examiner**

**1. ACCOUNTING POLICIES**

*General Information*

West Street Evangelical Church is a charity registered in England & Wales. The address is West street Evangelical Church, West Street, Carshalton, SM5 2NR

*Basis of Accounting*

The financial statements have been prepared in accordance with Accounting & Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom & Republic of Ireland (FRS102) and The Charities Act 2011 and UK General Accepted Accounting Practice, effective from 1 January 2015.

*Income Resources*

Incoming resources are recognised when received, or when the charity becomes legally entitled to income and can be measured with sufficient reliability.

*Direct Charitable Expenditure*

All expenditure is accounted for on a cash basis.

*Taxation*

West Street Evangelical Church is a registered charity and is exempt from taxation to the extent that any income and gains are applied to its charitable purposes.

*Value Added Tax*

Value Added Tax is not recoverable by the Charity, and as such, is included in the relevant costs in the Statement of Financial Activities.
