



Advancement of Islamic religion for the benefit of the public in Dartford and the surrounding areas, In particular but not exclusively through the establishment of a mosque or masjid, the holding of prayer meetings, and the production and /or distribution of literature on the Islamic religion to enlighten others about the Islamic religion.
- b). To relieve persons who are in conditions of need or hardship or who are aged and sick and to relieve the distress caused thereby in the said location and in such other parts of the United Kingdom or the world as the trustees may from time to time think fit.
