For the year ended 31 December 2022

Sutton Coldfield Baptist Church (a Charitable Incorporated Organisation, registration 1199202) was incorporated on 7 June 2022.

The Trustees of the charity report that no activity took place during 2022. The Trustees of Sutton Coldfield Baptist Church (unincorporated trust, registration 1131309) have been taking steps to incorporate the charity. It is expected that the assets and liabilities of the unincorporated charity (registered number 1131309) will be transferred to the incorporated charity (registered number 1199202) during 2023.

During 2022 registered charity number 1199202 received no income (other than a £1 transaction to establish a new bank account) and undertook no activities or expenditure.

Achievements and Performance

The CIO was newly registered and was not expected to undertake any activity until the assets and liabilities from charity number 1131309 are transferred to charity number 1199202.

Financial Review


A single transaction took place to establish a new bank account for the charity.

The Trustees expect the assets and liabilities of the unincorporated charity (registered number 1131309) to be transferred to the Charitable Incorporated Organisation (registered number 1199202) during 2023.


