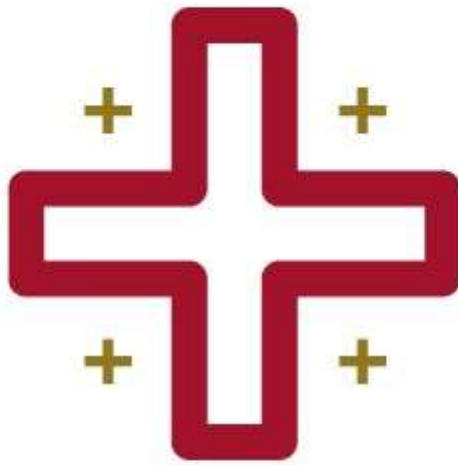

**Objects of the Charity**

To advance the orthodox Anglican expression of the Christian faith, for public benefit, in accordance with the Anglican Network in Europe (ANiE) Statement of Belief and Practice, including but not limited to teaching, prayer and fellowship, by: Facilitating the ministry of the Presiding Bishop of the Anglican Network in Europe; Facilitating relationships between, and the ministry of, the constituent bodies of the Anglican Network in Europe; Facilitating relationships with other ecclesial bodies.

**Governance**

The policy and operating decisions of the charity rest with the Trustees who meet regularly to monitor the activities of the charity on behalf of its Synod.

Every Trustee should be chosen from the members of the Synods of the Dioceses. In selecting individuals for appointment as Charity Trustees, the ANiE Synod members must have regard to the skills, knowledge and experience needed for the effective administration of the charity. All Charity Trustees must subscribe and adhere to, in belief and lifestyle, the ANiE Statement of Belief and Practice.

At the charity's AGM on 28 January 2025, Mrs Pauline Skinner stood down as she was the only elected trustee from the previous AGM. She was duly elected again to another term.

Venerable Prince Charles Ezeanochie and Mr Ogemdi Okafor were appointed 15 October 2024.

Mrs Amaka Ani, Reverend Canon Francis Olaniyi and Mr Keith Robertson were appointed 25 February 2025.

**Review of Activities**

Throughout the period, the main activities undertaken by ANiE were:

- The ministry of the Presiding Bishop of the Network, which included several visits to churches in the network and potential members, as well as meetings with fellow Bishops and Archbishops from within the UK and from the Anglican Communion worldwide, and attendance at various conferences and other ecclesial events;
- The running of a monthly prayer meeting on Zoom for all members of the Network, including the recording of several interviews with orthodox Anglicans from around the world;
- The hosting of a missionary delegation from the Church of Uganda in April 2024;
- The participation of an ANiE delegation at the GSFA Assembly in Egypt (June 2024);
- Participation at the Anglican Church in North America (ACNA) Assembly and Investiture (June and November 2024 respectively);
- Gafcon Primates Councils in the USA (June and November 2024, and March 2025);

- The inauguration of a new ANiE diocese, Anglican Missionary Congregations (AMC), and the consecration and enthronement of their new Bishop (October 2024);
- The participation in The Alliance meetings in Berkshire alongside Gafcon Primates (October 2024)
- Preaching at Christ Church Cathedral, Plano, and at a clergy and spouses retreat hosted by the Anglican Diocese of the Living Word in Georgia, USA (October 2024);
- Participation in the consecration of the new Bishop of Chile (January 2025); and
- Participation in the G25 conference in Plano, USA (March 2025).

In planning the activities the Trustees have applied the guidance on public benefit issued by the Charity Commission.

### **Achievements**

A particular highlight in the period was the inauguration of a third and new diocese, Anglican Missionary Congregations, and the consecration and enthronement of their new Bishop in October 2024.

Throughout the period, the Presiding Bishop has visited several churches and been in conversation with a number of parties interested in joining the Network. We have witnessed growth in the number of churches in each of the three diocese, as well as increased recognition of the ANiE's ministry internationally.

### **Financial Review**

During the year income was £91,891. Expenditure was £92,116.

The income mostly came from contributions from the dioceses which make up ANiE (£65,654), though there were significant contributions also from regular donors, from both individuals and supportive churches (£14,736).

The most significant item of expenditure, £65,054, is represented by the employment costs for the two people employed by ANiE. Throughout the period, there were two employees – the Presiding Bishop and an Administrator. The remaining expenditure was for the Presiding Bishop's expenses, other ordinary operating costs, and expenditure related to strategic meetings at home and abroad.

ANiE ran a small deficit this year (£225) which was covered by the reserves. ANiE continues to be in a healthy financial situation. The Trustees' give thanks to God for the generous contributions from dioceses, churches, individuals and other organisations which have enabled this.

The Trustees aim to hold unrestricted cash of no less than £20,000, which equates to approximately 3 months' expenditure.

## **Trustees' Responsibilities**

Charity law requires Trustees to prepare financial statements for each accounting year which at least record the receipts and payments of the charity for the year. We have opted to prepare our accounts on an accruals basis.

We are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable us to ensure that the financial statements comply with the Charities Act 2011.

We also have a responsibility to safeguard the assets of the charity and to take reasonable steps to prevent fraud or any other irregularities.

## **Note 1 Accounting Policies**

### **Basis of financial statements**

The financial statements have been prepared in accordance with the current Statement of Recommended Practice, Accounting and Reporting by Charities and applicable accounting standard FRS 102 and with the Charities Act 2011.

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

### **Fund accounting**

Unrestricted funds are income funds that are to be spent on the Charity's general purposes. There were no Restricted funds (donations or grants for a specific Charity activity intended by the donor) or Designated funds (General funds set aside by the Trustees for a particular purpose) in 2024-25.

### **Incoming resources & Debtors**

Planned giving, collections and similar donations are recognised when received. Tax refunds are recognised when the incoming resource to which they relate is received, with a debtor being recorded for the amount expected. Grants and legacies are accounted for when the Charity is entitled to the use of the resources, their ultimate receipt is considered reasonably certain and the amounts due are readily quantifiable. Interest is accounted for as and when accrued by the payer. All incoming resources are accounted for gross. Debtors are recorded as the amount expected to be received.

### **Resources expended & Liabilities**

All expenditure is recognised when it is incurred and is accounted for gross. Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

### **Fixed Assets**

Tangible fixed assets for use by charity are capitalised if they can be used for more than one year, and cost at least £1,000. They are valued at cost and are depreciated on a straight-line basis over each asset's estimated useful life. Individual items with a purchase price of less than £1,000 are written off when the asset is acquired. The Charity currently holds no fixed assets, nor did it at any stage during the period.

- The participation in GAFCON Primates' Council meetings in Uxbridge (November 2023) and Rwanda (March 2024).

### **Achievements**

A particular highlight in the period was the participation of ANiE in the GAFCON conference in Kigali in April 2023. The ANiE gathered over 30 participants from our dioceses, a number of which played significant roles in committees and were presenters of various sessions at the conference.

The ANiE applied for, and was granted, membership of the Evangelical Alliance and the Global South Fellowship of Anglicans, both notable Christian networks.

Throughout the period, the Presiding Bishop has visited several churches and been in conversation with a number of parties interested in joining the Network. Individuals and churches have joined both dioceses.

### **Financial Review**

During the year income was £93,046. Expenditure was £76,963.

The income mostly came from contributions from the dioceses which make up ANiE (£63,970), though there were significant contributions also from regular donors, from both individuals and supportive churches (£29,076).

The most significant item of expenditure, £62,495, is represented by the employment costs for the two people employed by ANiE. Throughout the period, there were two employees – the Presiding Bishop and an Administrator. The remaining expenditure was for the Presiding Bishop's expenses, other ordinary operating costs, and expenditure related to strategic meetings at home and abroad.

ANiE has quickly established itself in a healthy financial situation. The Trustees' give thanks to God for the generous contributions from dioceses, churches, individuals and other organisations which have enabled this.

The Trustees aim to hold unrestricted cash of no less than £20,000, which equates to approximately 3 months' expenditure.

## **Note 1 – Accounting Policies**

### **Basis of financial statements**

The financial statements have been prepared in accordance with the current Statement of Recommended Practice, Accounting and Reporting by Charities and applicable accounting standard FRS 102 and with the Charities Act 2011.

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

### **Fund accounting**

Unrestricted funds are income funds that are to be spent on the Charity's general purposes. There were no Restricted funds (donations or grants for a specific Charity activity intended by the donor) or Designated funds (General funds set aside by the Trustees for a particular purpose) in 2023-24.

### **Incoming resources & Debtors**

Planned giving, collections and similar donations are recognised when received. Tax refunds are recognised when the incoming resource to which they relate is received, with a debtor being recorded for the amount expected. Grants and legacies are accounted for when the Charity is entitled to the use of the resources, their ultimate receipt is considered reasonably certain and the amounts due are readily quantifiable. Interest is accounted for as and when accrued by the payer. All incoming resources are accounted for gross. Debtors are recorded as the amount expected to be received.

### **Resources expended & Liabilities**

All expenditure is recognised when it is incurred and is accounted for gross. Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

### **Fixed Assets**

Tangible fixed assets for use by charity are capitalised if they can be used for more than one year, and cost at least £1,000. They are valued at cost and are depreciated on a straight-line basis over each asset's estimated useful life. Individual items with a purchase price of less than £1,000 are written off when the asset is acquired. The Charity currently holds no fixed assets, nor did it at any stage during the period.

**Objects of the Charity**

To advance the orthodox Anglican expression of the Christian faith, for the public benefit, in accordance with the Anglican Network in Europe (ANiE) Statement of Belief and Practice, including but not limited to teaching, prayer and fellowship, by: Facilitating the ministry of the Presiding Bishop of the Anglican Network in Europe; Facilitating relationships between, and the ministry of, the constituent bodies of the Anglican Network in Europe; Facilitating relationships with other ecclesial bodies.

**Governance**

The policy and operating decisions of the charity rest with the Trustees who meet regularly to monitor the activities of the charity on behalf of its Synod.

Every Trustee should be chosen from the members of the Synods of the Dioceses. In selecting individuals for appointment as Charity Trustees, the ANiE Synod members must have regard to the skills, knowledge and experience needed for the effective administration of the charity. All Charity Trustees must subscribe and adhere to, in belief and lifestyle, the ANiE Statement of Belief and Practice.

**Review of Activities**

Throughout the period, the main activities undertaken by ANiE were:

- The ministry of the Presiding Bishop of the Network, which included several visits to churches in the network and potential members, as well as meetings with fellow Bishops and Archbishops from within the UK and from the Anglican Communion worldwide, and attendance at various conferences and other ecclesial events.
- The organisation and running of some significant services, in particular consecrations of new Assistant Bishops within the Network;
- The running of a monthly prayer meeting on Zoom for all members of the Network, including the recording of several interviews with orthodox Anglicans from around the world;
- The organisation and preparation for participation in the GAFCON conference in Kigali in April 2023.

In planning the activities the Trustees have applied the guidance on public benefit issued by the Charity Commission.

**Achievements**

In 2022 Anglican Network in Europe registered as a Charity. Previously, a Limited Company had been registered with Companies House, but it was apparent that a CIO structure would better reflect the nature of ANiE and its activities. As a condition of registering as a CIO, the old Limited Company has been struck off the register, with all its assets and activities having transferred over to the new CIO.

Consequently, in its first period ANiE CIO received all the remaining funds from the Limited Company, registered as an employer and started to employ the Presiding Bishop and an Administrator, registered for Gift Aid, and took on all the operations of the old Limited Company.

A particular highlight of special significance in the period were two services organised by ANiE for the consecration of Assistant Bishops in its constituent dioceses. A number of Bishops and Archbishops from around the world attended and participated in these services, which were streamed online to an audience across the UK as well as in other countries. ANiE has also done a lot of work in preparing for the GAFCON conference in Kigali in April 2023. Throughout the period, the Presiding Bishop has visited several churches and been in conversation with a number of parties interested in joining the Network. Individuals and churches have joined both dioceses.

### **Financial Review**

During the year income was £62,846. Expenditure was £33,081. 2022-23 was Anglican Network in Europe CIO's first year. A significant amount of income, £25,858, was gifted from the Limited Company, which is no longer listed on the register of companies at Companies House following a voluntary application to have it struck off. The remaining income mostly came from the dioceses which comprise ANiE.

The most significant item of expenditure, £23,685, is represented by the employment costs for the two people employed by ANiE. At the start of the period there were no employees and at the end there were two – the Presiding Bishop and an Administrator. The remaining expenditure was for the Presiding Bishop's expenses and other ordinary operating costs.

ANiE has quickly established itself in a healthy financial situation. The Trustees' give thanks to God for the generous contributions from dioceses, churches, individuals and other organisations which have enabled this.

The Trustees aim to hold unrestricted cash of no less than £20,000, which equates to approximately 3 months' expenditure.

### **Trustees' Responsibilities**

Charity law requires Trustees to prepare financial statements for each accounting year which at least record the receipts and payments of the charity for the year. We have opted to prepare our accounts on an accruals basis.

We are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable us to ensure that the financial statements comply with the Charities Act 2011.

We also have a responsibility to safeguard the assets of the charity and to take reasonable steps to prevent fraud or any other irregularities.
