Report of the board of trustees for the year ended 31st of January 2025.

Introduction

The Liberty Family Church United Kingdom is an unincorporated organisation registered with the charity Commission (1199401) constituted under the declaration of Trust Deed dated 2nd of June 2022. It is an affiliation of Foursquare Church Great Britain with the head office now in Luton, Bedfordshire.

The aim of the charity is to propagate the gospel of Jesus Christ in Nuneaton and the surrounding areas. The Liberty Family Church UK as a local church under Foursquare Church Great Britain is accountable to the national leader at the head office. The church is governed at the local level by the Board of Trustees that is responsible for policies, strategies, activities and for setting out the administrative structure for running the Charity.

Current activities and programmes

The church expanded slightly during January 2024 to January 2025. Spiritually, we continued to worship at the Bermuda Phoenix Centre, focussing on discipleship through discussions of topical Christian's topics for different age groups, worship through singing and dancing, and then preaching. Fortnightly, we meet online for a Friday prayer meeting. Socially, men and women meet separately once a month in different settings, such as cafeterias, to chat and pray to encourage non-church members to participate in social activities (tea and chat). The church promotes physical and mental well-being through Walk and Pray. A walking activity every other Saturday. We have outreaches to the homeless home. The church. All these activities are open to the community. Outreaches, evangelism, and missions are other focused areas for achieving our objectives.

Achievements and Challenges

The board of trustees and the church council continue to meet physically (sometimes online) on a regular base to plan and organise the programmes and activities of the church and make decisions on important issues.

Family enrichment programmes launched in 2024 are a story of success. We now have a more robust children's Sunday schools that have more teaching aids that enhance all attending children and youths learning. In addition, the media team had grown and working towards reaching the wider communities.

The only challenges we are facing is the continuous use of the community hall which do not facilitate a longer time for socialisation after the church service due to time limit.

The board of trustees and the church council continue to meet physically (sometimes online) on a regular base to plan and organise the programmes and activities of the church and make decisions on important issues.

Family enrichment programmes launched in 2024 are a story of success. We now have a more robust children's Sunday schools that have more teaching aids that enhance all attending children and youths learning.

Future Projections

Our main aim is to continue to work towards the achievement of our objective of propagating the gospel, providing material and spiritual support to the needy and have our own place of worship

Our plan is to continue with the online method to carry out activities and programmes that support our objectives and combine that with onsite gatherings.

We will also continue to work collaboratively with other churches in the community in Nuneaton and Coventry.

Financial review:

During the year under review, The Liberty Family Church received income of £30,383. £900 of these donations were for the building fund and £5074 from gift aid. The charity's overall expenditure was £14,787.

Our plan is to continue with the online method to carry out activities and programmes that support our objectives and combine that with onsite gatherings.

We will also continue to work collaboratively with other churches in the community in Nuneaton and Coventry.

Financial review:

During the year under review, The Liberty Family Church received income of £16,590. This was mainly because of increased membership and increased donation from members. The charity's overall expenditure was £8,309.

Statement of Trustees' responsibilities

The Trustees are responsible for preparing the report and the financial statements in accordance with the requirements of the Charity Commission in England and Wales. 1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the statement of recommended practice: Accounting and Reporting by charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Charities Act 2011

Incoming resources

Resources expended

Depreciation is provided on all tangible fixed assets, other than freehold land, at rates calculated to write off the cost, less estimated residual value, of each asset evenly over its expected useful life, as follows:
