The Charity has donated fruit trees to over twenty five primary schools, given away over five hundred whip trees through community events, and most notably partnered with Camden Council to plant trees in council estates.

**TRUSTEE'S ANNUAL REPORT (incorporating Director's Report)
FOR THE YEAR ENDED 31 DECEMBER 2024**

The trustees present their report and financial statements of the charity for the year ended 31 December 2024. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS102) in preparing the annual financial statements of the charity.

The financial statements have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the charity governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published in October 2019 (second edition).

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is constituted as a company limited by guarantee and became a registered charity on 6 July 2022 (charity registration number: 1199564). The objects and powers of the Charity are set out in its governing document which is its Articles of Association.

Sophia Pasetti (CEO), who was not a trustee, was responsible for the day-to-day operation of KOKO Foundation until her resignation on 14/07/2025. From 14/07/2025 Rachel Kennedy is responsible for the day-to-day operations as Interim Head.

The Charity is run by a board of Trustees, with co-opted members. The Trustees are also the only company members of the Charity. The Trustees are currently carrying out a skills audit in the context of further Trustee recruitment and working with the Charity's legal advisors to ensure good governance and put in place relevant policies. The Trustees plan to host an induction training session with its legal advisors.

Whilst KOKO Foundation is an independent organisation constituted as a company limited by guarantee with Charitable status directed by a board of trustees, it has a close working relationship with The Hope Lease Limited (trading as KOKO).

RISK MANAGEMENT

The Foundation trustees regularly review the financial risks to the organisation and have put in place procedures to mitigate such risks. They are looking at also putting in more robust procedures to manage non-financial risks.

GOVERNANCE & INTERNAL CONTROL

The charity's system of internal controls is designed to provide reasonable but not absolute assurance against material misstatement or loss. The Trustees are satisfied that the systems in place reduce their exposure to major issues.

OBJECTIVES AND ACTIVITIES

The objects of the Charity are:

- To advance the education of the public, but not exclusively the education of young people, with reference to the performing arts, particularly but not exclusively through the provision of workshops, artistic training, performance, public discussion, and other educational programmes.
- To promote sustainable development for the benefit of the public by the conservation, protection and improvement of the physical and natural environment and the prudent use of resources.
- To promote social inclusion for the public benefit by preventing people from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society, but not exclusively by working with socially excluded people in and around the area of Camden in London. For this article 'socially excluded' means being excluded from society, or part of society, as a result of being a member of a socially and/or economically deprived community including (but not limited to) those that are excluded from society as a result of youth and/or unemployment.
- To advance the arts and culture for the benefit of the general public through promotion, production and encouragement of all art forms, including but without limitation, music, dance and film, with particular but not exclusive reference to live performances.
- For the public benefit to further such purposes as are exclusively charitable according to the laws of England and Wales from time to time.

In deciding what activities to pursue the Trustees of the Charity have had regard to guidance issued by the Charity Commission on public benefit.

ACHIEVEMENTS AND PERFORMANCE

KOKO Foundation is a registered charity in England and Wales (1199564), launched in 2022 to empower young people, strengthen communities, and champion environmental sustainability. With music, community, and the environment at its core, the KOKO Foundation delivers initiatives that unlock creative potential, improve wellbeing, and create greener urban spaces.

Communi-Trees

KOKO Foundation has taken its first steps towards cultivating a greener urban landscape through pioneering environmental initiatives. These have been delivered in partnership with Think & Do Camden and Camden Council, rewilding our borough for the benefit of the community ecosystem. This began in 2023 - a notable example being the rewilding of Kentish Town Fire Station - and has continued into 2024, with the expansion of 'Communi-Trees' and the launch of Beeline Boxes.

The most significant environmental initiative to date is Communi-Trees, a project co-designed and delivered with Think & Do in response to Camden Council's 2019 climate emergency declaration. This is a tree planting initiative that not only alleviates the impact of climate change, but contributes to positive health and wellbeing outcomes too. Greening urban environments have also been shown to have positive social impact, reducing antisocial behaviour and bringing communities together to share in the collective joy of cultivating a greener environment. To date, 255 trees have been planted, including 109 on estates and the remainder in local schools. Wherever possible, edible fruit trees are planted, creating a patchwork orchard across the borough - the first and largest of its kind. A new partnership with UCL enables detailed soil testing to identify safe and suitable sites for planting, though soil health challenges in the borough are limiting opportunities for food growing.

Planting days, talks and outreach programmes are integral to the delivery of Communi-Trees, encouraging residents to play an active role in shaping their environment. It's a popular initiative in the borough with enthusiasm from further local estates for planting, while recognition from the Mayor of London's Urban Forest Partnership in 2024 has helped establish Communi-Trees as a model for urban greening.

At our Communi-Trees sites, the KOKO Foundation and Think & Do recruit 'KOKO Foresters', a vibrant network of young people who are trained and employed to nurture our projects. This creates a real opportunity for the young people living on the estates, as we provide the tools and training they need to become custodians of their environment and introduce new career pathways. From planting and watering, to pruning and fruit harvesting, it's the KOKO Foresters who keep these spaces alive, season after season. To date, 13 KOKO Foresters have been recruited. For some, their role sparks a new and rewarding relationship with nature, positively impacting their wellbeing while simultaneously helping the environment. For others, it provides purpose, new skills and a pathway into green careers. Many forge new connections - with other Foresters through our annual KOKO Foresters party - and the neighbours and friends they meet through their work.

Chrissy joined us in 2023 as one of our first KOKO Foresters and has gone on to become a green mentor with Global Generation and a neighbourhood curator working on Regent's Park Estate Story Trail. She says *'Being a KOKO Forester has opened so many doors. Just like the mycelium connecting the trees, Communi-Trees has connected me to other community-based projects and I'm forever grateful.'*

Beeline Boxes

The KOKO Foundation's second major initiative, Beeline Boxes, was introduced in 2024 to cultivate biodiversity in places where access to green space is limited. In partnership with Think & Do and Camden Council, our galvanised metal boxes are designed and manufactured in collaboration with a local supplier and Hafiz Onitolo, a student and designer at Central Saint Martins, UAL. They are securely fastened to railings and balconies, and filled with evergreen herbs selected by residents. 90 boxes filled with pollinator-friendly herbs were installed at our pilot site. An initiative that goes beyond biodiversity and contributing to climate-resilient urban landscapes, community is at the heart of Beeline Boxes, as residents come together to connect with nature and one another. The far-reaching effects encompass everything from positively impacting health and wellbeing, to reducing antisocial behaviour, creating a safer and happier environment for all.

Beyond these core initiatives, the KOKO Foundation has distributed more than 2,000 tree whips and 'jammy hedge' fruit bushes to 26 local schools and community groups, prioritising areas most affected by pollution. Together, these efforts are building a more resilient, biodiverse, and connected urban environment.

KOKO Foundation Songwriting Academy

Alongside its environmental work, the KOKO Foundation continues to invest in young people's creativity, a response to the vital need for embodied, creative experiences that bring young people together to learn, grow, and discover the joy of creative arts.

After a successful pilot in 2023, two further Songwriting Academies took place in 2024, delivered in partnership with Skarbek Academy, founded by Ivor Novello award winner, Sacha Skarbek. The four-day workshop brings together participants aged 18-25 for a series of songwriting sessions, mentoring, masterclasses and more, led by industry experts. It culminates in a live showcase at The House of KOKO, attended by key figures from the music industry to facilitate further networking opportunities.

Music Bursaries

With an understanding of the transformative impact learning music can have on a child's health, wellbeing and development, we are working in partnership with Camden Music to make tuition accessible to more young people in the borough - beginning with students on free school meals who may not otherwise have access to music tuition.

In 2024 the KOKO Foundation initiated KOKO Bursaries – which currently fund 11 students. Six of these are emergency funds for students who would not be able to continue otherwise. These bursaries fund weekly one-to-one music lessons for a full academic year (30 sessions), group classes and instrument hire if required, for children aged 8-16.

Spatial Value x KOKO Award

In visual arts, the Spatial Value x KOKO Award continues to support emerging talent while enriching the education of local students. Creative knowledge exchange and collaborative community building through art education are at its heart, as we embolden the artists of the future. Like all our initiatives, this is designed to be scalable with the potential to replicate in schools throughout the borough.

The project is two-fold: propelling two outstanding young graduates (who are awarded a cash prize) from the Royal College of Art into their career and giving them the experience of working with a local state school to develop an art programme with A-level art students. These students benefit from working with young art practitioners and gain valuable, innovative skills, as well as developing their creative thinking. The collaboration is steered by an experienced curator and culminates in a showcase of the creative outcomes in the school, community, and at The House of KOKO.

Following a successful pilot in 2023, the KOKO Foundation has awarded two further RCA alumna with the Spatial Value x KOKO Award in Autumn 2024.

Benedict Cumberbatch

The KOKO Foundation's work gained further visibility in 2024 with the appointment of BAFTA, Olivier and EMMY award-winning actor, Benedict Cumberbatch as a global ambassador, joining Olivia Colman in championing our mission. With a particular focus on environmental projects, his involvement will help amplify awareness of the KOKO Foundation's impact and we hope, inspire cities globally to act. Benedict shared the following statement:

"I am honoured to be a KOKO Foundation Ambassador with a special focus on the environment. It's been so inspiring to witness first-hand, the amazing impact that the Foundation has quietly had over the past few years, making real and lasting change in Camden. I'm excited, inspired and committed to help bring awareness to the special work being done and continue to help improve the local area and scale the foundation's work around the country, and the world."

A Night at The Theatre, with Letters Live

2024 also saw the KOKO Foundation's first major public fundraising event, A Night at the Theatre, with Letters Live. The occasion celebrated Benedict Cumberbatch's appointment as a global ambassador and brought a star-studded line-up to KOKO's stage, to bring letters to life through powerful performances. Cumberbatch was joined on stage by a line-up curated by Letters Live and the KOKO Foundation, including Marisa Abela, Riz Ahmed, Cate Blanchett, Minnie Driver, Idris Elba, Richard Gadd, Ghetts, Damian Lewis, FKA Twigs, Taika Waititi, and our Voice of God Sophie Hunter. Readings were interspersed with music performances from Celeste, The Caveman, and an unforgettable medley from three-time Grammy Award winner Wyclef Jean closed the show.

A meaningful and special partnership with Letters Live, this was the KOKO Foundation's first significant fundraising event, accompanied by a silent auction of artworks and experiences, kindly donated by friends of the foundation. The event raised vital funds, attracted widespread media coverage including Variety, Rolling Stone and NME, and introduced the KOKO Foundation's mission to a much wider audience.

After the year-end a matter was reported to the Charity Commission who confirmed no regulatory action was required. The associated costs of the settlement of this matter will be recognised in the accounts for the year ending 31 December 2025.

GOING CONCERN

At the time of approving the financial statements, the Trustees have reviewed the going concern of the charity and consider that the charity has adequate resources to continue in operational existence for the foreseeable future.

PLANS FOR THE FUTURE

Beeline Boxes

Beeline Boxes have been an opportunity to inspire, educate and encourage the community to become custodians of their environment, the initiative has been well received by the local community, with plans to expand to two further estates in 2025.

KOKO Foundation Songwriting Academy

The KOKO Foundation plans to expand on the success of the Songwriting Academy with further courses, with a view to reach and benefit over 50 emerging musicians by the end of 2025.

Music Bursaries

We are developing a proposal with Camden Music Services for group music classes in primary schools and will look to extend our existing bursaries in 2025 for recipients who wish to continue learning.

Spatial Value x KOKO Award

This programme will run in a Camden school in the 2025 spring term, for 8-12 A-level art students aged 16-18.

FINANCIAL REVIEW

During the year to 31 December 2024 KOKO Foundation received £641,148 (2023: £191,097) in income. This included donations in kind totalling £nil from Hope Lease Ltd (2023: £1,823) for expenses incurred by the charity for charitable expenditure, marketing & PR services.

At 31 December 2024 the charity had an unrestricted reserves balance of £120,431 (2023: negative £6,422); and a restricted reserves balance of £550 (2022: £4,000).

RESERVES POLICY

The trustees consider that no reserves policy is required at present as its overheads are covered by a guaranteed annual sum from Hope Lease Ltd.

1 Accounting policies

Charity information

KOKO Foundation is a charitable company limited by guarantee, incorporated in England and Wales. The registered office is 3rd Floor 7 Greenland Street, London, England, NW1 0ND.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charitable company's memorandum and articles of association, the Companies Act 2006, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS102), Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland issued in October 2019, UK Generally Accepted Accounting Practice and applicable charity and company law. The charitable company is a Public Benefit Entity as defined by FRS102. The charitable company has taken advantage of the provisions in the SORP for charities applying FRS102 Update Bulletin 2 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the charitable company. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the Trustees have reviewed the going concern of the charity and consider that the charity has adequate resources to continue in operational existence for the foreseeable future.

1.3 Charitable funds

Unrestricted funds are available for use at discretion of the Trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

Transfers are made between funds when adequate justification and supporting evidence is provided.

1.4 Incoming resources

Grants are accounted for on an accruals basis and allocated between funds according to the basis of the grant being provided. Grant income is recognised when the charity is entitled to it after performance conditions have been met, the amounts can be measured reliably and it is probable that the income will be received. Where the charitable company is required to repay any part of the grant a provision is made for the amount due to be repaid.

Donations and legacies receivable are accounted for where there is entitlement, sufficient certainty of receipt and the amount can be measured reliably. In the case of unsolicited donations this is usually only when received. All other income is accounted for under the accruals concept. No amounts are included in the financial statements for services donated by volunteers. Donated capital items are included within the financial statements at their current value at the time of donation. Trading income is receivable on a profit share basis. Income received for future periods is deferred until those periods.

1.5 Resources expended

All expenses are accounted for on an accruals basis. Expenditure incurred in connection with the specific objects of the charitable company is included under the heading of direct charitable expenditure, overheads are allocated to activities in proportion to their use of facilities. The irrecoverable element of VAT is included with the item of expense to which it relates.

1.6 Creditors and provisions

Creditors and provisions are recognised where the charitable company has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement value.

1.7 Debtors

Debtors are recognised at the settlement amount due.

2 Critical accounting estimates and judgements

In the application of the charitable company's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

**TRUSTEE'S ANNUAL REPORT (incorporating Director's Report)
FOR THE YEAR ENDED 31 DECEMBER 2023**

The trustees present their report and financial statements of the charity for the year ended 31 December 2023. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS102) in preparing the annual financial statements of the charity.

The financial statements have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the charity governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published in October 2019 (second edition).

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is constituted as a company limited by guarantee and became a registered charity on 6 July 2022 (charity registration number: 1199564). The objects and powers of the Charity are set out in its governing document which is its Articles of Association.

Sophia Pasetti, who is not a trustee, is responsible for the day-to-day operation of KOKO Foundation.

The Charity is run by a board of Trustees, with co-opted members. The Trustees are also the only company members of the Charity. The Trustees are currently carrying out a skills audit in the context of further Trustee recruitment and working with the Charity's legal advisors to ensure good governance and put in place relevant policies. The Trustees plan to host an induction training session with its legal advisors.

Whilst KOKO Foundation is an independent organisation constituted as a company limited by guarantee with Charitable status directed by a board of trustees, it has a close working relationship with The Hope Lease Limited (trading as KOKO).

OBJECTIVES AND ACTIVITIES

The objects of the Charity are:

- To advance the education of the public, but not exclusively the education of young people, with reference to the performing arts, particularly but not exclusively through the provision of workshops, artistic training, performance, public discussion, and other educational programmes.
- To promote sustainable development for the benefit of the public by the conservation, protection and improvement of the physical and natural environment and the prudent use of resources.
- To promote social inclusion for the public benefit by preventing people from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society, but not exclusively by working with socially excluded people in and around the area of Camden in London. For this article 'socially excluded' means being excluded from society, or part of society, as a result of being a member of a socially and/or economically deprived community including (but not limited to) those that are excluded from society as a result of youth and/or unemployment.
- To advance the arts and culture for the benefit of the general public through promotion, production and encouragement of all art forms, including but without limitation, music, dance and film, with particular but not exclusive reference to live performances.
- For the public benefit to further such purposes as are exclusively charitable according to the laws of England and Wales from time to time.

In deciding what activities to pursue the Trustees of the Charity have had regard to guidance issued by the Charity Commission on public benefit.

ACHIEVEMENTS, PERFORMANCE AND PLANS FOR THE FUTURE

The KOKO Foundation is a registered charity - 1199564. Its mission statement is to empower youth, enrich communities, and nurture a green world. With community, music and environment at its heart, the KOKO Foundation has become a force for positive change; unlocking creative potential in disadvantaged young people, and nurturing the talents of the next wave of essential new artists. And while the KOKO Foundation's initiatives aim to enrich the community around its home in Camden through an array of creative partnerships and initiatives with local enterprises, its longer-term ambition is to ensure that those ideas can be replicated across London and beyond.

The KOKO Foundation has quietly taken its first steps towards achieving its goals by focusing upon local environmental initiatives. The most notable of these has been a partnership with Think & Do Camden and Camden Council, which has deployed a selection of activations to help rewild Camden for the benefit of the community ecosystem, one notable example being the Kentish Town fire station. In just two years, we've now contributed to an estimated 40% of new trees in London, and are receiving growing recognition.

The most significant environment initiative to date is the Communi-trees project, which has established over 170 mature trees on 10 council estates throughout the borough, including two edible fruit orchards – the first of their kind on Camden estates. The initiative is incredibly popular locally, and further sites have been identified for planting in Q4 2024.

For each site, we also employ young local residents, the 'KOKO Foresters' to maintain the trees. This encourages future generations to become custodians of their environment and connect with nature, creating a positive circular economy, rather than relying on external council contractors. We now have 16 KOKO Foresters employed across our sites, who come together at KOKO for special pizza nights to further build community. The KOKO Foundation funds everything from community events and consultations with local residents to soil testing, professional tree planting, trees, equipment for their ongoing care and maintenance, and the training and employment of 'KOKO Foresters' for one year.

The programme has been such a success that the KOKO Foundation has partnered with The Ashden Climate Trust to pursue plans to expand into 20 more boroughs, and we've also gained recognition from the Mayor of London, with Communi-trees being highlighted as a case study in the Urban Forest Partnership, 2024.

The foundation has also given away 2,000 tree whips across 26 community events and has proudly rewilded 26 local schools with fruit trees and jammy hedges, with an initial focus on schools that are situated on major roads and polluted areas, to foster cleaner environments and increase biodiversity.

Building on our successful partnership with Think & Do and Camden Council, in July 2024 we launched a pioneering new project; Beeline Boxes. Working in partnership with a student of socially responsive design at Central St Martins University, we have co-designed and manufactured galvanised metal boxes which are filled with edible evergreen herbs and installed on public walkways on estates. For our first estate 90 Beeline Boxes have been installed, filled with 360 plants. Designed to increase biodiversity in an urban area of Camden and encourage the community to engage with nature, the boxes also have an incredible social impact, transforming a neglected building into somewhere colourful and full of life.

KOKO Arts Academy

After a successful pilot in November 2023, of 12 students aged between 18-30, the foundation has launched KOKO Arts Academy, forging creative opportunities for young people and nurturing the next generation of talent. The KOKO Arts Academy invites aspiring young people to learn, grow, and discover the joy of the creative arts, through workshops and programmes.

Following the pilot, a second Academy focused on music took place in May 2024 in partnership with Ivor Novello award winning songwriter and producer, Sacha Skarbek. A three-day workshop for 12 students aged 18-25 year olds focused on songwriting, mentoring and industry expertise, the course culminated in live performances by the students in Ellen's, KOKO, accompanied by session musicians. The third academy in collaboration with Sacha Skarbek is scheduled for November 2024, with plans to expand into other creative industries in 2025.

Benedict Cumberbatch

In summer 2024 BAFTA, Olivier and EMMY award-winning actor, Benedict Cumberbatch joined the KOKO Foundation as a global ambassador alongside Olivia Colman, with a special focus on the environment – a matter close to his heart. As an ambassador, Cumberbatch will amplify our efforts to ensure a greener and more sustainable city, while drawing a focus to environmental projects that can transform communities and inspire other cities globally. On joining, Benedict has said:

"I am honoured to be a KOKO Foundation Ambassador with a special focus on the environment. It's been so inspiring to witness first-hand, the amazing impact that the Foundation has quietly had over the past few years, making real and lasting change in Camden. I'm excited, inspired and committed to help bring awareness to the special work being done and continue to help improve the local area and scale the foundation's work around the country, and the world."

Letters Live

To celebrate our new relationship with Benedict Cumberbatch we are holding a very special fundraising edition of Letters Live at KOKO, in support of the KOKO Foundation. This will be the charity's first significant fundraising event and will welcome remarkable musical and acting talent to the stage, including Benedict Cumberbatch, Cate Blanchett, Riz Ahmed, Idris Elba, FKA Twigs – and many more. Over a decade, Letters Live has built up a reputation as a truly iconic event, so it's incredibly special to be hosting it at KOKO – which has already caught media attention, featuring in Variety, NME, Rolling Stone, and more.

Tickets are available to the general public, alongside a carefully curated audience of VIP guests, HNWs and media, who are likely to give generously to the foundation, and become important advocates of our work – amplifying our message among their own communities. Taking place in November 2024, we expect it to be a significant event in raising both money for the charity and awareness of our work. A silent auction will encourage further donations on the night.

Good Vibes Day with Femi Koleoso

Recognising the transformative power of just one day, Good Vibes Day empowers young people through music. Free to attend, KOKO's theatre set the scene for a day of drum tuition, networking, industry advice and a jam session for kids and music students, led by Femi Koleoso, best known as drummer of the Grammy award winning Gorillaz, and drummer and frontman of Mercury prize winning jazz group, Ezra Collective. The KOKO Foundation funded the first KOKO edition in December 2023, for 15-20 year olds, with priority given to disadvantaged young people. Almost 100 participants joined in a collective, community building jam, with one-to-one drumming lessons with Femi for approximately ten students. Following its success, we plan to hold a second this December 2024.

Music Bursaries

We're determined to make music accessible for all young people in Camden – and beyond. We understand the transformative impact learning music can have on a child's health, wellbeing and development, and are working in partnership with Camden Council and Camden Music Services to implement music bursaries, beginning with students on free school meals who wouldn't otherwise have access to music tuition.

In 2024 we're funding 11 music bursaries – six of which are emergency funds for students that would not be able to continue otherwise. These bursaries fund weekly one-to-one music lessons for a full school year (30 sessions) and instrument hire if required, for children aged 8-16. We are also developing a proposal with Camden Music Services for group music classes in primary schools.

Spatial Value x KOKO Award

Like all KOKO Foundation initiatives, this is a dynamic project aimed to be scalable, with the potential to replicate it in schools throughout the borough. Creative knowledge exchange and collaborative community building through art education are at its heart, as we embolden the artists of the future.

The project is two-fold: propelling two outstanding young graduates (who are also awarded a cash prize) from the Royal College of Art into their career and giving them the experience of working with a local state school to develop an art programme with A-level art students. These students benefit from working with young art practitioners and gain valuable, innovative skills, as well as developing their creative thinking. The collaboration is steered by experienced curator, and culminates in a showcase of the creative outcomes in the school, community, and at The House of KOKO.

Following a successful pilot in 2023, we have awarded two further RCA alumna with the Spatial Value x KOKO Award in Autumn 2024. The programme will run in a Camden school in the spring term, for 8-12 A-level art students aged 16-18.

FINANCIAL REVIEW

During the year to 31 December 2023 KOKO Foundation received £191,097 in income. This included donations in kind totalling £1,823 from Hope Lease Ltd (2022: £63,286 for expenses incurred by the charity for charitable expenditure, marketing & PR services).

At 31 December 2023 the charity had a negative unrestricted reserves balance of £6,422 (31/12/2022: negative £4,873); and a restricted reserves balance of £4,000 (2022: £nil). Donations from Hope Leasing Ltd are due to KOKO Foundation in 2024 which will bolster unrestricted reserves.

RESERVES POLICY

1 Accounting policies

Charity information

KOKO Foundation is a charitable company limited by guarantee, incorporated in England and Wales. The registered office is 3rd Floor 7 Greenland Street, London, England, NW1 0ND.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charitable company's memorandum and articles of association, the Companies Act 2006, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS102), Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland issued in October 2019, UK Generally Accepted Accounting Practice and applicable charity and company law. The charitable company is a Public Benefit Entity as defined by FRS102. The charitable company has taken advantage of the provisions in the SORP for charities applying FRS102 Update Bulletin 2 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the charitable company. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the Trustees have reviewed the going concern of the charity and consider that the charity has adequate resources to continue in operational existence for the foreseeable future.

1.3 Charitable funds

Unrestricted funds are available for use at discretion of the Trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

Transfers are made between funds when adequate justification and supporting evidence is provided.

1.4 Incoming resources

Grants are accounted for on an accruals basis and allocated between funds according to the basis of the grant being provided. Grant income is recognised when the charity is entitled to it after performance conditions have been met, the amounts can be measured reliably and it is probable that the income will be received. Where the charitable company is required to repay any part of the grant a provision is made for the amount due to be repaid.

Donations and legacies receivable are accounted for where there is entitlement, sufficient certainty of receipt and the amount can be measured reliably. In the case of unsolicited donations this is usually only when received. All other income is accounted for under the accruals concept. No amounts are included in the financial statements for services donated by volunteers. Donated capital items are included within the financial statements at their current value at the time of donation. Trading income is receivable on a profit share basis. Income received for future periods is deferred until those periods.

1.5 Resources expended

All expenses are accounted for on an accruals basis. Expenditure incurred in connection with the specific objects of the charitable company is included under the heading of direct charitable expenditure, overheads are allocated to activities in proportion to their use of facilities. The irrecoverable element of VAT is included with the item of expense to which it relates.

1.6 Creditors and provisions

Creditors and provisions are recognised where the charitable company has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement value.

1.7 Debtors

Debtors are recognised at the settlement amount due.

2 Critical accounting estimates and judgements

In the application of the charitable company's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

FOR THE PERIOD ENDED 31 DECEMBER 2022**

The trustees present their report and financial statements of the charity for the period ended 31 December 2022. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS102) in preparing the annual financial statements of the charity.

The financial statements have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the charity governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published in October 2019 (second edition).

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is constituted as a company limited by guarantee and became a registered charity on 6 July 2022 (charity registration number: 1199564). The objects and powers of the Charity are set out in its governing document which is its Articles of Association. Sophia Pasetti, who is not a trustee, is responsible for the day to day operation of KOKO Foundation.

The Charity is run by a board of Trustees, with co-opted members. The Trustees are also the only company members of the Charity. The Trustees are currently carrying out a skills audit in the context of further Trustee recruitment and working with the Charity's legal advisors to ensure good governance and put in place relevant policies. The Trustees plan to host an induction training session with its legal advisors.

Whilst KOKO Foundation is an independent organisation constituted as a company limited by guarantee with Charitable status directed by a board of trustees, it has a close working relationship with The Hope Lease Limited (trading as KOKO).

OBJECTIVES AND ACTIVITIES

The objects of the Charity are:

- To advance the education of the public, but not exclusively the education of young people, with reference to the performing arts, particularly but not exclusively through the provision of workshops, artistic training, performance, public discussion, and other educational programmes.
- To promote sustainable development for the benefit of the public by the conservation, protection and improvement of the physical and natural environment and the prudent use of resources.
- To promote social inclusion for the public benefit by preventing people from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society, but not exclusively by working with socially excluded people in and around the area of Camden in London. For this article 'socially excluded' means being excluded from society, or part of society, as a result of being a member of a socially and/or economically deprived community including (but not limited to) those that are excluded from society as a result of youth and/or unemployment.
- To advance the arts and culture for the benefit of the general public through promotion, production and encouragement of all art forms, including but without limitation, music, dance and film, with particular but not exclusive reference to live performances.

In deciding what activities to pursue the Trustees of the Charity have had regard to guidance issued by the Charity Commission on public benefit.

ACHIEVEMENTS AND PERFORMANCE

The KOKO Foundation is a registered charity - 1199564. Its mission statement is to empower youth, enrich communities, and nurture a green world. Throughout that process, the KOKO Foundation will become a force for positive change throughout the local area, by helping to unlock the potential of its disadvantaged young people, and to nurture the talents of the next wave of essential new artists. And while KOKO Foundation's initiatives aim to enrich the community around its home in Camden through an array of creative partnerships and initiatives with local enterprises, its longer-term ambition is to ensure that those ideas can be replicated across London and beyond.

The KOKO Foundation has quietly taken its first steps towards achieving its goals by focusing upon local environmental initiatives. The most notable of these has been a partnership with Think & Do Camden and Camden Council, which has deployed a selection of activations to help rewild Camden for the benefit of the community ecosystem, one notable example being the Kentish Town fire station.

The KOKO Foundation's most significant environment initiative to date is the Communi-trees project, which has resulted in 188 mature trees being planted on 10 council estates throughout the borough. Having just planted Camdens first fruit orchard across two local council estates. The project also encourages young people to invest their time into their community by learning about the environment and by paying a small team of KOKO foresters on each estate to care for the trees, rather than using outside council contractors, in the process creating a healthy and positive circular local economy. The KOKO Foundation also funds all of the equipment which is used to maintain the trees on each estate. The programme has been such a success that the KOKO Foundation has partnered with The Ashden Climate Trust with plans to expand into 20 more boroughs. The foundation has also given away 1500 tree whips across 26 community events as has proudly rewilded 26 local schools with fruit trees and jammy hedges focusing on schools who are sited on major roads with pollution to make their environments cleaner and increase biodiversity.

KOKO foundation will launch its new project, Beeline Boxes in partnership with Think&Do and Camden Council this June. Its aim is to increase biodiversity in urban areas in Camden estates and expand encouraging young people to engage with nature. For the pilot, alongside a student of socially responsive design from Central St Martins university, we will be co-designing & manufacturing 90 galvanised metal Beeline Boxes which will be filled with evergreen herbs and installed public on walkways in the ThreeFields estate, Camden.

The foundation has added an estimated 40% to the total public tree planting in the borough of Camden (if replacement trees are not included). Not bad for a little new foundation!

Plans for the future

After a successful pilot, of 12 students aged between 18-30, the foundation will launch the KOKO ARTS ACADEMY in 2024, with its first full academy focusing on Music, launching in May 2024 in partnership with Ivor Novello winning songwriter and producer Sacha Skarbek and his songwriting academy, it will be a 3 day work shop of song writing, mentoring and music industry experts doing Q&A's about the business side of the industry. The academy will end with a performance in Ellens in KOKO, showcasing the music and songs the students have created across the workshop with a live band.

FINANCIAL REVIEW

The accounts for the period to 31 May 2022 have been restated to remove accrued income from donations of £7,400 in accordance with Charities SORP, section 5, which states donations should be recognised on receipt and they were not received by the Charity until June 2023.

During the period to 31 December 2022 KOKO Foundation received donations in kind totalling £63,286 from Hope Lease Ltd. This was for expenses incurred by the charity in the main for grants & funding, marketing & PR services.

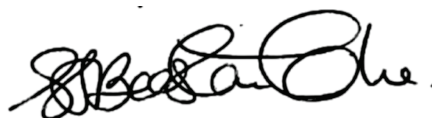
Independent Examiner's Statement

1 Accounting policies

Charity information

KOKO Foundation is a charitable company limited by guarantee, incorporated in England and Wales. The registered office is 3rd Floor 7 Greenland Street, London, England, NW1 0ND.

1.1 Accounting convention

The financial statements have been prepared in accordance with the charitable company's memorandum and articles of association, the Companies Act 2006, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS102), Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland issued in October 2019, UK Generally Accepted Accounting Practice and applicable charity and company law. The charitable company is a Public Benefit Entity as defined by FRS102. The charitable company has taken advantage of the provisions in the SORP for charities applying FRS102 Update Bulletin 2 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the charitable company. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the Trustees have reviewed the going concern of the charity and consider that the charity has adequate resources to continue in operational existence for the foreseeable future.

1.3 Charitable funds

Unrestricted funds are available for use at discretion of the Trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

Transfers are made between funds when adequate justification and supporting evidence is provided.

1.4 Incoming resources

Grants are accounted for on an accruals basis and allocated between funds according to the basis of the grant being provided. Grant income is recognised when the charity is entitled to it after performance conditions have been met, the amounts can be measured reliably and it is probable that the income will be received. Where the charitable company is required to repay any part of the grant a provision is made for the amount due to be repaid.

Donations and legacies receivable are accounted for where there is entitlement, sufficient certainty of receipt and the amount can be measured reliably. In the case of unsolicited donations this is usually only when received. All other income is accounted for under the accruals concept. No amounts are included in the financial statements for services donated by volunteers. Donated capital items are included within the financial statements at their current value at the time of donation. Trading income is receivable on a profit share basis. Income received for future periods is deferred until those periods.

1.5 Resources expended

All expenses are accounted for on an accruals basis. Expenditure incurred in connection with the specific objects of the charitable company is included under the heading of direct charitable expenditure, overheads are allocated to activities in proportion to their use of facilities. The irrecoverable element of VAT is included with the item of expense to which it relates.

1 Accounting policies (continued)

1.6 Creditors and provisions

Creditors and provisions are recognised where the charitable company has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement value.

1.7 Debtors

Debtors are recognised at the settlement amount due.

2 Critical accounting estimates and judgements

In the application of the charitable company's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
