This initiative has allowed these</b></li> </ul>

Three of these families are thriving, and the cows are proving to be a valuable asset to their livelihoods. Unfortunately, one family continues to face challenges due to illness and extreme weather conditions that destroyed their greenhouse. However, they remain resilient with ongoing support.</li> <li>• <b>Support for Emergency Flood Efforts:</b> We donated £2,500 to support flood relief efforts in Bosnia, providing critical assistance to those affected by the floods.</li> <li>• <b>Qurbani Food Distribution:</b> We distributed food in the form of Qurbani, ensuring that those in need had access to vital nutrition during a key time of the year.</li> </ul> <p>Through these initiatives, the charity has made a significant difference in the lives of its beneficiaries, alleviating both immediate hardship and fostering long-term sustainability.
