Structure, Governance and Management

Governing Document:

Two Rivers Community Pantry is a Charitable Incorporated Organisation, registered with the Charity Commission on 18th August 2022 and governed by its Constitution (CIO Foundation model).

All of the Trustees are members of the Charity. If the CIO is wound up, the members of the CIO have no liability to contribute to its assets and no personal responsibility for settling its debts and liabilities.

Recruitment and appointment of Trustees

The Trustees form the 'Executive Committee' of the charity. Every Trustee is appointed for a term of three years by a resolution passed at a properly convened meeting of the charity Trustees. In selecting individuals for appointment as charity Trustees, the current charity Trustees must have regard to the skills, knowledge and experience needed for the effective administration of the charity.

The Constitution states that there must be at least 3 charity Trustees and the maximum number of charity Trustees is 12.

Any person retiring as a charity trustee is eligible for reappointment.

A charity Trustee who has served for three consecutive terms may not be reappointed for a fourth consecutive term but may be reappointed after an interval of at least one year.

Trustee Induction and Training:

New Trustees undergo induction training. The induction includes a discussion about the role and responsibilities of Trustees, the activities, aims and objectives of the charity, the structure of the organisation, board of Trustees, general procedures of the organisation. New Trustees are introduced to members of staff and other Trustees, and are provided with the Charity Commissions 'Roles and Responsibilities of Trustees', the Constitution, the latest statutory financial statements, Annual Report, and financial reports provided to the board of Trustees. Any additional training required by the new Trustees will be identified during induction, and may be requested at any point by new and existing Trustees, where it is considered useful to their role as Trustee.

Organisational Structure:

The board of Trustees have overall responsibility for the Charity. Trustees are aware that any conflict of interest is declared and minuted. The board holds a meeting quarterly.

The Charity has a foundation model constitution. The only voting members of the Charity are the Charity Trustees.

If the CIO is wound up, the members of the CIO have no liability to contribute to its assets and no personal responsibility for settling its debts and liabilities.

Risk Management:

The major risks, to which the charity is exposed, as identified by the Trustees, have been reviewed and systems have been established to mitigate those risks. All systems and procedures are reviewed regularly to ensure they meet charity law and our own organisations aims and objectives.

Objectives and Activities

Two Rivers Community Pantry objects are:

"The prevention or relief of poverty in Goole and the surrounding villages, by providing grants, items, and services to individuals in need and/or charities, or other organisations working to prevent or relieve poverty, in particular but not exclusively by the provision of a foodbank and community supermarket specifically for those who are in poverty to provide food which they could not otherwise afford through a lack of means."

Main objectives for the following year:

In shaping our objectives for the following year and planning our activities, the Trustees have considered the Charity Commission's guidance on public benefit.

The main objectives for 2023/24 are:

- To continue evolving membership of the pantry to the local community
- To continue developing relationships with various agencies to support the needs of the local community
- To expand the list of suppliers who can provide food and produce either free or significantly discounted
- To evolve projects that support the local community to overcome barriers and relieve poverty.

Achievements and Performance

Review of Activities 2022/23

During the financial period we moved from operating as a project of East Riding Voluntary Action Services (ERVAS) Limited (now known as Community VISION (Voluntary Infrastructure Support Involving Organisations and Networks) CIO) to an independent CIO. This has been a learning curve for the Trustees, with developing our own governance, policies and processes. An interim payment from general unrestricted funds held by East Riding Voluntary Action Services (ERVAS) Ltd in relation to Two Rivers Community Pantry from pantry sales and provision of services has been made during the year. A further payment will be made in the next accounting period. In addition, ERVAS received and holds some restricted funds in relation to the work of Two Rivers Community Pantry for which it holds contractual obligations which it is legally responsible for complying with. ERVAS continues to work with Two Rivers Community Pantry to ensure these funds are spent in line with the requirements of the fund.

This financial period has been one of continued development in addressing food poverty in Goole and the surrounding areas.

We have continued our reach across our community, providing food and assistance to residents in the area as well as working in partnership with other local charities.

During the year our operation continued to be impacted by the cost of living crisis. The demand for emergency food remained high as well as subsidised produce from the pantry but we were able to cope thanks to the commitment of our staff and volunteers and the generous support of the community.

Our ambition is to enhance our operation and to go further to alleviate and combat the causes of poverty.

Review of Activities 2022/23 (continued)

A major step was taken towards this year when we completed the refurbishment of the former stockroom into a warm space to support the community.

The cost of living crisis has continued to impact our community and we have seen considerable increase in those not normally requiring support, especially the escalation of the working poor. Towards the end of this financial period, we also developed a partnership with Humber Learning Consortium (HLC) for the delivery of initiatives that support beneficiaries numeracy skills and employability pathways, assisting them in day to day budgeting, and overcoming the various barriers they may have in pursuing their aspirations. This will commence delivery in the next financial period.

We have worked closely with many agencies including East Riding Voluntary Action Services (ERVAS) Ltd and members of the East Riding Food Poverty Alliance, Citizens Advice, Hull and East Yorkshire Credit Union, East Riding Adult Education, YMCA, Local Growth Team at East Riding Council, Goole Town Council and many more. We are proud to be part of a community that daily shows care and commitment to those encountering hardship, and a spirit of togetherness when times are challenging.

All of our work is carried out by a wonderful group of local volunteers who do an amazing job and the food that we distribute still comes from the local community. We must extend heartfelt thanks on behalf of the Trustees to our volunteers for their hard work, adaptability and dedication in a challenging environment. We also extend heartfelt thanks to our partner agencies, Humber Learning Consortium, local supermarkets and stores who have supported us, as well as grant aiding bodies, local churches and particularly the local community who have contributed food and finance to the Pantry to ensure its continued operation.

The Two Rivers Community Pantry board of Trustees is satisfied that in 2022/23:

- Our work reflected our aims.
- Our resources were well managed.

During the accounting period we have undertaken the following activities:

- We have continued evolving membership of the pantry to the local community
- We have continued developing relationships with various agencies to support the needs of the local community
- We have expanded the list of suppliers who can provide food and produce either free or significantly discounted
- We have started preparations for new projects that support the local community overcome barriers, i.e. Multiply and Exploring Opportunities with HLC and the development of a Warm Space
- We partnered with Goole Town Council to provide a Christmas market

- We accessed funding from East Riding of Yorkshire Council Emergency Food and Essential Supplies Fund.
- We have maintained our relationship with the East Riding Food Poverty Alliance (ERFPA) and continue to be a partner on the White Goods Scheme.

Financial Review

Reserves Policy

It is the aim of the Trustees to retain six months running costs in the unrestricted general fund to ensure adequate cash flow and manage the organisation effectively.

Looking ahead, and subject to finance, we aim to undertake refurbishment of further space that will enable us to take catering produce and repurpose to into relevant portion sizes, naturally ensuring compliance with all relevant legislation.

Statement of Trustee's responsibilities

The charity Trustees are responsible for preparing a Trustees' Annual Report and financial statements in accordance with applicable law and Financial Reporting Standards. Charity law requires the charity Trustees to prepare financial statements for each year which give a true and fair view of the state of affairs of the charity. In line with the Charities Act 2011, the charity has elected to prepare their accounts on the Receipts and Payments basis which is an acceptable format for non-company charities with an income below £250,000. The Trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charity's website and the information supplied to the Charity Commission. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

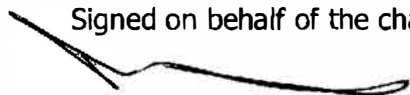

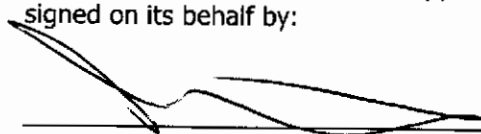

Notes to the Financial Statements For the period ended 31 July 2023

1. Accounting policies

1.1. Basis of Preparation

The charity have prepared their accounts on the Receipts and Payments basis in line with Charity Commission guidance. This is an acceptable format for a non-company charity with an income below £250,000.

This is the first period of operation of the charity which was registered as a CIO on 18 August 2022. Prior to this, the activities were operating as part of East Riding Voluntary Action Services (ERVAS) Ltd. A transfer of assets both physical and monetary was made to the charity in the financial period, further transfers were made after the period end.

As this is the first accounting period of the charity the accounts show no comparative figures.

1.2. Going Concern

The Trustees consider the Charity to be a going concern. The accounts have been prepared on this basis.

1.3. Fund accounting

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors. Restricted funds are accounted for separately to each other and to the core funding of the Charity.

General funds are unrestricted funds which are available for use at the discretion of the trustees in the furtherance of the general objectives of the charity and which have not been designated for other purposes.

A brief description of each of the Restricted Funds is given below:

ERYC – Christmas Market

Restricted funding was provided by East Riding of Yorkshire Council for a Christmas market in Goole. Two Rivers Community Pantry worked in partnership with Goole Town Council to organise and provide a Christmas market.

ERYC – Emergency Food and Essential Supplies

Restricted funding was provided by East Riding of Yorkshire Council for emergency food and essential supplies to support people in need.

ERVAS – Emergency Food and Essential Supplies

Restricted funding was provided by East Riding Voluntary Action Services (ERVAS) Ltd from a restricted fund held on behalf of Two Rivers Community Pantry. These funds were originally received from East Riding of Yorkshire Council. This is being paid to Two Rivers Community Pantry in arrears on receipt of an invoice and evidence of spend. At the period end there is an outstanding amount due to Two Rivers Community Pantry, this has been paid in the next accounting period.

5. Restricted funds (continued)

ERVAS – White Goods

Restricted funding was provided by East Riding Voluntary Action Services (ERVAS) Ltd as lead partner on the White Goods project, funded by East Riding of Yorkshire Council.

Two Rivers Community Pantry is a partner on this project. Referrals of people in need of large white goods are sent from partners to the lead partner who provides these items. In addition, partners are provided with funds to purchase small white goods such as air fryers and slow cookers.

HLC - Multiply

Restricted funding was provided by Humber Learning Consortium as lead partner on the Multiply Project, funded by National Government through East Riding of Yorkshire Council.

Two Rivers Community Pantry is a partner on this project providing numeracy skills to people accessing its services.

This is being paid to Two Rivers Community Pantry in arrears on receipt of monitoring reports. At the period end there is an outstanding amount due to Two Rivers Community Pantry, this has been paid in the next accounting period.

6. Trustee Remuneration

No remuneration directly or indirectly out of the funds of the Charity was paid or payable for the period to any trustee.

There was reimbursement of travel expenses amounting to £754 paid to 2 trustees during the financial period.

If the Charity is wound up or dissolved and after all its debts and liabilities have been satisfied there remains any property, it shall not be paid to or distributed among the members of the Charity but shall be given or transferred to some other charity or charities having objects similar to the objects of the Charity.

9. Going Concern

Trustees consider the Charity to be a going concern for a period of at least 12 months after the date on the Independent Examiners report as the Charity generates income through the delivery of a Community Supermarket to those in need in the Goole area.
