Bodies responsible for governance and management: The Trustees provide the legal oversight of the church and the church leadership have a pastoral brief and oversee the spiritual life of the church, ensuring that the church fulfils its objectives, with support from others within the church.

The Trustees meet during the year to hear reports of the work and to make necessary decisions.

Safeguarding and Policies: The church operates a safeguarding policy which is available in the church records from the Safeguarding Co-ordinator. The church is registered with Thirtyone:eight, the organization which provides training and resources for safeguarding matters and other related issues.

C. OBJECTIVES AND ACTIVITIES

Objectives: The objectives of the Global Mission for Christ Ministries are for the public benefit and for the advancement of the Christian faith in Gloucester in particular, but without limitation. 
