**Objects:** 1.THE PROMOTION OF THE ESTABLISHMENT, CONTINUATION, EFFICIENCY AND EFFECTIVENESS OF ALMSHOUSE CHARITIES IN STRATFORD-UPON-AVON.2.THE PROVISION OF SOCIAL HOUSING IN THE FORM OF ALMSHOUSE ACCOMMODATION FOR PEOPLE IN NEED BY REASON OF AGE, FINANCIAL HARDSHIP, DISABILITY OR OTHER CHARITABLE NEED.3.THE RELIEF OF POVERTY AMONGST CURRENT ALMSHOUSE RESIDENTS IN STRATFORD-UPON-AVON AND OTHER RESIDENTS OF STRATFORD-UPON-AVON AND THE SURROUNDING AREA BY PROVIDING: GRANTS, ITEMS AND SERVICES TO INDIVIDUALS IN NEED AND/OR CHARITIES, OR OTHER ORGANISATIONS WORKING TO PREVENT OR TO REDUCE THE NEED, HARDSHIP OR DISTRESS OF SUCH PERSONS;4.ANY OTHER CHARITABLE PURPOSE WHICH SHALL BE SELECTED BY THE TRUSTEES IN THEIR ABSOLUTE DISCRETION FROM TIME TO TIME.

**Activities:** Provision of low-cost, self-contained, low-level supported accommodation (almshouses) for local elderly people of limited financial means. Awarding of grants for a specific purpose to needy individuals and families living within the town boundary of Stratford-upon-Avon.
