Governing Document

FoodBanked is constituted as a charitable association registered with the Charity Commission on 05 September 2022 under charity number 1200267 and is governed by a constitution adopted on 05 September 2022.

Objects

The object of FoodBanked is the prevention or relief of poverty within east London and surrounding Essex areas, primarily through the provision of food, clothes, hygiene, household products and services to people in poverty and/or charities, or other organisations working to prevent or relieve poverty

Aims and Objectives

The aims and objectives of the charity are to provide essential food, clothes, hygiene and household products to people in need within east London and surrounding Essex areas

Future plans


