TREASURER'S REPORT

Total £37,500 including vat which he will reduce to £35,000 if all works done in one go.

£7000 deposit has now been paid. Hall will be closed for 3 weeks. Some private party bookings could not be taken as they would require use of the kitchen.

Making sure we keep £5000 on account to cover costs.
