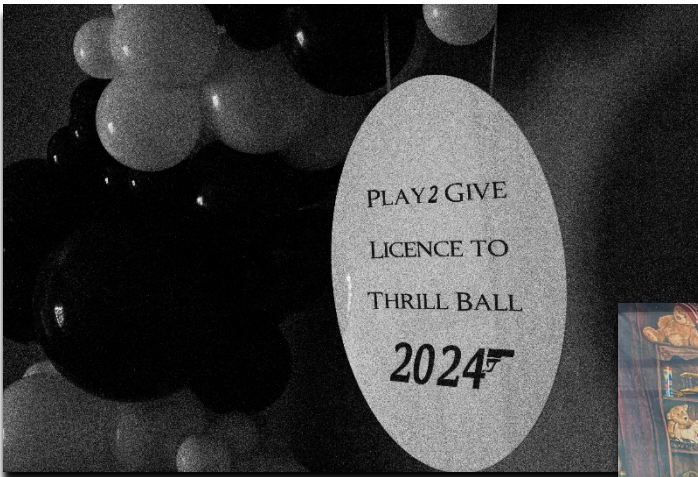

Achievements and performance

The founder of the Play2Give Charity is Andrew Baker, who has been raising funds for county causes since 2002. In 2021, Andrew was given an MBE for services to charity in the New Year Honours, and a British Citizen Award in 2017. Play2Give has been nominated for several awards over the years, including winning the Thames Valley Charity of the Year in 2020.



Play2Give had its busiest, packed, and its most successful year across the financial year. Once again, we held a wide number of fun, diverse and engaging events for the community, joining in with stalls at public events and many of our events as well as our two flagship campaigns raised record breaking amounts than any other year.

£30,000 for Oxford Head Injury Services

A highlight of 2024 was reaching a landmark total of £30,000 in the later part of the year for Oxford Head Injury Services (formerly Headway Oxfordshire). This milestone amount was reached after the proceeds raised by our 007-themed ball in September saw OHIS receive over £3,408 pushing us over the £30,000 threshold. OHIS presented Andy with an OHIS Fundraising Superhero award at their Christmas lunch and party, in tribute. The formal £30k celebrations will be held back until our sixth gala ball in 2025, which is scheduled for October 2025. Andy has been an OHIS service user since 2012 and attends the activity and rehabilitation centre twice a week, so the extraordinary achievement is even more special as a patient giving back to a service that has made such a meaningful and positive impact on his life.



The share of proceeds for OHIS raised from our fifth gala ball saw us fund Christmas lunches and festive activities for service users and carers, and helping to provide wellbeing in doing so, for those supported by this specialist brain injury support

organisation. The black-tie ball in September was one of our biggest highlights of the year, and as one of our flagship events, was held for a second year running at the beautiful setting of Milton Hill House and raised more than the previous year smashing past the £6,000 threshold. Over £6,300 was raised.

Other 2024 Highlights

Another highlight of the financial year was our 14th annual football tournament, held at Wallingford Sports Park, which, despite being postponed by three weeks for the first time in event history due to bad weather, didn't disappoint and still raised close to £6,000 with fewer (due to the postponed date clashing with Truck Festival) than anticipated teams. Many corporate teams amongst community groups and teams of friends all took part. The top fundraising team cup this year went to ATA Logistics Ltd, based in Didcot, and for the first time a plate which went to a team from Didcot, whilst the 2024 champions was a team from Headington in Oxford who contested for a third year. The day also included fun on the side for families and was well attended with the sports park providing food and refreshments, and raffle prizes donated by many companies and organisations.



Other event highlights of the financial year included another sell-out Christmas party which saw £950 in proceeds, and our very first indoor Christmas market, supported

by Didcot Events CIC and Abingdon Lions, host at Milton Hill House, in November which was busy throughout with a packed car park, almost 40 stalls and over £2,000 raised. Record-breaking and sell-out Christmas parties, and our first ever quiz night held in November in partnership with the Courtyard by Marriott Oxford South, with production support by RD Productions was amongst other events and activities including stalls, tombola's and raffles.

We received a wonderful donation of £250 from the President of the Rotary Club of Oxford, who chose us as her charity of choice from her year in term. We continued to see donations come through from individuals creating Facebook birthday fundraisers, and many regular corporate partners as well as new corporate sponsors came on board.



Significant financial donations came from Cannon Packing and Logistics based on Milton Park with their annual £1,000 Christmas donation, and the Broadways pub in Didcot adopted us as their charity for the year after a public vote on their Facebook page which saw our charity receive the greatest number of votes. They held events over the Easter weekend including a fun-filled boogie bingo night, a 24-hour darts marathon and carried our pots on the bar. Explosive Learning Solutions Ltd based on the Harwell business park continued to sponsor us, and provided table sponsorship for our ball, took part with a collection for our Easter campaign and director Cath Convery volunteered at some events with us.



2024 Financial Donations Provided

We gave £22,431.25 from grants in the financial year to charities including £15,000 to the Oxford Children’s Hospital, all of which was raised the previous year. Our latest contribution to the hospital will be spent on funding a brand new and much-needed Echo probe machine for children having cardiac care, and an exciting artwork project on the teenagers’ ward, ‘Melanie’s Ward’. As well as the £3,408 given to Oxford Head Injury Services as mentioned earlier on in this report, they also received £2,000 from 2023 which will go towards the general upkeep of the activity and rehabilitation centre, and £275 went to Sobell House towards their family room refurbishment appeal. Footsteps, Viking House and SSNAP which supports the neonatal care unit at the John Radcliffe, all received £275 each.

The charity continued to attend local community events to raise funds and awareness of its work, including the traditional and annual Harwell feast, a fantastic day of family fun. We held a tombola at the event.

We once again took part in the Oxford Hospitals Charity’s OX5 RUN in March 2024, an annual five-mile fun run held at Blenheim Palace which raises funds for the local children’s hospital. Our team including members for a third year, from our corporate partner, Driving Miss Daisy Didcot, helped to raise over £667 collectively. In total this fun run raised over £100,000 for children’s services helping to fund patient comforts, specialist equipment and a children’s radiology play specialist amongst much else.

We continued to benefit from storage and admin space thanks to BizSpace in Didcot, who provided a room for us in 2023 which we share with fellow local charity, Oxfordshire Foster Care Association, enabling us to increase what we do and storage of all of our Christmas gifts, tombola prizes and extra room to work from, and we are enormously thankful to BizSpace for their support and sponsorship as a lifeline to our charity.

Awards and Recognition

2024 saw us recognised as a nominee in the Didcot Town Council Awards. We were shortlisted in the annual John Eldridge Award for Voluntary Service, in a nomination made by the Oxford Hospitals Charity the previous year. Whilst we did not win, we were proud to be recognised for all the good work we do for the benefit of the town, and amongst some deserving nominees including the winner Andrew Snell, who runs the town's foodbank. Andy Baker attended the ceremony on behalf of all the team. He is pictured below receiving our certificate from the 2023/24 Mayor of Didcot, Axel Macdonald.



Some of our supporters and volunteers were once again appreciated and celebrated in our annual volunteer award given in memory of a late supporter, presented at our annual ball. Nominations for 'The Angela Norris Play2Give Award' come from the public and are judged by a committee.

In 2024 the winner was three-time nominee Chloe Boyne, who has volunteered for our charity since August 2019, pictured below, together with our founder Andy on the

night, with her award . Chloe first helped raise funds for us as part of her summer National Citizen Service social action project and has taken part in every OX5RUN since. She also has run marathons and done so much including helping to organise our annual football tournament since 2022, collectively helping us raise over £10,000 since she first supported us as a student back in 2019 and celebrated her fifth anniversary, so the timing of the award was a fitting tribute. We continue to recognise the importance and value of our supporters, and so for all those donating or raising £30 or over, they receive a signed certificate and a P2G Hero medal.



10th Anniversary Sleigh2Give Appeal

Our festive drive saw ‘Sleigh2Give’, our annual Christmas campaign, reached a special milestone turning ten years old. Once again, the seasonal gift giving appeal provided thousands of toys and gifts worth over £100,000’s distributed to children in hospitals, hospices, the less fortunate and low-income families. Our 10th anniversary appeal in 2024 was the biggest and best one collecting gift donations more than ever amassing donations not just from Oxfordshire but other counties including Berkshire and Plymouth. Sleigh2Give was also one of the very first recipients of the ‘giving tree’ initiative run by Dunelm in Didcot. Our birthday appeal saw more donation points and more supporters than ever before take part. Around £300k worth in the value of presents was estimated to have been raised, and we have enough toys to be able to gift out to young patients in hospital at Easter 2025, for children who can’t eat chocolate and for year-round toys in 2025 for children having procedures and stays in the hospital.



Our huge thanks to our continued sponsors of the appeal Changing Lives and Go Green Taxis and our corporate partner, Driving Miss Daisy Didcot for providing transportation for our big Oxford deliveries each Christmas.



Record-breaking Easter egg collection



Our fourth Easter drive was the biggest and best collection yet in 2024 seeing us raise around over 1,270 plus Easter eggs all donated by the local community which was given out to children and families in hospital, hospices, and those in need from children, families and nurses in hospital, to financially struggling families in Didcot to the vulnerable and children with disabilities, so many received joy from our Easter bunny thanks to our ever generous supporters.

Play2Give's founder is Andrew Baker, who has been raising funds for county causes including Oxford Children's Hospital primarily since 2002. In 2021, Andrew was given an MBE in the New Year Honours for services to charity and a British Citizen Award in 2017 for charitable giving. Play2Give has been nominated for several awards over the years, including the Thames Valley Charity of the Year in 2020.

Play2Give had its busiest, packed, and most successful year across the financial year (2022-2023). We held a range of fun, diverse and engaging events for the community, and many of our events raised record breaking amounts than any other year.

A highlight of the year was reaching the landmark total of over £100,000 raised for the Oxford Children's Hospital across a two-decade lifetime of giving, which was marked and celebrated at two separate occasions, one at the hospital with representatives from our charity, the hospital charity, and the hospital's play team and some young patients. Our great Gatsby ball held at the end of September 2023 was a joint celebration with the hospital and saw the hospital pay tribute and mark appreciation with a special video, gifts, and a large cake. This spectacular night, our fourth gala event, raised over £5,125 in profit for two local causes including the hospital and Oxford Head Injury Services.

Another highlight was our annual football tournament, which returned for its 12th year, and saw a record 28 teams compete raising close to £6,000. Many corporate teams amongst community groups and teams of friends all took part, and Planet IT, on Milton Park, was awarded the top fundraising team cup, presented by charity patron and local MP David Johnston.



Other event highlights of the financial year included record-breaking and sell-out rock roll and roll bingo nights, sell-out fundraising Halloween and Christmas parties, and a sold-out drag show night, hosted by the Courtyard by Marriott Oxford South, amongst other activities including stalls, tombola's and raffles. Two festive markets in 2022 and in 2023 saw great crowds, and wet weather on the latter didn't stop a great turnout to have fun with festive spirit and cheer brought to the town of Didcot.



We received a wonderful donation of over £2,350 from the Mayor of Didcot, now trustee, Mocky Khan, pictured below with Andrew Baker, who across his Mayoral year was able to contribute the funds raised through his successful fundraising events including a festive fun run, a barn dance, and his red themed dinner and dance. In October 2022, we received a £500 donation from the Truck Festival grant scheme, which was given from the funds the annual 3-day music festival raised.

Across the year, we continued to receive support from our patrons who helped to spread awareness as well as getting involved in or attending some of our events. The charity continued to attend local community events to raise funds and awareness of its work, including a Coronation celebration day organised by another local charity and the annual Harwell feast, a day of family fun.



We took part in the Oxford Hospitals Charity's annual OX5 RUN in March 2023, an annual five-mile fun run which is held at Blenheim Palace. We enter a team in this yearly event which raises funds solely for the Oxford Children's Hospital Charity fund. Our largest team ever of 12 raised over £1,370 benefiting the hospital's charity which saw us help to raise funds for specialist medical equipment and to help fund the role of a play specialist for children's radiology amongst toys, games and patient comfort items and artwork to brighten and entertain children's stays.



We secured a grant from our local district councillor's grant scheme and along with corporate sponsorship we were able to hold our postponed family fun day also known as Play2Give's Party on the Park, see below.

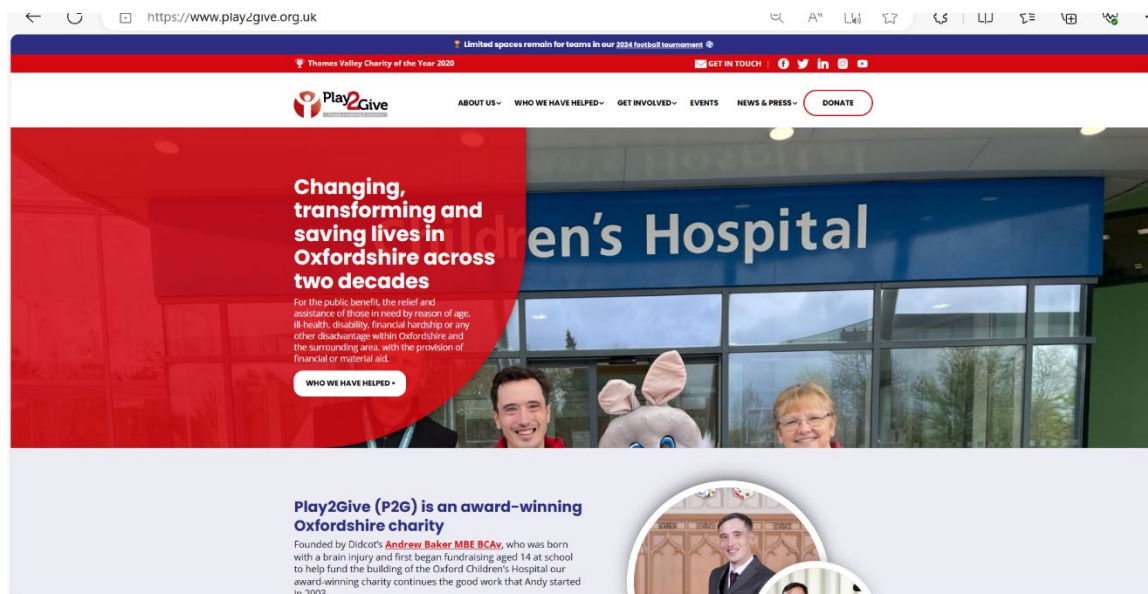
After being postponed in early September 2022, due to the passing of the late Queen Elizabeth II, our 15th birthday party on the park took place in August. Despite after a sunny start, the weather was then against us, though it didn't dampen the spirits and we saw a great crowd turn out across the day, from families enjoying picnics in the park to revellers dancing and enjoying the live music by night.

We gained additional storage space in early 2023 thanks to sponsors BizSpace Didcot, who provided a room for us which we share with a fellow local charity, Oxfordshire Foster Care Association, enabling us to increase what we do and has been a lifeline for us being able to store all of our Christmas gifts, tombola prizes, extra room to work from and BizSpace has been supportive by sponsoring or taking part in some of our events.

Our brand-new website was launched with a fresh new look, easier accessibility and navigation and a much easier way for the public and potential supporters to contact us through online forms. The new website, created by Lee Vanstone Web Development, went live in November 2022, with great response and feedback. Our biggest thanks to Lee for all his help and implementation of our new site.



We sadly bid farewell to one of our longest-serving and oldest volunteers, Maggie, who moved up North towards end of 2023, to be closer to her family for personal reasons. Maggie has been a dedicated and stalwart volunteer since 2012 and come rain or shine, she was a familiar and friendly face behind stalls, at many of our events and each November in Tesco, Didcot with her cheery disposition and smile helping spread the awareness and gift giving for our Sleigh2Give toy collection. Maggie will be greatly missed, and we wish her all the best as she begins her new life up north, and we thank her immensely for her valuable contribution and her devotion to our charity.

For two consecutive years running, we were nominated in the BBC Radio Oxford Make a Difference Awards. September 2022 we were finalists for the Fundraiser Award and in September 2023 for Best Community Group. The end of the year (2023) followed with a nomination in the Didcot Town community awards, where we have been shortlisted for the John Eldridge Award for voluntary service, for which the ceremony takes place in spring 2024. One of our trustees, Matthew Norris-Silva, was recognised as a nominee in the 2022 Didcot Town awards for the 'Unsung Hero' award, for his efforts in raising funds over many years and his role as community officer.



Many of our supporters and volunteers were celebrated in our annual award given in memory of a late supporter, which is presented at our gala ball, each year. Volunteers Linda and David Latter, and Leanne Coates, were all winners in 2022 and 2023 respectively. Nominations for 'The Angela Norris Play2Give Award' come from the public and are judged by a committee. We continue to recognise the importance and value of our supporters, and so for all those donating or raising £30 or over, they receive a signed certificate and a P2G Hero medal.



Our material aid saw 'Sleigh2Give', our annual Christmas campaign, provide thousands of toys and gifts across two consecutive appeals and between both provided over £100,000's worth distributed to children in hospitals, hospices, the less fortunate and low-income families. 2023's appeal was the biggest and saw more donation points and more supporters than ever take part. Our third Easter drive, saw us raise around 600 plus Easter eggs, donated by the local community which was given out to children and families in hospital, hospices, and those in need. Our huge thanks to our continued sponsors of the appeal Changing Lives and Go Green Taxis and our corporate partner, Driving Miss Daisy Didcot for providing transportation for our big Oxford deliveries each Christmas.
