OBJECTIVES AND ACTIVITIES

Love Barton is a Christian charity to tackle systemic issues keeping people and families in Barton in poverty, and to release them to flourish in all areas of life.

Barton is one of the most deprived estates in Oxford, sitting among the 20% most deprived wards nationally. For children and young people, outcomes are even starker: the area ranks in the bottom 10% for education across England. Nearly a quarter of children (24%) grow up in poverty, double the Oxfordshire average.

It is into this context that Love Barton works. We exist walk alongside those facing poverty, isolation and crisis, and create a space where individuals and families can flourish.

Based on the needs of the community and our current capacity our work is built around three interconnected areas – Health & Wellbeing, Youth, and Flourishing Families. Each address pressing needs within our community, but all are underpinned by our relational, long-term approach.

In Spring 2025 our Interim Charity Manager joined Love Barton to cover our permanent Charity Manager whilst on maternity leave.

Health & Wellbeing: Working to provide practical and emotional support to those in Barton facing food poverty, isolation, and poor mental health.

Over the course of the 2024-2025 financial year, our foodbank, run in partnership with Community Emergency Foodbank Oxford, provided food parcels to 1,238 individuals. Each parcel represents more than food; it represents care, dignity, and reassurance that neighbours in crisis are not forgotten. Alongside emergency provision, our dedicated volunteer team offers encouragement, advice, and signposting so that families feel supported beyond their immediate needs.

In addition to this practical help, our Hear4You listening service continued to provide vital emotional support throughout 2024. We received 14 referrals from a wide range of sources, including social prescribers, local churches, Love Barton itself, and even through social media. The individuals we supported were facing complex challenges: bereavement, financial hardship, unemployment, poor mental and physical health, suicidal thoughts, family breakdown, loneliness, violence, and substance misuse.

Three trained volunteers delivered over 60 hours of one-to-one listening, with sessions ranging from a single meeting to ongoing support over 24 weeks. This flexibility is one of Hear4You's greatest strengths: it allows us to respond to people's need as they truly are. Clients repeatedly tell us that having someone listen without judgement is crucial – giving them hope, space to breathe, and the encouragement to take next steps.

Over the course of the year to strengthen the service we have:

- Distributed over 100 wellbeing packs at local health promotion and Love Barton events
- Improved accessibility through new signage and promotional resources
- Commissioned professional photography and videography to raise awareness and ensure effective signposting across Barton

This combined impact of our foodbank and Hear4You services is clear: hundreds of individuals and families have been supported in their most vulnerable moments, while many others have found encouragement and connection through our wellbeing initiatives. By working relationally and flexibly, Love Barton continues to build a community where physical, emotional, and spiritual wellbeing can take root and grow.

Youth: Working to support young people with low self-esteem and/or family challenges to have the confidence to make good choices and work towards their dreams and ambitions.

Being a young person today is more demanding than ever, and in an area like Barton those demands are layered on top of financial hardship. Nationally, about 1 in 5 children and young people aged 8 to 25 are estimated to have a probable mental health disorder. Rates of mental distress among young people have risen sharply in recent years, with young women showing higher prevalence. Meanwhile, research shows that children and adolescents growing up in poverty are more likely to experience emotional and behavioural difficulties, lower self-esteem, and restricted life-chances. They face additional barriers to accessing mental health support, social opportunities, and stable environments; challenges that compound the everyday pressures of relationships, social media, schooling, identity, and future planning.

In Barton, where socio-economic challenges are high, these pressures are not abstract. That is why our youth work matters. We continued our partnership with Know Your Worth this year to deliver an eight-week self-esteem course for teenage girls in Barton. Attendance during the first session was outstanding at 97%, showing how deeply the course resonated with young people.

Youth (Continued)

Over the eight sessions participants explored topics such as:

- What self-esteem is and how it can be nurtured
- Emotions and strategies to manage them
- Social media, identity, and online safety
- Healthy vs unhealthy relationships
- Hopes, dreams and overcoming limitations
- Resilience, inner strength, and coping strategies
- Stress management and self-care

The impact was significant:

- 100% of respondents said their self-esteem had improved by the end of the course
- The proportion feeling 'satisfied with themselves on the whole' rose from ~50% at the start to 86% by week eight
- The percentage of girls feeling 'they have much to be proud of' increased from 29% to 57%
- 86% of respondents agreed that they now know they are a person of worth who is equal to others

Following the course, all participants were invited into six months of one-to-one mentoring, matching them with trained volunteers. This mentoring is designed to carry forward the self-esteem work by offering deeper relational investment, ongoing encouragement, and individualised conversations.

Flourishing Families: Working to provide practical and pastoral support to families in need, particularly those in crisis and empower parents to translate the love they have for their kids into experiences and parenting that sees the child flourish.

Strong families are the foundation of a thriving community. Yet for many in Barton, family life is lived under enormous strain: financial hardship, isolation, and the stress of parenting without support can make it difficult for parents to provide the safe and nurturing environments they long for. Love Barton believes in equipping and encouraging parents so that their children can flourish.

In August 2024 we ran a Kids Matter parenting course, designed to support parents experiencing low income and low support. The impact was clear. From the end of the course surveys, parents reported that:

- 50% had developed better routines at home
- 50% felt they were looking after themselves more
- 50% said they were playing with their children more
- 50% said they were managing their children better
- 50% said they could listen and encourage their children better
- 50% said they felt their family team was stronger
- 100% said they would recommend going to a Kids Matter group to a friend

Parents' comments revealed the transformative impact of the course. They commented that the programme: 'Helps in ways that you wouldn't realise' and '...has been like a therapy session which has helped me a lot.'

Alongside this, we sought to bring joy and dignity to families at key moments in the year. At Christmas, we invited 50 families to receive festive hampers filled with food, gifts, and treats. For households struggling to make ends meet, these hampers were a reminder that they are seen, valued, and not alone.

Financial Review and Reserves Policy

Unrestricted year-end balance was £43,627, in line with last year. The Charity aims to have 4 months reserve in the value of £12,000 which the trustees consider appropriate to cover core operational costs and staff commitments.

Love Barton Summary

Love Barton is a Christian charity established on 14th September 2022 to tackle systemic issues keeping people and families in poverty, and to release them to flourish in all areas of life. 2023/2024 was a year of significant growth for Love Barton as we employed a Charity Manager to oversee the day-to-day running of the charity. Together with our trustees, the Charity Manager developed our vision statement to be:

"Working to see every person in Barton fulfilling their potential and as a result the whole community flourishing."

We also agreed upon five values to underpin our work. These are: *relational, collaboration, longevity, acceptance and hope.*

We identified three priority areas for our work and were able to restart and initiate a number of projects accordingly.

Health and Wellbeing: Working to provide practical and emotional support to those in Barton facing food poverty, isolation and poor mental health.

- Foodbank: In partnership with Community Emergency Foodbank Oxford we ran a twice-weekly foodbank hub. In 2023/2024 we gave out 529 food parcels to individuals and families referred by local organisation.
- Hear4You: In 2023/2024 we re-launched our free listening service Hear4You after a break to provide free emotional support to those facing stress, loneliness, bereavement, isolation and poor mental health. Through this 4 trained volunteer listeners supported 11 individuals through over 40 hours of active listening.

Youth: Working to support young people with low self-esteem and/or family challenged to have the confidence to make good choices and work towards their dreams and ambitions

- Know Your Worth: In partnership with Know Your Worth we supported 5 teenage girls through an 8-week self-esteem course. 4 out of 5 of these reported higher self-esteem after

the course using the rosenberg scale while the other participant maintained their level of self-esteem.

- Mentoring: All 5 girls who completed the Know Your Worth course signed up for 6-months of follow-on mentoring with a trained volunteer of which many claimed it made a huge positive impact on their confidence and wellbeing.

Flourishing Families: Working to provide practical and pastoral support to families in need, particularly those in crisis, and empower parents to translate the love they have for their kids into experiences and parenting that sees the child flourish.

- Adhoc Courses: In partnership with Christians Against Poverty we supported 5 parents to improve their financial situation by hosting a money-management course.
- We gave away over 200 festive hampers containing essential food, christmas gifts and treats to families in need identified through local schools and community workers.
- We welcomed over 50 individuals from the community to an Easter event where children and families enjoyed crafts, games and a hot meal. We also celebrated our official launch with a community party giving out over 200 burgers and sausages at a free family fun afternoon with a BBQ.

As part of our 2024 fundraising strategy, we hosted a Vision Night in December to unveil our giving campaign focused on securing regular monthly donations. This initiative reflects our commitment to establishing a consistent and reliable income stream through the support of dedicated donors. We have worked diligently to encourage and cultivate a base of regular givers, ensuring financial stability to sustain and grow our mission.

Love Barton is a Christian charity established on 14th September 2022 to tackle systemic issues keeping people and families in poverty, and to release them to flourish in all areas of life.

2022/2023 was a year for Love Barton to focus on setting up and establishing its core operations. This has resulted in the charity forming its strategy, key policies, whilst understanding our funding requirements, and establishing the key areas of focus and the desired outcome from the projects and courses that will be on offer in the following financial year.

Initial funding has been obtained from several donations, allowing Love Barton to be in good stead, in preparation for the recruitment of a Charity Manager. Preparation during this year will see the start of three priority projects, along with training and managing a growing team of volunteers to achieve our desired goal in the local community of Barton.

The three priority projects are:

Hear4You listening service

This service, which provides a trained volunteer listener for those who are lonely, bereaved, or suffering poor mental health, attracts referrals from the local GP practice who see us as a way of providing immediate support when NHS waiting lists are 6 months.

Know Your Worth self-esteem project

An 8 week course for vulnerable teenage girls aged 14-16. The course covers topics such as healthy self-esteem, confidence, managing emotions, relationships, resilience and social media. The girls all receive a workbook and weekly goody bags, and mentoring for 6 months is offered with a specially matched volunteer.

Flourishing Families

This project will have two elements

- a. Proactive: Conduct a needs analysis for local children aged 0-5, anticipating that one outcome will be to run parenting groups for young mums.
- b. Reactive: Responding to families in need and families in crisis by providing a family friend volunteer who can support parents and lift the burden when they need it most (e.g. childminding, doing a weekly shop), which gives children the best possible chance of thriving in their birth family.

We anticipate the impact of this project will be to drastically reduce the number of children locally going into care, and so influence a change in culture and expectations.
