Governance and management

The charity is operated under the rules of its constitution adopted 3 October 2022 and most recently amended 12 January 2023

As per our constitution, Trustees are nominated and seconded by voting members and then elected at our AGM. Additional trustees upto our maximum can be appointed by the trustees but they must then resign at the next AGM stand for re-election.

Objectives and activities

To relieve the needs of children and young people (CYP), including their parents, carers and families, who have disabilities and/or special educational needs in Nottinghamshire and the surrounding area, in order to improve their quality of life, promote their inclusion in their local communities and to help and support them to reach their full potential.

Summary of the main activities undertaken for the public benefit

Meeting and liaising with local authority, NHS Integrated Care Board (ICB) and other agencies to represent views of parent carers and ensure services are delivered as set out in legislation and guidance. Engaging with parent carers to gather views on local services and other issues effecting children and young people with special educational needs and / or disabilities (SEND). We work alongside local authorities, education, health, and other service providers to ensure the services they plan, commission, deliver and monitor meet the needs of children and families with SEND

in Nottinghamshire. Visiting education establishments to establish and support parent forums and deliver the Autism in Schools project.

1. Providing information and signposting to services and resources for parent carers

We keep families informed about relevant services, resources, events, consultations, policy updates, and pertinent issues. Through our monthly newsletter, email updates, website, social media page, stalls at community events, peer-to-peer phone calls and parent group engagements, we endeavour to provide families with access to relevant information.

This enables families to access the services and support they need to become more informed, connected, active and empowered citizens and get support tailored to their family's particular needs.

2. Providing peer support

We connect with support groups and Children's Centres; visit schools, set up and establish new parent groups, receive frequent emails from individual parents seeking advice and support, and deliver participation peer support groups as part of the Autism in Schools and the Partnership for Inclusion of Neurodiversity in Schools projects.

Supporting parents of children and young people with disabilities or additional needs in Nottinghamshire means families meet, share, and learn from each other. It reduces isolation and increases confidence and knowledge and provides a sense of inclusion and understanding, building connections with others in similar situations.

3. Engagement and Representation

We engage with parent carers through various channels, including holding stalls at relevant parent carer marketplace events, distributing the forum's leaflets out to groups, organising workshops/ engagement sessions on subjects relevant and useful to families with a child or young person with SEND, sharing out information about surveys and other activities used to capture parent carers' challenges and concerns, hear from individual parents through their shared stories, emails, and phone calls, and encourage and actively support the establishment of parent-led support groups. We engage with parent carers in diverse ways so that different voices are heard, and gather views on the local services and other issues affecting children and young people with SEND (Special Educational Needs and Disabilities) and their families. We collect feedback and get parents and carers' lived experiences to service commissioners, providers and OFSTED /CQC.

These activities mean there is a constructive channel of communication between parents, carers, and strategic partners to influence positive change, create quality services, and provision that meets the needs of all children and young people with SEND in Nottinghamshire.

4. Influencing and transforming services and attitudes

We meet and liaise with the local authority, NHS Nottingham and Nottinghamshire ICB (Integrated Care Board), school staff and other agencies and ensure that the experiences, challenges and ideas of parent carers and their children, are represented and heard, and that they can be used to influence the planning, shaping, commissioning and delivery of services.

As equal partners, we offer constructive feedback, acting as a critical friend while remaining fully independent.

We champion parent engagement and the value of hearing directly from families and working together with them. The forum wants as many parent carers as possible to become involved in the way that is possible for them. The forum consistently encourages parent carers to get involved whenever possible, whether by participating in surveys or joining focus groups. We advocate for the huge benefits that peer support brings. These opportunities allow families to share their experiences directly with those who can make a difference. This is rooted in the knowledge that children and young people, along with their parents, are the most qualified to determine the services they need in their local area.

We undertake evidence gathering projects to enable in-depth data to be collected to evidence the lived experiences of these families and to validate the need for change and improvement.

Increasing knowledge and awareness of the barriers faced by families helps build understanding and an equitable and inclusive quality of life for children with any disability, special educational need, condition, or impairment in Nottinghamshire and creates quality services that meet the needs of all.

Public benefit statement

The Trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance on public benefit, 'Charities and Public Benefit'.

Summary of the main achievements during the period

We hosted a number of workshops, for example delivering Makaton taster sessions, and attended several parent carer marketplace events with parent numbers of up to 250. Here, we connected with a diverse group of parent carers, distributed informational materials, gained new members, and listened to families' experiences of services and concerns. Feedback from these events indicated that participants felt they had gained useful information, were better informed, heard, and more involved as a result.

We maintained a website of relevant information, sent out a monthly newsletter, and continued to reply to emails and phone calls from individual parents who contacted us to seek support, advice and signposting.

We attended strategic governance and Board meetings. Strategic decision-making and planning sessions have continued to expand, and there has been a growing emphasis on attending more meetings in person.

In January 2023 Nottinghamshire became the first Local Area to be inspected under the new OFSTED/CQC framework. Following the SEND local area inspection outcome of "widespread and/or systemic failings" the engagement work for the forum has increased considerably. Parent carers from the forum are members of three boards within the new governance structure: the SEND Partnership Assurance and Improvement Group (PAIG), the SEND Executive Leadership Group, and the SEND Partnership Improvement Board.

Our parent representatives contributed to numerous service delivery areas, including Short Breaks, the SEND Local Offer Groups, the Neurodevelopmental Assessment Task & Finish Group, the Early Years EHCP Development Group, the Joint Nottinghamshire and City SEND Employment Core Group, the Including Parents Conference Planning Group, and the Nottingham & Nottinghamshire Children and Young People's Integrated Care System Board. Additionally, the forum has been actively involved in two major projects: the Autism in Schools project and the Partnerships for Inclusion of Neurodiversity in Schools (PINS) project. Altogether, we dedicated over 300 hours to participating in work stream meetings, steering groups, and conferences.

The Steering Group held monthly meetings, offering a hybrid option to encourage strong participation and support a more diverse team. The Steering Group plans the work of the Charity, coordinates representation, parent participation and engagements, and plans events.

Forums work in their local areas but should also connect regionally. Nottinghamshire Parent Carer Forum are active within the East Midlands network of forums, and we attend regular meetings for our area, discussing diverse topics and ensuring that local concerns are heard regionally and nationally.

At the forum's regular quarterly meeting with Local Authority colleagues, we address issues that families have shared with forum representatives. One such concern was the increasing use of part-time timetables, which many parent carers had highlighted as a significant issue. This prompted the forum to raise the matter formally, leading to an invitation to conduct an in-depth review to fully understand the experiences of children and families affected by part-time timetables, provide a comprehensive overview of the procedures involved, and identify areas for improvement with actionable recommendations.

To accomplish this, we conducted semi-structured interviews with key stakeholders, including parents and young people, distributed an online survey with both qualitative and quantitative questions to parents and carers, analysed data from the Local Authority, and reviewed relevant policies. We are now at the point of sharing and presenting the findings with those in a position to influence potential change and shape meaningful improvement in the use of part-time timetables.

Financial review

We are in a good financial position at the end of our financial year with a significant surplus in funds. We have secured additional funding streams in addition to our annual Department of Education grant which has funded our increased workload and will allow us to increase our engagement parent carers and our influence with statutory bodies. Through the Partnerships for Inclusion of Neurodiversity in Schools (PINS) project we will have generated additional income which will continue into our next financial year.


The charity's policy on reserves

The trustees agreed at their meeting in March 2024 an unrestricted reserve was increased from £6,000 to £10,000 to be maintained in the current account to ensure that the charity has sufficient funds to withstand financial issues or to accommodate a four month winding up period for the charity in an organised manner as required by the charity's constitution. This change was made to reflect in increased wage costs due to increased workload. The designated reserves amount will be reassessed annually at the first business meeting of the trustees following the AGM.

Financial risks

The majority of our income is received in the form of grants from public bodies, this funding may be effected by changes in national and local government policies.



We advocate for wider parent engagement and the value of hearing directly from families and support the development of meaningful opportunities for engagement.

We promote co-production in decision making and planning for future service provision, so that parents and carers can contribute to the development of services that meet their needs.

We undertake evidence gathering projects to enable in-depth data to be collected to evidence the lived experiences of these families and to validate the need for change and improvement.

Increasing knowledge and awareness of the barriers faced by families helps build understanding and an equitable and inclusive quality of life for children with any disability, special educational need, condition, or impairment in Nottinghamshire and creates quality services that meet the needs of all.

Public benefit statement

The Trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance on public benefit, 'Charities and Public Benefit'.

Summary of the main achievements during the period

We hosted workshops and attended several parent carer marketplace events with parent numbers of up to 200. Here we got to meet and engage with parent carers, shared publicity material, got new members and heard families' experiences. Feedback shown that participants believed they were better informed and more engaged as a result.

We attended strategic governance meetings, mostly virtually, but with a number now resumed in-person. Meetings included the ICS SEND Health Assurance Group, SEND Accountability Board, and the Local Area Quality Assurance EHC plan Steering Group.

We had parent representatives engaged in many areas of service delivery including Short Breaks - SEND Local Offer Groups, Short Breaks Steering Group, NottAlone Steering Group, Preparing for Adulthood workstreams, Joint Notts/City SEND Employment Core Group and the neurodiversity website coproduction group. In total

we participated in more than 200 meetings achieved by 375 parental representatives attending work-stream meetings, steering groups or conferences.

We maintained a website of relevant information and several social media platforms as well as continuing to email regularly to parents on our database and to send out a monthly newsletter.

The Steering Group met monthly with a hybrid option. This enabled participation from a more diverse team. The Steering Group plans the work of the Charity, coordinates representation, parent participation and engagements, and plans events.

As members of the National Network of Parent Carer Forums we work to keep the voice of parents and carers loud and clear, and influence and shape the delivery of services for disabled families. This includes attending work stream meetings and acting as representatives from Nottinghamshire at these strategic meetings.

Forums work in their local areas but should also connect regionally. Nottinghamshire Parent Carer Forum are active within the East Midlands network of forums, and we attend regular meetings for our area, discussing diverse topics and ensuring that local concerns are heard regionally and nationally.

At the forum's regular quarterly meeting with colleagues from the Local Authority, we raised parent carers' increasing experience and concern about the use of part-time timetables, how they are being monitored, whether it was a growing problem, and the effect it could have on families and children's outcomes. Coming out of that discussion the forum was invited to submit a scoping document to carry out a review into this area. The document details the purpose of the review, methodology, key lines of enquiry and key questions, reporting mechanisms, and anticipated outcomes. It has now undertaken a project to enable in-depth data to be collected to evidence the lived experiences of families and to validate any need for change and improvement.

In late January Nottinghamshire became the first Local Area to be inspected under the new framework. The forum worked extremely hard to raise awareness of the inspection and to encourage parent carers to complete the OFSTED/CQC survey, and a great many parents did. The Steering Group worked laboriously over several long days, putting in many hours, to ensure that the limited time with the inspection team would be put to best use. We were able to present a detailed breakdown of the areas where children and young people with SEND were being failed, covering the top priorities for parents e.g. statutory failings, unacceptable waits and gaps in services. We used data, evidence and referenced surveys to validate everything that was raised. The parent voice of life in Nottinghamshire was communicated strongly and clearly to the inspection team.

The OFSTED/CQC Inspection report said "The Nottinghamshire Parent Carer Forum (NPCF) take an active role in representing the families of children and young people with SEND. NPCF is represented on the SEND accountability board. Members of the

forum use their own and their members' experiences to challenge partnership leaders when services and provision are not good enough. NPCF is involved in the **Nottinghamshire Parent Carer Forum**

partnership's planning to improve services and provision. However, they are rightly concerned that leaders' planning is reactive rather than forward looking."

In the light of the OFSTED/CQC Inspection outcome in May 2023 of, "widespread and/or systemic failings" the forum has been committed to ensuring parent carers are involved in the improvement work arising. Parent representatives from the forum are engaged at all strategic levels under the SEND Improvement Plan including attendance at the SEND Executive Leadership Group, SEND Partnership Improvement Board and SEND Partnership Assurance and Improvement Board (PAIG).

We have secured additional funding streams in addition to our annual Department of Education grant which has funded our increased workload and will allow us to increase our engagement parent carers and our influence with statutory bodies.

The charity's policy on reserves

The trustees agreed at their meeting in September 2023 an unrestricted reserve of £6,000 be maintained in the current account to ensure that the charity has sufficient funds to withstand financial issues or to accommodate a four month winding up period for the charity in an organised manner as required by the charity's constitution. The designated reserves amount will be reassessed annually at the first business meeting of the trustees following the AGM.

Financial risks

The majority of our income is received in the form of grants from public bodies, this funding may be affected by changes in national and local government policies.
